Our office has had meetings and conversations about this and met with the AAA and Senior Solutions at the Appalachian COG in March.

Doug Wright of Senior Solutions closed the Honea Path site and moved the HP seniors to another location in Anderson. Anyone using the Honea Path site would have been given the option to relocate with Senior Solutions, and if transportation was needed it should have been provided. It is my understanding that the some of the Honea Path seniors opted not to move with Senior Solutions and declined the group dining meal.

Senior Solutions is contracted by the AAA – using aging funds allocated by the Office on Aging. By law, the Office on Aging is prohibited to get involved in a service contract between a provider and the AAA. If the AAA agrees and approves the contractor/provider can open and close group dining sites based on need etc. The Office on Aging has a policy that requires all group dining sites to serve at least 25 seniors per day in order to be financially viable and to aid in food safety needs.
