

CAYCE — Former Florida Gov. Jeb Bush praised South Carolina's efforts to combat domestic violence on the first day of the potential Republican presidential candidate's two-day swing through the Palmetto State.

The comments came Tuesday afternoon at the headquarters of Sistercare, a Columbia-area battered women's shelter. Bush appeared with Gov. Nikki Haley after the two privately toured a safe house shelter for battered women.



During his tenure as governor, Bush said he worked to provide more funding to decrease the number of women on waiting lists to get into shelters and to pass tougher penalties for abusers.

He credited his wife, Columba, for putting the issue in the public spotlight in Florida.

"Once again, Gov. Haley is showing what leadership is all about," he said of the governor's work on the issue.




Bush said he began to visit domestic violence centers at the beginning of his term as Florida governor.

"We had an epidemic of domestic violence," he said. Bush said Haley's new domestic violence task force, which is seeking to study and propose broad solutions to the problem, is the right way to go.

"This elevates the conversation to the right place," he said.

South Carolina's efforts to strengthen domestic violence penalties, take guns away from high-level offenders change the culture that perpetuates the violence follows last year's Post and Courier series "Till Death Do Us Part." The award-winning series revealed that more than 300 women had been killed in domestic violence in South Carolina over the

\*\*\*\*\* Synopsis:  
On 02-15-15, I, Cpl. Langenfeld, met with a white female at the Colleton County Sheriffs Office. The female identified herself as Fairey Breland Gresham. Gresham appeared to very upset. I began to take her verbal statement, and it went as follows:

Statement/Victim: (Gresham) Gresham stated that she and her "soon to be" ex-husband are legally separated. Gresham stated that she and her husband have had problems for over the past few years. Gresham stated that today she went over to their house to feed the cats that they own, and her husband started to argue with her. Gresham stated that she then attempted to leave the residence when her husband stated, "You want it to be over, then fine its over!" Gresham stated that as she attempted to leave, he placed her in a headlock. Gresham stated that she was able to immediately flip him over her body, and leave the residence. Gresham stated that there has been a history of abuse from him over the years and that she has not reported it to law enforcement. Gresham stated that within those years, she has been physically, emotionally, and sexually abused by her husband. Gresham stated that besides feeding the cats, she called him out over his affair with another woman as well. She believes that what initially started her husband's anger this evening.

Deputy's Actions/Observations: After taking the above verbal statement, I noticed that Gresham's husband kept continually calling her. Gresham picked up a few times and explained to him that she was at the CCSO filing a police report. I could over hear him yelling in the background, as Gresham stated that he hurt his arm during the course of the struggle. Gresham also stated that he was on his way to the Sheriffs Office. I asked Gresham if she had any marks or bruises on her person, and she stated no. I was unable to detect any marks or bruises on her person in the region where he placed her in a headlock. Gresham did state to me that she is in fear of her life, and I advised her of the procedures that I was going to offer, and that I was going to take, but I needed to hear her husbands side of the story.

Moments later, a white male driving a red pickup truck, drove into the parking lot. The white male identified himself as Rudi Gresham. I advised Mr. Gresham to stay away from the victim, until we were done interviewing him. Gresham began to give me his verbal statement, and it went as follows:

Statement/Suspect: (Rudi) Rudi stated that he and his separated wife had gotten into an argument. Rudi stated that he did not place his wife into a headlock, but as he was walking by her, he tripped and fell, with his wife being in the way. Rudi stated that they have been having problems due to the lack of intimacy that was in their relationship. Rudi stated that he has made some problems in the past by sexually assaulting his wife, as being one of them. When asked about his past, Rudi stated that he did sexually assault her, but he just let it go. Rudi stated that he will stay away from his wife, because he is a very popular person in Washington.

Deputy's Actions (Observations) After taking the above statements from both parties, I was able to advise Mrs. Gresham that she needed a lawyer for personal possessions that they both have at the residence. I also stated to her that she needed to not have anymore contact with her husband, due to the totality of the circumstances that occurred tonight. I advised Gresham that I could not charge Rudi with Criminal Domestic Violence only because: -She had no physical manifestations, -Both had conflicting stories, -Rudi stated that she assaulted him. After explaining to Mrs. Gresham why I couldn't charge Rudi, she understood. I also stated to Mrs. Gresham that if for any chance, an hour, or a day later, she developed any physical manifestations, to come to the Colleton County Sheriffs Office and I would have the necessary elements to obtain a warrant for Rudi's arrest. Mrs. Gresham was also advised that the Victim's Advocate would also be advised of this incident. I stated to Mrs. Gresham that she needed to not make anymore contact with her husband through the divorce process. If any contact needed to be made between them, to let her attorney handle it. After explaining the procedures to Mrs. Gresham, I advised Rudi of the same. I explained to him that in the State of South Carolina, he could get a minimum of 30 years for rape. I also advised Rudi to not have anymore contact with his wife, and that if so, go through his attorney as well. After the advisements, I then cleared from the scene.

Notes: Mrs. Gresham was also advised that if Rudi came back onto her property, to notify law enforcement immediately:
