A meeting of the Department of Transportation Commission was held at the offices of the Department of Transportation in Columbia, South Carolina at 3:00 p.m. on June 7, 1994. In compliance with the "Freedom of Information Act" the news media was advised in writing of the time, date and place of this meeting.

SECTION 1: The Commission unanimously passed a motion approving the Minutes for the meeting of May 19, 1994 pending correction to the Appendix of Section E. paragraph 5 to read as follows:

"(5)" The decision of the panel shall be the final agency decision unless any party to the proceeding files exceptions and submits a brief in support to the Director within thirty days of receipt of the panel's decision. Upon timely receipt of exceptions and a brief, the Director shall hear oral argument and render a final agency decision on the matter. Any party seeking to uphold the panel's decision shall also have the opportunity to submit a brief to the Director prior to a final decision.

SECTION 2: The Commission unanimously passed a motion adopting, on interim basis, county transportation plans for Barnwell and Dillon County.

SECTION 3: The Commission unanimously passed a motion of concurrence on a recommended statewide allocation of federal and state mass transit funds for FY 1994-95 and authorizin the Department to enter into an agreement with the Federal Transit Administration, as shown in detail in the Appendix.

SECTION 4: The Commission unanimously passed a motion authorizing the continuation of the State Mass Transit Fund Program and re-authorized a maximum sum of \$3.0 million dollars during fiscal year 1994-95, as shown in detail in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the action of the Department in extending existing bituminous retreatment contracts to include additional resurfacing work, as shown in detail in the Appendix.

SECTION 6: The Commission unanimously passed a motion approving the action of the Department in extending existing construction contracts to include additional resurfacing work, as shown in detail in the Appendix.

Request for Concurrence on a Recommended Statewide Allocation of Federal and State Mass Transit Funds for FY 1994-95, and Authorization to enter into an Agreement with the Federal Transit Administration

Code Section 57-3-40 (A) and (B) of Act 181, Act of 1993 (Restructuring of State Government Act 1993-1994) authorizes the Department's Division of Mass Transit (DMT) to "develop and coordinate a general mass transit program and policy for the State ...", and directs the DMT "to apply for and to receive state, federal, or other funds" for the purposes of developing such program and providing mass transit services. In compliance with these requirements, the DMT has developed and submitted a detailed program budget through the Department for state, federal and other funds, and has made formal applications to the Federal Transit Administration (FTA) under the FTA's Sections 8, 18, RTAP and 26(a)(2) programs for federal assistance.

It is, therefore, requested that the Transportation Commission approve the recommended Statewide allocation of anticipated FTA funds, State General Funds, and other funds, amounting to a combined sum of \$4,405,926, in order to assist in the administration, planning, capital, operation and maintenance expenses of statewide and local mass transit projects for fiscal year 1994-95, as outlined on the attached schedule. It is also requested that the Transportation Commission authorize the Department to enter into a written agreement with the FTA upon the Department's receipt of FTA's Notification of Grant Approval.

STATE MASS TRANSIT FUND PROGRAM (FORMERLY, SHIMS PROGRAM)
FOR FY 1994-95

The Division of Mass Transit request the approval of the Department and Transportation Commission to continue the State Mass Transit Fund Program established under the former SHIMS Program, and to re-authorize a maximum sum of \$3.0 million during FY 1994-95 for purposes of implementing local mass transit projects in accordance with policy and procedures adopted by the Transportation Commission on December 16, 1993. A copy of the Department's Announcement and description of the State Mass Transit Program is provided as part of this request.

Announcement and Program Description Next

TRANSFER OF EXISTING GRANTS FROM THE SOUTH CAROLINA DISABILITIES
RESEARCH COMMISSION TO THE CENTRAL MIDLANDS REGIONAL PLANNING
COUNCIL

It is recommended that the Commission approve the transfer of two existing State Mass Transit Fund (formerly SHIMS) grants from the SC Disabilities Research Commission to the Central Midlands Regional Planning Council in order to continue operation of the Dial-A-Ride Transit (DART) service in the Columbia Urbanized Area. The two grants and their amounts involve:

- Contract Number SHP-7792 for \$20,250 and
- Contract Number SHP-3193 for \$43,740

\$12,544 of Contract Number SHP-7792 has already been matched with FTA Section 9 funds by the SC Disabilities Research Commission for the purchase of three paratransit vehicles and computer equipment. This equipment is included in the recommended transfer, plus the balance of the two grants, totaling \$51,446, which will be used to match FTA Section 9 monies for the procurement of eight (8) additional paratransit vehicles.

SECTION 9: On motion of Commissioner Jefferson, seconded by Commissioner Loftus, the Commission unanimously passed a motion authorizing the Department to expedite into a 3 year plan the widening to four lanes of the 31 mile portion of US Highway 52 from Kingstree to Moncks Corner by adding to the State Transportation Improvement Plan (STIP) that portion not already included in the plan.

SECTION 10: The Commission passed a motion to go into Executive Session for the purpose of discussing personnel matters.

OPEN SESSION

SECTION 11: On motion of Commissioner Willis, seconded by Commissioner Loftus, the Commission unanimously passed a motion accepting Mr. Fanning's conditional resignation effective July 23, 1994 with the following provisions:

(1) that the Department pay Mr. Fanning severance compensation of \$60,000.00

(2) that Mr. Fanning provide consultant services, at the cost of \$25,000.00 for a period of six months relating to toll roads and partnering arrangements;

(3) that the details of the Agreement will be left to the SCDOT counsel to finalize.

The motion is predicated on the approval of the Budget and Control Board and all terms of the Agreement, including Mr. Fanning's resignation, are conditional on that approval.
