Subject: One SC Fund - Round Five Grant Details

Good Afternoon!

Thanks to the efforts of the One SC Fund Grants Committee, 15 grants, totaling \$380,000, were awarded to eight nonprofit organizations. (Three of the organizations are undertaking projects in multiple counties.) The funded organizations are providing skilled volunteer labor and an additional \$3,502,252 in financial support for the projects.

To-date, the One SC Fund has provided \$2,268,000 in grant dollars that are being used to repair, rebuild and/or refurnish 1,123 homes. The funded organizations have provided a total of \$20,329,752 through

donations of labor, materials and/or dollars – an almost 10:1 match.

A special note of thanks to Cliff Bourke, who chairs the Grants Committee, for his leadership and to Erin Johnson, CCCF's VP for Community Investment, who is now supporting the work of the committee. Erin joined the Foundation on November 7, 2016 and has developed a sound knowledge about the needs across our state and the organizations that are helping our residents rebuild.

Note: After paying the Round Five grants, the balance of the One SC Fund (thanks to a generous donation of \$75,000 that arrived today) is approximately \$687,000.

And, as the Foundation is not charging fees to manage the fund, CCCF's in-kind contribution now totals \$184,000.
