Comments

This project involves improvements and concrete removal at the intersection of US 301/501 and S-25. The project will require a small amount of new right-of-way (ROW) to straighten the intersection. This project was reviewed using ArchSite, Web Soil Survey, historic maps, and historic aerial photographs. The soil review indicated that soils throughout the project area were somewhat poorly drained. The ArchSite review indicated that no previously recorded cultural resources are within or near the project area. Historical maps and aerials dating to the second half of the 20th century indicate the area was sparsely populated. A cultural resources survey was conducted on November 1, 2018. This survey consisted of a pedestrian reconnaissance of the project area and the excavation of four shovel tests in the proposed area of new ROW. The project area was found to be disturbed from development and the soils within the area of proposed new ROW were found to be hydric. No artifacts were recovered from the shovel tests. Two historic standing structures were noted nearby the project area (Site Nos. 1502 and 1503). Both resources are recommended not eligible for the NRHP. No additional cultural resource investigations are recommended. No historic properties will be affected.



Effect Determination:

For Type I and Type II projects that have no effect on historic properties, the completion of this screening form with supporting documentation (e.g. ArchSite Map) provides evidence of FHWA and SCDOT's compliance with Section 106 of the National Historic Preservation Act.
