Deferred Action for Childhood Arrivals...the schools should have been aware after the AG's opinion came out in March 2014, but in this case I do not think any of the cosmetology schools (private or secondary) became aware of anything until August/September 2014 when we started sending out letters of denial. The applicants have the right to appeal to the full board, but according to the law we cannot issue a license or permit. We started getting calls from many of the schools and we referred them to the AG's opinion and encouraged them to seek their legal counsel for the best approach for those in this type of situation who want to gain cosmetology education from SC approved schools.

Individuals with a DACA status cannot be denied an education, but they cannot be granted a license either. Attached is the AG's opinion.

Good Morning Katherine,

Just following up on our conversation on Saturday. I hope you had a nice long weekend. This is in response to an employee we have named, Mitsy Nidiyare Lugos-Aguilar.

Mitsy Lugos started esthetics school at the International Spa Institute in Bluffton, SC on November 2nd, 2013. She was never informed that she would not receive a license from the State of South Carolina, based on her Work Visa Status. When did the rules in South Carolina change? Or have they always remained the same?

Misty Lugos finished esthetics school in May 2014. She sent all of her completed paperwork into Credential Services, as requested by LLR. She received approval that she could take the practical and written exams required by the state to receive an Esthetics License. Why was she granted approval, if her Work Visa would permit her from being granted a license?

Mitsy Lugos passed both required exams and was never told at either LLR testing location that she would never receive a license, why?

Mitsy Lugos appealed their decision to grant her license and was denied again because of the information on her Affidavit of Eligibility being verified though the federal Systematic Alien Verification of Entitlement. Federal law currently prohibits a state from issuing professional or commercial license to aliens, unless the state has opted out of those federal restrictions. Which this letter says, South Carolina has not opted out. I have attached a photo of the letter that I am quoting below.
