Yes, the interim magistrate appointment can be made like the previous ones. (Pursuant to Section 1-3-210, the Governor may appoint magistrates while the Senate is out of session, but the appointment is temporary, and the Senate must consent to the appointing during its next session (end of 2016 session) in order for the appointment to be permanent.)

The interim appointment can be made after the resignation is accepted by our office. I suggest having the current magistrate send a signed letter of resignation to our office with the effective date. Once accepted, we can make the interim appointment.

The interim magistrate would begin serving as magistrate immediately and would hold the office until the expiration of the current magistrate's present term.
