This is in response to your email to Duane dated December 6. Besides our budget, we have one additional item on our legislative agenda for the upcoming session. That is, to propose technical corrections to the Motion Picture Incentive Act. Amendments have long been needed to add clarity to the statute by using current terminology and practices used by the film industry and the SC Department of Revenue (DOR). We are also proposing the codification of film-related budget provisos. The technical corrections and codification of provisos will not have a fiscal impact.

The draft legislation is complete, except that on Friday we were informed by DOR that they may have an additional amendment. Hopefully, we will have the document finalized and able to send to you next week.
