Mr. Poore called the meeting to order and Councilman Joey Wright gave the invocation.

Mr. Jack Cobb stated that he was still interested in providing credit union services for Anderson County employees. On the motion of Mr. Kinley, seconded by Mr. Hooper, Council voted unanimously to allow the Anderson Community Federal Credit Union to provide services to the employees and to contact the department heads and to schedule meetings to explain the advantages, and the County would provide payroll deductions. Mr. Cobb stated that he could pay for the deductions of the insurance for the 22 employees that participate so that the program could be set up.

Ms. Annie Ruth Morse asked Council to appropriate any additional funds possible for the Black History and Culture Center to restore the Keese Barn. On the motion of Mr. Rhodes, seconded by Mr. Wright, Council voted unanimously to receive as information.

Mr. Thad Arnold stated that the plans for the renovations of the Courthouse were complete and suggested that they be put out on bids and be received back on August 31, 1982 at 2:00 in the Council's Chambers. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to send the bids out.

Mr. Watson discussed requests to renew radio maintenance contract for EMS & Sheriff's Department. Morris Communications could provide the service for the same price as last year (\$8802) for EMS. Communications Service Center proposed the same rates as 1981 (\$7954.80) for the Sheriff's Office. On the motion of Mr. Wright, seconded by Mr. Bratcher, Council voted unanimously to approve the maintenance contracts as requested.

Mr. Karl Kenyon presented second reading of Ordinance #92 (Park Regulations). On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to approve on second reading Ordinance #92.

Mr. Kenyon presented Ordinance #91 (Human Resources Commission) for third and final reading. On the motion of Mr. Kinley, seconded by Mr. Bratcher, Council voted unanimously to approve on third and final reading.

On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to appoint Mr. Pat Flack as the Coordinator & Director of the Human Resource Commission.

Mr. David Hooper read Ordinance #88 (Referendum to Change the Form of Government) for third and final reading. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted three (3) in favor and two (2) opposed. Mr. Wright & Mr. Bratcher opposed.

On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to appoint Bill Hood, Sam Sullivan, and Marshall Pickens to the Anderson County Alcohol & Drug Abuse Commission.

Mr. Rhodes presented second reading of Ordinance #93 (Nine Single Member Districts) calling for a scheduling a referendum to change the number of County Council single member districts for approval on second reading. On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted unanimously to approve the ordinance.

Mr. Kinley read Ordinance #94 (Purchase of a Sewer System) for approval of first reading. On the motion of Mr. Kinley, seconded by Mr. Wright, Council four in favor to approve. Mr. Bratcher opposed the motion.

Mr. Poore introduced Mr. Johnson with Seacoast Equipment. Mr. Johnson discussed the purchase of two Tiger Mowers for \$29,277.04 each. On the motion of Mr. Hooper, seconded Mr. Kinley, Council voted unanimously to authorize the purchasing agent to purchase two of the tiger mowers.

Mr. Poore asked Mr. Kenyon to read a letter from William D. Leeke with the S..C Dept. of Corrections concerning the per capita cost of incarceration for the Department of Corrections.

On the motion of Mr. Rhodes, seconded by Mr. Kinley, Council voted unanimously to give Mr. Poore \$20,000 for patching and aprons for the entire County.

Mr. Kinley submitted Cloverdale subdivision which included Bern Circle, Fairhaven, Arrow Wood Drive, Meadow Brook Drive, Sweet Briar Circle, Cloverdale Road, Clarmount Lane to Mr. Poore to be paved. Mr. Kinley stated that he was authorizing \$61,408 for Mr. Poore to pave these as requested. Mr. Poore said he would try to do it as cheap as the contractor if not then he would recommend that we go with the contractor.

Mr. Rhodes submitted (for tar & gravel) Calhoun & Thomas, Sarrar St., Gallard St., Harrison, Miller Street and Hicks Road-for asphalt to Mr. Poore for repair.

Mr. Hooper submitted: Linmar Circle, Beulyn Road, Breazeale Road, Plantation Road Nelson Street, Memory Lane and Leon Drive to Mr. Poore.

Mr. Bratcher submitted the Honea Path Parking Lot and Clement Road. He stated he would like to get with the Mayor of Honea Path for others.

Mr. Wright will get with Mayor Middleton of Williamston to complete his list.

On the motion of Mr. Kinley, seconded by Mr. Rhodes, Council voted unanimously to appropriate approximately \$75,000 in each district to be used on the roads submitted for repair. This money to come from the Asphalt account in the Contingency Fund.

Mr. Hooper discussed PATH and the USDA Food Program. Mr. Hooper recommended that all but \$1,000 in the PATH budget be transfered over to the USDA Food Program and the balance of \$2,402.50 to be transfered from the Contingency Fund for the Food Program. Mr. Kinley seconded Mr. Hooper's recommendation. Council voted unanimously to approve the transfer.

Mayor Middleton discussed the need for the Sewer Ordinance.

Mr. Kinley requested the Treasurer to submit a monthly report detailing funds received by source, disbursements made, and outstanding obligations for and of the

last day of each month. Mr. Kinley directed the clerk to send her a letter.

Mr. Poore discussed the need for a custodian for the Agriculture Building and the DSS Building. He asked Council to fund a position for an additional custodian. Mr. Kinley asked for prices on a private firm to clean the buildings and report back to Council.

Council adjourned at 10:35 a.m.
