As tensions remain high between President-elect Donald Trump and the intelligence community over Russian election interference, former House Speaker Newt Gingrich said Sunday that Mr. Trump shouldn't have a good relationship with the U.S. intelligence agencies right now.

**Note:** That means his foreign policy and national security Cabinet officials -- including secretary of state nominee Rex Tillerson, defense secretary nominee James Mattis and U.N. ambassador nominee Nikki Haley -- will have a "really large assignment."

**Note:** Gingrich said, adding that Tillerson, Mattis and Haley will be "the explainers who have to be able to go both ways -- that is, walk and say, 'Mr. President what you said yesterday was interpreted the following way.'"

The South Carolina Chamber of Commerce is urging lawmakers to do away with the sales tax exemption on gasoline and eliminate the sales tax cap on automobile purchases in order to generate money to fix the state's deteriorating roads. That's one of the three key thrusts of the Chamber's legislative agenda for this year, along with improved workforce development and streamlining of business licenses for small businesses.

**Note:** Gov. Nikki Haley has insisted that any gas tax increase must be accompanied by a tax cut somewhere else. But with her imminent departure to become ambassador to the United Nations, she won't be a factor in the upcoming debate.

**Note:** Lt. Gov. Henry McMaster hasn't made his position known on the issue, but Pitts said the state's business community is "very comfortable" with McMaster becoming governor after Haley leaves.

But complex legal challenges and a shortage of lethal drugs used in executions could slow or derail Roof's date with a lethal injection.
