Since 2002 she has led the university as its first female chancellor, visiting the Statehouse frequently to advocate for USCB, particularly on the issue of state funding parity. Her current salary is listed in state budget records as \$172,306. Gov Haley at 106k and yes Bill miles at a pay package of what we know 400k .

The university had a head count of 1,794 last fall. South Carolina residents make up 80 percent of the student body, a number that reaches 91 percent when military members and their dependents are factored in, along with reciprocity agreements with Georgia border counties.

The resolution also lists Upshaw's community involvement, including her service on the board of directors for Coastal Carolina Hospital from 2011-13, and on the Hilton Head Island-Bluffton Chamber of Commerce since 2000.
