Mr. Poore called the meeting to order and Councilman Joseph G. Wright gave the invocation.

On the motion of Mr. Kinley, seconded Mr. Hooper, Council voted unanimously to approve the minutes from the May 18, 1982 meeting as mailed.

Ms. Margaret Herron discussed the Good Neighbor Cupboard; a program serving the hungry of Anderson County. She asked Council to consider funding for the organization. Council received as information.

Mr. Curtis Kinley discussed giving the letters from the Bailes Building to the Bailes Family. Mr. Poore stated that Mr. Whitten from the Treasurer's Office had asked for the star. On the motion of Mr. Kinley, seconded by Mr. Hooper, Council voted unanimously to give the letters to the Bailes Family and the star to Mr. Whitten.

Mr. Poore presented his proposed 1982-83 FY budget and Mr. Watson read the Ordinance to Council. Mr. Walters, County Engineer, spoke briefly on the need to repair certain bridges in the County. On the motion of Mr. Kinley, seconded by Mr. Rhodes, Council voted unanimously to postpone the first reading of the budget until June 15 due to the lack of time to study the budget.

Mr. Hooper suggested that Council direct the engineers of Russell & Axon to study the following and report back to Council in two weeks.

1. The cost of air conditioning the Court House.
2. The cost to rewire the Court House.
3. The cost to thermopane the windows in the Court House (like City Hall).
4. The cost of updating and renovating the judges chambers in the Court House.
5. The cost of lowering the ceiling and lighting the ground floor of the Whitner Building.
6. The cost of renovating the Magistrates and jury rooms and Probate Judge's Office.

Council asked that the cost of each of the above to be listed separately and then totaled.

Ms. Taylor asked that Council fund all possible for Path, Inc.
