

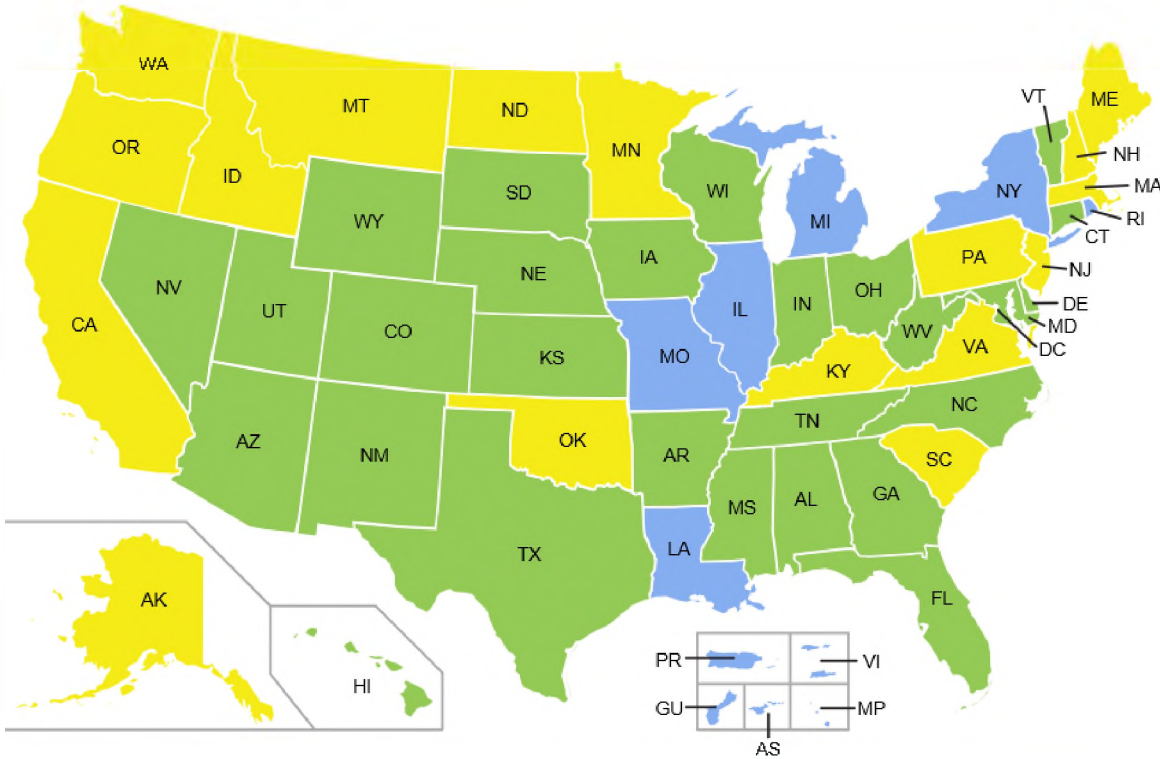

What's REAL ID?

2005 federal law



- US Congress passed in 2005
- Phased implementation
 - All yellow states have extensions through October 10, 2018
 - Last extension SC will have to submit – anticipates compliance during Q1 of 2018
- You must have a REAL ID to
 - Board a flight
 - Enter a secure federal building
 - Visit a military installation



Changing to a REAL ID

What Documents are Needed?

For a complete list of accepted documents, visit www.scdmvonline.com and search "MV-93" (US Citizens) or "MV-94" (International Customers).

- **Proof of Identity**
(Birth Certificate or valid US Passport)
- **Proof of Social Security Number**
- **2 Proofs of Address**
- **Proof of all Legal Name Changes**



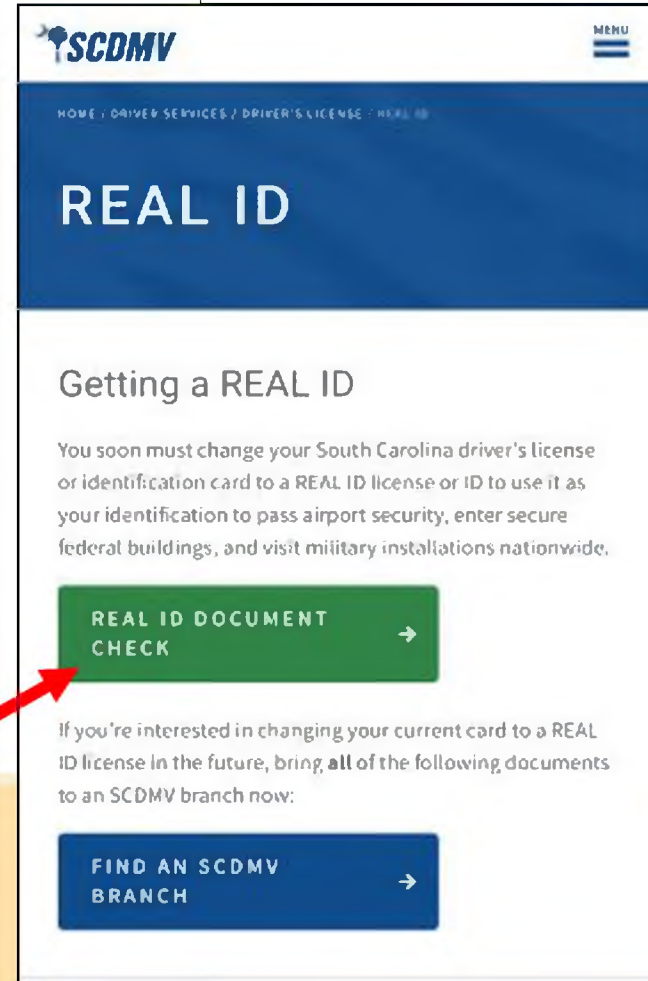
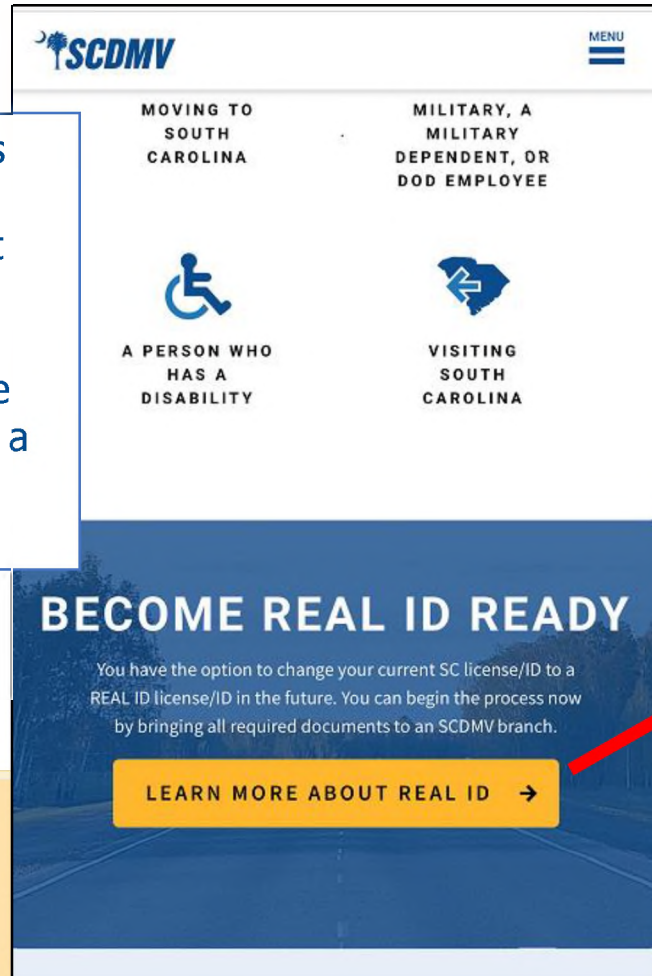
- Bring these documents to the SCDMV now
 - Most people may be able to order online
 - Check if your documents are already in the system
- CDLs, IDs, international customers
- No change in price
- Regular licenses valid for eight years regardless of age



REAL ID Document Check

Check if your documents are on file with the SCDMV. If so, you may be eligible to order and pay for a REAL ID license online in the future.

REAL ID information is available on the Home page. Customers must scroll down until they reach the REAL ID banner, then select the yellow box to move to a REAL ID information page.



The REAL ID information page is a good resource for customers who have questions about REAL ID.

Customers can choose the green button which will take them to the Document Check process.

Order REAL ID license online


















- All required documents are on file with the SCDMV
- You have a regular (Class D, E, F, G, M, or any combination of those) license
- You can pay with a valid card
- Your license is **not** expired
- You did **not** renew your license by mail the last time you renewed
- Your driving privileges are **not** suspended
- You are **not** a convicted violent offender
- You have **not** had five points or more against your driving record in the past two years
- You do **not** have a Conditional or Special Restricted license



Once cards are available

- Two different types of driver's licenses and two different types of identification cards once REAL IDs are available next year
- When state certified compliant (Q1 of 2018), all SC cards valid for federal purposes until **October 1, 2020**

What Should You Do Now

- Locate your Source Documents (Birth Certificate, unexpired Passport, Marriage License, Divorce Decree, Court Documents, Social Security Card, etc.)
- If you're missing documents contact the appropriate agency (DHEC, SSA, Courts, Office of Vital Statistics in your birth state, etc)
- If you're visiting a DMV before Real ID's are issued, submit your documents for filing in our system. If you believe you may have documents already on file, check online or call our Contact Center
- If your license is up for renewal before Real ID – renew online for 5 years/\$12.50
