We just received an update from PEBA with their latest projections for the 2015 plan year. These

models reflect a smaller impact on the FY 2014-15 budget, but also (speaking to Column II here) a variant on a grandfathered plan in which the allowable inflationary increases in deductibles, co-pays, etc. would be made.

I wanted to pass this along, since it replaces the August projections we shared earlier. Thanks.
