### Governor Nikki Haley News:

**Associated Press:** South Carolina military police on tap for Guantanamo force

Military police from the South Carolina Army National Guard have been ordered to prepare for a possible deployment to Guantanamo Bay Naval Base in Cuba as early as this fall, a Guard official said Tuesday. About 100 members of the 131st Military Police Co. in Beaufort (BYOO-fort) have been told to prepare for a potential deployment in the new fiscal year, which begins in October, said National Guard spokeswoman Col. Cindi King.

**Note:** South Carolina Gov. Nikki Haley has been sharply critical of any plan to send detainees to the brig or anywhere else in the state. Last week, Haley criticized the federal government for keeping her in the dark about plans regarding any possible prison site for the detainees, which she contended would make her state a target for terrorists. "I don't want it going into any state in the country," Haley told a House Homeland Security subcommittee.

**The Hill:** Administration speeds up review boards for Guantánamo detainees

The Obama administration has quietly been speeding up the pace of review boards for Guantánamo Bay detainees in an attempt to whittle down the number of prisoners. Since mid-April, the Pentagon has scheduled about two review boards per week through the end of May, up from about two to three per month earlier this year. So far, the number of review boards scheduled and conducted for 2016 is 21, almost double the 12 conducted in 2015. Two more reviews are planned but don't have a date scheduled. "All initial hearings are planned to be completed by the end of the fall," said Navy Lt. Cmdr. Gary Ross, a Pentagon spokesman.

**Note:** South Carolina Governor Nikki Haley (R) denounced the plan last week during a House hearing. "Moving detention operations from a secure facility outside of the continental United States and into Charleston, South Carolina will not stop the propaganda," she said. "This line of thinking is giving these terrorists too much credit and validity. Terrorists do not need a jail to hate us. They hate us all on their own."

**Note:** "Whether the terrorists are detained on an American military base in Cuba or somewhere in the United States, they will be held under the same legal authority, by the same country, in the same manner, for the same duration, and for the same reasons. Why does the zip code matter from a foreign relations standpoint?" she added.

An Iowa-based company that assembles and distributes fiber optic and copper cables is opening up operations in Easley and plans to create more than 70 jobs, the company founder said. Zero Connect had decided to locate its new facility in Greenville before meeting Ray Farley, director of Alliance Pickens, and other Pickens County officials, Larry Kendall said.

**Note:** "The investment that Zero Connect is making in the people of South Carolina is a significant commitment to our state and is a real reason to celebrate," Gov. Nikki Haley said in a release from the Commerce Department. "The 72 jobs this great company is creating in Easley will make a real difference in the lives of South Carolinians, and we look forward to seeing the impact it will have on this community for years to come."

The South Carolina Senate's \$7.5 billion spending plan for the coming fiscal year would finish reimbursing counties' clean-up expenses from the 2014 ice storm. The plan tentatively approved Tuesday would distribute nearly \$12 million to 22 counties. Senate President Pro Tem Hugh Leatherman says the \$4 million provided in the current budget covered just 25 percent of expenses not paid with federal emergency aid. That \$12 million is the first priority among roughly \$50 million in spending senators added Tuesday. The supplemental list will be funded if tax collections exceed current estimates.

A proposal by Sen. Lee Bright to withhold funds to local governments that pass certain bathroom ordinances has failed, likely ending any legislative debate on the issue this year. Bright's proposal came as the Senate began debating its version of the budget for the fiscal year starting in July. The proviso would have withheld funds from any local government if it adopted any ordinance or regulation "requiring a business to allow a person to use a restroom, dressing room, or shower room different than the restroom, dressing room or shower room designated for that person's sex as identified on that person's birth certificate." But senators asked that the proposal be ruled out of order citing a rule that requires amendments be germane and not alter permanent law.

The Aiken County School District has released a statement amid national debate of how public school districts should accommodate transgender students in its public restrooms and locker rooms. Responding to inquiries, school district spokeswoman Merry Glenne Piccolino released a statement on Tuesday to the Aiken Standard. "Aiken County Public Schools does not have a present policy directly related to restroom or facility use in the District other than by conventional designations, as with all traditional public facilities. However, it is has been our practice to work closely with parents and individual students in order to provide reasonable accommodations for student needs while respecting the rights of individual privacy of all students as well."

Chicago Public Schools will allow transgender students and employees to use bathrooms and locker rooms corresponding to their gender identities, according to guidelines released Tuesday by the nation's third-largest school district. The policy, which also applies to "gender non-conforming students," covers all education opportunities, including overnight field trips, and allows for alternative arrangements if requested, such as a single-stall restroom or separate changing schedule. "CPS, like much of the country, has become far more aware of the needs and experiences of the transgender community, and it's crucial for CPS guidelines to reflect our commitment to promoting safe and inclusive schools," district Chief Education Officer Janice Jackson said in a statement.

Attorneys for a white former North Charleston police officer charged in the shooting death of a black motorist are opposing a bid to reschedule the murder trial. Prosecutor Scarlett Wilson last week asked that the trial of Michael Slager be held starting either this August or in May 2017. Slager is currently set to stand trial Oct. 31 in the death of Walter Scott. Wilson says she won't be able to try the case starting in October because she needs then to prepare for another trial, that of Dylann Roof in the Charleston church mass shooting. That trial is set for next January.

The former North Charleston police officer who shot Walter Scott objected this week to a prosecutor's proposal to change his trial date. Michael Slager is scheduled to be tried on a murder charge starting Oct. 31. But a delay in the state's prosecution of Dylann Roof, the accused killer of nine at Emanuel AME Church, prompted 9th Circuit Solicitor Scarlett Wilson to ask for the proceeding to be moved up to August or pushed back to May 2017. The state's high court has excused Wilson from appearing in cases other than Roof's until Roof is tried.

A South Carolina sheriff is praising his officers Tuesday for not immediately firing on a man who pointed a gun at them because there were other people around in a busy retail area of Greenville County. The officers found Reginald Darnell Dogan around 7:30 p.m. Monday after someone called to report a suspect waving a gun, Greenville County Sheriff Steve Loftis said at a news conference. The first deputy demanded the man drop the gun, and instead he pointed it at the officer. The deputy did not fire because he feared he might hit other people visiting restaurants or stores on the busy streets nearby, Loftis said. "This took an incredible amount of self-control and discipline," the sheriff said.

The Columbia Police Department has agreed to take steps to help people who are hard of hearing like providing sign language interpreters. The police department negotiated an agreement with the U. S. Justice Department after a deaf person filed a complaint. In the agreement, the police department will designate a coordinator to make sure the agency complies with the Americans with Disabilities Act. The agency will also provide officers with a card within 90 days to help them communicate with hard-of-hearing people. The agreement also requires the police department to provide a special phone used by the deaf in every station and substation.

The U.S. Department of Justice announced Tuesday it reached a settlement with Columbia Police Department concerning communications access to those with hearing disabilities. "Our first responders play a critical role in protecting the safety of our communities, and we must ensure they can communicate effectively with all people, including those with hearing disabilities," said Principal Deputy Assistant Attorney General Vanita Gupta, head of the Justice Department's Civil Rights Division. **Associated Press:** Police begin wider body camera use after months of testing

After months of testing, many of the nation's big-city police forces are planning to expand their use of body cameras by the summer, but the number of officers with such gear will still be relatively small, an Associated Press review found. The 2014 killing of Michael Brown in Ferguson, Missouri, and other deaths at the hands of police around the U.S. have led to demands that officers be issued wearable cameras to deter misconduct and document shootings and other clashes. But because of cost concerns, union resistance and other factors, the rollout has been slower than some cities envisioned.

Republican front-runner Donald Trump rehashed unsubstantiated claims Tuesday that his rival Ted Cruz's father has links to President John F. Kennedy's assassin, Lee Harvey Oswald. In a telephone

interview broadcast by Fox News on Tuesday, Trump cited a National Enquirer story that claimed Rafael Cruz appeared in a 1963 photo in New Orleans with Oswald and others as Oswald distributed pro-Cuba leaflets. The Cruz campaign immediately denounced the claims as "garbage" and Trump offered no proof beyond citing the supermarket tabloid.

When President Bill Clinton rolled into the small Appalachian town of Ashland, Kentucky, in 1996, cheering crowds lined the streets. Local boy-turned-country music star Billy Ray Cyrus performed a special version of his hit, "Achy Breaky Heart" before nearly 20,000 supporters at a riverfront re-election rally. Back then, this was Clinton country. Today, it looks an awful lot more like Trump town. Hillary Clinton was met in Ashland on Monday by just a handful of supporters and a lone heckler, who shouted: "Go home, Hillary!" Later on, hundreds of protesters stood in pouring rain, waved Donald Trump signs and chanted "Kill-ary" as Clinton toured a health center in Williamson, West Virginia.

The combat death Tuesday of a U.S Navy SEAL who was advising Kurdish forces in Iraq coincides with a gradually deepening American role in fighting a resilient Islamic State, even as the Iraqis struggle to muster the military and political strength to defeat the militants. The SEAL, who has not been further identified, is the third American serviceman to die in combat in Iraq since the U.S.-led coalition launched its campaign against the Islamic State in the summer of 2014.
