never talk to the Doctor & my
attorney handle my case and no
body told me that my attorney was
dis Bar. The Attorney Bar in Columbia
never told any one. I was a hard
worker any time they need me even
when i was off i came in. Not for my boss
but for the patient. I was working to
fix up my trailer and to buy me a
better car for work. I know that you
are a very good person, and i also
know that you will help me because i
have voted on you twice. I voted on
you because i believe in god and
i also believe in you. I will sue them
beside having these pain I can't
work, they did me wrong and i will
