### Governor Nikki Haley News:

**The State:** SC State still doesn't know if \$13.6 million bailout is coming

S.C. State University is still awaiting word from state budget leaders whether they will give the state's only historically black public college a \$13.6 million bailout, school president Thomas Elzey said Thursday.

**Note:** The board, that includes legislative budget leaders and chaired by Gov. Nikki Haley, could provide a loan to the university to pay vendors -- some of whom have not been paid since August, according to school officials.

Their \$12 million investment and 615 jobs they are bringing to the North Augusta area will have a positive impact on the whole of the state and especially the local community," Gov. Nikki Haley said.
