### Governor Nikki Haley News:

**Associated Press:** SC Gov. Haley concerned about Chinese tire tariff

Gov. Nikki Haley wants the U.S. Commerce Department to lower a tariff on tires made in China by Giti Tire, which is planning a \$560 million plant in South Carolina. The Herald of Rock Hill reports (<http://bit.ly/1GZkR9j>) that the governor wrote a letter to the federal agency this week saying the nearly 18 percent tariff "inequitably affects Giti's business."

South Carolina Gov. Nikki Haley has asked the U.S. Department of Commerce to reconsider the countervailing duty it imposed on Giti Tire USA Ltd., saying Giti's duty rate — which is 2 percentage points higher than the general duty — "inequitably affects Giti's business."

Note: "If this error is not corrected quickly, it will hurt Giti's competitive position with their extremely cost-sensitive domestic customer based," Ms. Haley wrote. "I urge Commerce to quickly resolve this issue before it inequitably affects Giti's business as they build their new facility in our state."

**Note:** Chaney Adams, Ms. Haley's press secretary, added: "Governor Haley has always said we have to take care of our businesses and workers. Giti is a company that will take care of a lot of our families, and so when she became aware of the tariff situation, it was important to her to contact the Obama administration directly."

South Carolina Governor Nikki Haley wrote a letter to the commerce department asking them to reconsider the 17.69% tariff against Giti Tire (USA) Inc. for its Chinese produced tires, according to The State.

**Note:** In her letter, Haley asked the department to revise the tariff rate against Giti and urges the commerce department to "quickly resolve this issue before it inequitably affects Giti's business as they build their new facility in our state."

South Carolina's unemployment rate remained unchanged in November at 6.7 percent, the state Department of Employment and Workforce said Friday. The number of South Carolinians working also

reached a record high for another month at 2.05 million people in November as the state added about 5,100 jobs, according to the agency.

More people entered the job search in South Carolina in November as the number of state residents who are working reached a record high, the S.C. Department of Employment and Workforce said Friday. The number of people working reached 2,051,511, while the labor force expanded by 5,563 people to an all-time high of 2,197,756.

The group's board of directors unanimously voted Friday morning to dissolve the nonprofit organization after months of uncertainty about its ability to secure funding next year and alliance director Kim Statler's decision to take a new job at the S.C. Department of Commerce.
