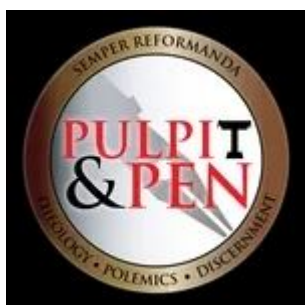
Furthermore, God's Requirement for Murder is [Justice](#), not incremental "regulation". [ Amos 5:15, [KJV](#) ]

Nazi Germany's Third Reich conducted mass exterminations using three main methods

under the command of Reichsführer-SS **Heinrich Himmler**:

1) Mass extermination by shooting and burial in mass graves ( e.g., anti-tank ditches )

conducted by mobile **Einsatzgruppen** (SS) units.

2) Mass extermination in mobile gas vans ( diesel engine exhaust ) conducted by mobile **Einsatzgruppen** (SS) units, then burial.

3) Mass extermination in fixed facility extermination camps ( e.g, Auschwitz, Belzec, Sobibor,

Treblinka ) manned by **SS -Waffen**, by gassing, including use of Zyklon B in the "showers" and

then incineration of victims' bodies in crematoria, such as conducted at **Auschwitz II – Birkenau** .

Einsatzgruppen [ Nazi mobile mass killing units under SS command ]

Einsatzgruppen , "task forces" or "deployment groups") were **Schutzstaffel** (SS) paramilitary death squads of Nazi Germany

that were responsible for mass killings, primarily by shooting, during **World War II** (1939–45).

Under the direction of **Reichsführer-SS Heinrich Himmler** and the supervision of SS-**Obergruppenführer Reinhard Heydrich**,

the Einsatzgruppen operated in territories occupied by the **German armed forces** following the **invasion of Poland** in September 1939

and **Operation Barbarossa** (the invasion of the Soviet Union) launched from **occupied Poland** in June 1941. The Einsatzgruppen worked

hand-in-hand with the **Orpo Police Battalions** on the Eastern Front to carry out operations ranging from the murder of a few people

to operations which lasted over two or more days, such as the massacre at **Babi Yar** with 33,771 Jews killed in two days, and the

**Rumbula massacre** (with about 25,000 killed in two days of shooting). As ordered by Nazi leader **Adolf Hitler**, the **Wehrmacht** cooperated

with the Einsatzgruppen and provided logistical support for their operations. Historian **Raul**

Hilberg estimates that between 1941 and 1945 the Einsatzgruppen and related auxiliary troops killed more than two million people, including 1.3 million Jews. The total number of Jews murdered during the Holocaust is estimated at 5.5 to 6 million people.

After the close of World War II, 24 senior leaders of the Einsatzgruppen were prosecuted in the Einsatzgruppen Trial in 1947–48, charged with crimes against humanity and war crimes. Fourteen death sentences and two life sentences were handed out. Four additional Einsatzgruppe leaders were later tried and executed by other nations.

After a time, Himmler found that the killing methods used by the Einsatzgruppen were inefficient: they were costly, demoralising for the troops, and sometimes did not kill the victims quickly enough. Many of the troops found the massacres to be difficult if not impossible to perform. Some of the perpetrators suffered physical and mental health problems, and many turned to drink.

During a visit to Minsk in August 1941, Himmler witnessed an Einsatzgruppen mass execution first-hand and concluded that shooting Jews was too stressful for his men.

During a visit to Minsk in August 1941, Himmler witnessed an Einsatzgruppen mass execution first-hand and concluded that shooting Jews was too stressful for his men. By November he made arrangements for any SS men suffering ill health from having participated in executions to be provided with rest and mental health care. He also decided a transition should be made to gassing the victims, especially the women and children, and ordered the recruitment of expendable native auxiliaries who could assist with the murders. Gas vans, which had been used previously to kill mental patients, began to see service by all four main Einsatzgruppen from 1942. However, the gas vans were not popular with the Einsatzkommandos, because removing the dead bodies from the van and burying them was a horrible ordeal. Prisoners or auxiliaries were often assigned to do this task so as to spare the SS men the trauma. Some of the early mass killings at extermination camps used carbon monoxide fumes produced by diesel engines, similar to the method used in gas vans, but by as early as September 1941 experiments were begun at Auschwitz using Zyklon B, a cyanide-based pesticide gas.

Plans for the total eradication of the Jewish population of Europe—eleven million people—were formalised at the Wannsee Conference, held on 20 January 1942. Some would be worked to death, and the rest would be killed in the

implementation of the **Final Solution** of the **Jewish question** (German: Die Endlösung der Judenfrage). Permanent killing centres at Auschwitz, **Belzec**, **Sobibor**, **Treblinka**, and other Nazi extermination camps replaced mobile death squads as the primary method of mass killing. The Einsatzgruppen remained active, however, and were put to work fighting partisans, particularly in Belarus.

ri600COLUMBUS, Ohio, March 20, 2018 / [Christian Newswire](#)/ -- Whistle blowers for a national pro-life group, Created Equal, have uncovered ongoing illegal transactions of dead baby body parts between a Greenville, SC abortion clinic and Stericycle, America's largest biological waste hauler. On three separate occasions, [video](#) was captured showing a representative of Greenville Women's Clinic illegally transporting dead babies in a passenger car and transferring the aborted baby body parts

to a Stericycle waste truck at a local gas station.

Five different transactions are referenced in a March 6, 2018 [Notice of Alleged Violations from the S.C. Department of Health and Environmental Control](#) (SCDHEC) to Greenville Women's Center and Stericycle.

According to the letters from the SDHEC's Bureau of Land and Waste Management Division of Compliance and Enforcement these illegal actions violate [South Carolina's Infectious Waste Management Regulation 61-105](#). The [SDHEC alleges](#) that Greenville Women's Center (GWC) violated nine regulations. They include:

- Illegally transferred and storing infectious waste (aborted babies).
- Transferring waste at a non-designated transfer facility (gas station).
- No having a properly marked transfer vehicle and leak resistant cargo carrying containers.
- Not being registered as a transporter of infectious waste.
- Having no infectious waste management plan.

The [SDHEC alleges](#) that Stericycle violated five regulations. They include:

- Illegally transferred and stored infectious waste (aborted babies).
- Illegally transferred infectious waste from one vehicle to another at a non-designated transfer facility.
- Illegally accepted infectious waste without a proper manifest.

Greenville Women's Clinic has been investigated before, found in violation of other rules and regulations, and issued enforcement actions after inspections were completed in September 2017.

"Abortionists and their medical waste enablers are the dregs of society and medicine and, therefore, are forced to conduct their nefarious activities in secret. Because abortionists kill babies, they also break other laws. We thank the SCDHEC for bringing to light both the unlawful conduct of Greenville Women's Clinic and Stericycle. We demand the SDHEC shut down both these operations over these violations, not just given a slap on the wrist." -- Mark Harrington, President, Created Equal
