Monday's work group meeting which included staff and leadership from DSS, DJJ, and SDE was extremely productive and served to help further clarify the programmatic requirements for the future JDLH services to children as required by the transition proviso. We have also received additional information from President Webb, and have spoken with Mr. Shonka and several other JDLH board members as requested by the advisory group.
