I was notified today via e-mail that the personal information of myself and my family was compromised due to the SCDOR failing to maintain proper security measures around my tax returns. I appreciate that the state has offered to pay for ID Theft monitoring service through Experian. However, being that I have been identified as someone whose data was compromised, why is the state only paying for the first 12 months of ID Theft protection, and not paying for a lifetime subscription? Why is it going to be my financial responsibility to pay for this service after the first year for something that the SCDOR caused through their incompetency? Knowing that the state has provided this service for free for only the first 12 months, the person or organization who has the financial data of myself and my family will most likely wait for 12 months before trying to use my compromised data before fraudulently using it.
