Claiming I called her work place and threaten to run into the work place building with my car and running over her and watch her die. She said, I had physically and mentally abused her for two years. She said, I threaten her life if she does not give me all her money and did not allow her to leave the home. O rder of protection was put in place on 5/04/2015 by the Honorable Judge Michael Holt.

On 7/23/2015 Jennifer Matthews filed a complaint with city officer Shenda McLeod and a warrant was served on me and I was put in jail.Jennifer Matthews claimed a call from unknown number was answered at her work place and officer McLeod heard me threaten her.I don't know the officer, how would she know my voice. September 16,2015 in court, no officer,no statement from officer and because I did not receive all ny paper work , the judge Holt put case off until October,19,2015.

Jennifer Matthews married Richard Lane Jan.06, 2015 by our pastor Ricky Miller in Dillon, S.C.

Jennifer Matthews on March 2014 DHEC charged her with"ILLEGAL DISTRIBUTION OF DRUGS"(LORTAB AND XANEX).

Sometime in early May,2014 she did not have a vehical and after church ask if I would take her to see one of her former hospice patients, she wanted to take her some peaches from my tree.She went in and I smoked a cigarette outside,the lady's husband invited me to sit in living room with him,shortly Jennifer came out and we left.

On May 29,2015 We were both served by Marlboro County Sheriff with a warrant for Burglary,1st degree,stealing pills and turning oxygen up on patient .We both were locked up and released on a 50,000 bond.

INNOCENT MEN'S LIVES ARE BEING DESTROYED BY ,WOMEN WHO FALSELY ACCUSE A MAN OF DOMESTIC VIOLENCE WITHOUT FEAR OF CONSEQUENCE, BUT THE ACCUSED MAN HAS NO VOICE AGAINST HER.MY WIFE IS A MENTALLY DISTURBED INDIVIDUAL, USING SUCH LAWS TO EXACT HER REVENGE AGAINST FORMER HUSBAND AND NOW HER PRESENT HUSBAND.

A complaint was filed in family court of the fourth Judicial Circuit by Janet Altman Byrd, attorney for Jennifer Lane , husband Matt Matthews. Filed by Gwen T. Hyatt on June,17/2013 at clerk of court ,Dillion, S.C. On pg.(2of6)paragraph 5, husband of 15 yrs.and giving birth to four children by him accuses Jennifer Matthews of drug addiction to Xanax and possibly other drugs unknown and habitual drunk.

Pg(2 of 6)paragraph 8, husband, Matt Matthew claim his wife Jennifer had called local police to there home claiming domestic violence on *2 times* him,police found these claims unfounded.Matt stated that he feared for hiself and minor children's safety.

Pg(4 of 6)Matt Matthew requested a restraining order to prevent Jennifer from harassing, threatening,abusing or coming about his children,place of employment,and parents home on both temporary and permanent basis.

Pg.(5 of 6)paragraph 20,restraining order to prevent his wife from exposing children to any immoral,indecent, or illegal activites.

A. Granting divorce on ground of habitual drunkenness.

B.Matt Matthews received sole custody of four minor children.

J. Jennifer Matthew could only have supervised visitation with her children.

On November 16th,2013, Richard Jay Lane was taken by officer Randy Tyler to county jail and booked for Domestic Violence on Jennifer Matthews .Jennifer Matthews, by letter and verbal ,and to John Waller, attorney for Richard lane, denied that she made any statement to officer Randy Tyler, aledging that he made this up because he was friends with her parents ,and with Richard Lane in jail ,my parents and him would move me out and take me home the next day, and they did. The following monday , Jennifer slipped out of parents home and went back to Richard Lane.

The 911 call was made by Betty Brigman, for destruction of property.

Mr. Randy Tyler is no longer with Dillon Sheriff dept.

VERSES RICHARD JAY LANE, INCIDENT 11/16/2013

CALL TO 911 MADE BY BETTY BRIGMAN, FOR PROPERTY DAMAGES. ON DECEMBER, 9 /2013 TAPE WAS SUBPOENA BY JANET ALTMAN BYRD. THIS CALL CLEARLY STATES BETTY BRIGMAN AS CALLER, JENNIFER DENIES SAYING ANYTHING TO SHERIFF TYLER THAT PROMPT HIM TO DOMESTIC VIOLENCE CHARGE ON RICHARD JAY LANE. MR. TYLER IS VERY GOOD FRIENDS WITH HER DAD HARRY MCKENZIE AND RETURNED ON 11/17/2013 WHILE HARRY MCKENZIE AND WIFE WERE MOVING JENNIFER OUT. HE AFTER THE FACT TOOK PICTURES OF DAMAGES TO WALL AND HELPED HARRY MOVE FURNISHINGS TO FLAT BED TRAILER. AT THIS TIME MR. LANE WAS IN DILLON COUNTY JAIL. ONLY JENNIFER, HER MOTHER AND FATHER WERE GIVEN PERMISSION TO BE IN DWELLING, MRS. BRIGMAN DID NOT GIVE RANDY TYLER PERMISSION. MR. TYLER HAD DISCUSSED THIS WITH HIS NOW GIRLFRIEND ON DAY OF INCIDENT AND SHE WAS TEXTING JENNIFER, SISTER ON FACE BOOK, INFORMING HER OF CONFIDENTIAL MATTER. THIS MATTER HAS BEEN TURNED OVER TO HONORABLE JOHN WALLER, IN MARION. NO ACTION HAS YET BEEN SERVED ON RICHARD JAY LANE, AS TO ANY COURT HEARING. I FEEL THAT ITS ON BACK BURNER UNTIL AFTER JENNIFERS HEARING. LET JANET PLAY THE TAPE., ';;;

I Jennifer M. Matthews, testify to the fact that on November 16th, 2013 there was no physical contact or any verbal threats made to me Jennifer M. Matthews by Richard Jay Lane.

On the weekend of November 16th of 2013 Richard Jay Lane and I had a lover's quarrel and fuss that did involve cursing and my clothes being thrown into the floor of our bedroom but at no time did he ever put his hands or any object on my body and he never verbally threatened me.

This is an innocent man in regards to the charges of Criminal Domestic Violence. I never called 911 or asked anyone to call 911 on November 16th 2013 regarding me and Richard Jay Lane to report any verbal or physical domestic violence. Richard Jay Lane went to sleep on this day approximately 12:00 pm after our argument and never at any time did I feel threatened by him or that I needed to call 911 or did I feel that I needed to leave my home.

Mrs. Betty Brigman, my landlord came to the residence that evening approximately 4:00 – 5:00 pm and entered the home seeing a hole that Richard Jay Lane had knocked in the living room wall with his hand. This made her very upset. At this time Richard Jay Lane was still sleeping. She then picked up his phone and immediately called 911 to report property damage to her home.

Mr. Randy Tyler arrived at our home and spoke to Mrs. Betty Brigman. Mrs. Betty Brigman told Randy Tyler she wanted Richard Jay Lane arrested for property damage. Officer Tyler replied "This will only hold him 24 hrs. I need more than this."

I Jennifer M. Matthews never asked to speak to Officer Tyler. I never said that Richard Jay Lane put my head through the wall; I never stated that he grabbed or threatened to kill me with a garden hoe, and I never stated that he threw any glass at me. This glass was a liquor bottle that he dropped in the kitchen earlier in the day. The bruise on my left upper arm was not placed on my body by Richard Jay Lane. This bruise was acquired at my place of employment at Regency Medical Hospital of Florence SC while assisting a patient out of the bed where they grabbed my arms to pull up on. This bruise was already green which proves that this was an old injury. Richard Jay Lane was asleep from approximately 12:00 pm to 6:00 pm on this day. If I Jennifer M. Matthews felt threatened or feared for my safety in any way I had ample time to leave.

I am not currently with Richard Jay Lane. I am coming forward to clear his name of these untrue and false accusations as he is an innocent man. I never stated or accused Richard Jay Lane of any of these accusations that I read on the incident report. I never signed or gave any information to Mr. Tyler other than the fact that we did have an argument on this day.

I willingly give this statement on my behalf Jennifer M. Matthews. I have not been

threatened, paid or influenced by any means to submit this statement by anyone. I am submitting this to clear my name and prevent an innocent man from criminal charges on false statements.
