As a reminder, we plan to discuss the following during our time together:

- * Strengthening service providers to take advantage of pay for success financing
- * Other interventions (e.g. Triple P, quality pre-kindergarten, etc.) worth exploring for PFS
- * Legislative considerations for moving PFS forward in South Carolina

During the feasibility study process, we determined that more work needs to be done to strengthen early childhood service providers to focus on their outcomes, to help develop their financial, human, and social capital to take advantage of PFS financing, and improve evaluation to account for successes. Whether to prepare for PFS opportunities or not, we believe it is important to assist providers to prepare for an outcomes based world and are considering several ways to do that. We would very much appreciate your insights during this meeting.
