Mr. Young:

Within the last two weeks my Social Security number has been accessed by someone and they redirected my monthly distribution to an account they had opened online to a bank in Kansas City, MO.

My husband and I subsequently "Blocked" our Social Security accounts to prevent this from occurring again

The reason I am e-mailing you is that the recent steps take by the State **do not** prevent this from happening. What all Social Security recipients should to is to "Block" their accounts on the Social Security website. This means if you need to make any change i.e. change of address, etc. one would have to visit a Social Security office to unblock their account.

Someone in the State Government and Social Security should communicate this information to anyone receiving Social Security benefits.
