Subject: Hurricane Mathew update 4 Oct 5

Good Day All


Horry County is at OPCON 3 with full activation of the EOC in response to the potential threat from Hurricane Mathew. Based upon the direction from the Governor, Horry County is preparing for a possible evacuation for Zone A at 7 AM in the morning. Resources are moving into the county to support that evacuation at this time. Lane reversals will **NOT** be used unless there is a last minute reason to do so. If there is an evacuation, all of the Red Cross hurricane evacuation shelters will open at the time the evacuation starts. The shelter list can be found on emd.horrycounty.org. The EOC will be staffed over night as well. The phone bank is in operation as well so you can direct folks to contact us if they have questions. The number to call for information at the EOC is 843-915-5150.

The latest NHC forecast tack below has a significant bend to the right as Mathew approaches SC. This is an interesting shift which has been showing up on one of the models. I am very hopeful that this trend will continue. We still have 3 more NHC forecast packages to look at before 7 AM so we will see.

Operational Issues:

EOC activated but with the change in potential evacuation time until in the morning, we have reduced our operational staffing so not to burn everyone out. At this point, the EOC will still be staffed over night to be ready for the 7 AM evacuation order. We will be back at full staff by 6 AM.
