This system of indexing is patented, and some copies both the sub-index and sheets containing the general index, the loose leaf binder in which the sub-index and sheets are bound, and the sheets of the general index, are sold by the Walker, Evans & Cogswell Co., of Charleston, S. C., also by the State of South Carolina, and by the State of Georgia, Florida and Alabama.
