I also know that they've been in my home with attempts to poison me and my family, slowly so that if something happens to us it will appear as "natural cause" I know that they've planted listening devices and audio in my home (I hear beeping sounds and can't seem to figure out where the sounds are coming from). I've had white powder on my stirring wheel and light fixtures in my car.

I've been subjected to psychological terrorism by corrupt members of law enforcement, fire fighters, recruited cults and civilians. Law enforcement has been using systematic harassment using noise (sometimes from nearby residences) unauthorized wiretapping, email hacking, mail tampering and computer hacking to harass and stalk me for retaliation.

I, nor my children or my partner are in trouble with law enforcement, nor are we under investigation for any reason. I'm a single African American woman and I'm striving to run a small business. This complaint is one of many. I'm in a daily battle for my right to live freely. The more I complain about the meticulous/organized acts that are being inflicted upon me (car damage, phone tampering, mail tampering, email hacking, computer hacking and possibly unlawful entrance to my home) for retaliation, to my local law enforcement the stronger the gang stalking/organized harassment gets. The organized harassment has been going on for over a year now and it's getting worse.

My name is Genevieve Hopkins; I am seeking help from you, the Department of Justice and the Office of Investigation in Washington DC. I am being gang stalked/ organized harassment, by my local law enforcement and I know that the City of Spartanburg is involved as well. I know that the vast majority of the law enforcement officers in this country perform their very difficult jobs with respect for their communities and in compliance with the law. Even so, there are incidents in which this is not the case.

Someone is intercepting my packages through FedEx with attempts to poison me my family and my customers. I am a "Targeted Individual". I know that law enforcement have started an intense slander campaign against me and have recruited or coerced people to participate. I know that all of this is designed to virtually neutralize and destroy me and my company over time.

The retaliation arises, because I sought help from the South Carolina Human Affairs Commission in Columbia South Carolina, (Case#SHAC-#3-7-28-14-50, EEOC Case # 14C-2014-01031), Legal Aid Spartanburg South Carolina (Mrs. Krystal Alexander) other regulating authorities, grant issuers and me speaking out in reference to the discrimination against me by the Hub City Farmers Market and the City of Spartanburg, here in Spartanburg South Carolina.

The Hub City Farmers Market is a non-profit organization and has a constant need for grants, sponsors and individual tax-deductible contributions to run their market. The Hub City Farmers Market is heavily funded by the city of Spartanburg.

I have reached out to my state attorney general (no response); SLED, local law enforcement, FBI in Greenville South Carolina, and no one will help me with the law enforcement retaliation. I filled an immediate complaint on line with the Internet Crime Department in Washington Complaint Id: 11603011343011062 and Complaint Id: 11602291436411532, the emailed that I used is originetca@gmail.com, since then law enforcement, has went in and locked me out of my email, they are purposely doing this so that I cannot get access to help against them.

I have proof that a "fire fighter" or his wife (Robin Novak) hacked into my email to share information with others in reference to the case, that they are retaliating against me for. When they stalk and harass me, they let me know and find humor in it. I know that it's designed to put fear into me, and to show me that they have power, so that I will not contact the Department Of Justice and the Office of Investigations about what they are doing to me. They do not want me to move forward with my law suit against the city of Spartanburg and the Hub City Farmers Market. They have been striving to keep me quiet for almost two years.

I was a vendor at the Hub City Farmers Market, during my time at the Hub City Farmers Market, the executive director Brendan Buttimer and market manager Devon Gray (whose husband is a city police officer) engaged in a pattern of discrimination towards me. I have documentation and pictures to support my claims. Before Mr. Brendan Buttimer & Devon Gray came, my character had never been in question at the market or anywhere that I would go to sell and promote my small business.

The executive director Mr. Buttimer is aggressive and extremely confrontational. When Mr. Buttimer and Devon Gray unexpectedly expelled me indefinitely without cause, I repeatedly asked for an explanation as to why I was asked to leave. Neither he nor the market manager gave me an explanation.

After doing a lot of research, I found Mrs. Novak and called her on the phone (at her job); I asked if I could meet with her, I didn't share why over the phone or my name. I told her that I would explain everything to her when we meet; I told her that we could meet in a public place or at her job if she felt more comfortable. She agreed to meet with me at her job. I went to her job (Ambulatory Surgery Center Of Spartanburg located at 720 N Pine Street Spartanburg) when I arrived I went to the front window and the receptionist called Mrs. Novak and Mrs. Novak met me, then led me back to her office, as soon as I went into her office, I spotted the actual picture that's the profile of her and her husband that's on the email of hers that hacked my information. One of the people that have been hacking into my phone and email made the mistake of allowing my phone to sink their email contacts into my cell phone.

I began to explain to Mrs. Novak that someone has been hacking into my Gmail account illegally, under the email "tqmunurse@gmail" and this picture that's here in her office is the profile picture, I put my phone battery back in (I have to do this to keep them from removing things) to show her, she admitted that it was her email, but had not used it in years, she also asked should she be worried, she also asked how did I find her. I found that odd, I said no you should not be worried, but please let your husband know.

I took a chance and asked her if her husband was in law enforcement, she said no he's a "firefighter" but have law enforcement friends all over. I asked her if it was possible for me to speak with her husband; she said no, she seemed real nervous during our meeting. The next day the Gmail profile picture of her and her husband "tqmunurse@gmail" was removed? Please DO NOT let this lady job or titles mislead you; she and her husband are involved in the gang stalking against me.

In the month of December 2015 my next door neighbor which is a detective pulled me over (tag #JIM 513) in what I thought was his personal vehicle, I strongly believe that he's in on the gang stalking against me as well, he has now switched vehicles and have a different tag, because law enforcement is monitoring everything that I do, I'm sure that the detective is very much aware that I'm preparing this letter for you, Department of Justice and the Office of Investigation in Washington DC.

When the detective pulled me over he corned me off and turned the blue lights on and got out of his vehicle and came to my driver's side door and started interrogating me, I asked him why did he pull me over and interrogating me and why was he asking about a car (my partner) at my house. He was yelling at the top of his lungs at me, stating that I was following him, that's why he pulled me over?

My partner is enrolled at the Spartanburg Community College for Heating and Air, he was so grateful to get help through SC Works here in Spartanburg County. I run a small business called Origin Tea; my small business is registered with the South Carolina Department of Agriculture. We both have had mishaps in our lives, I had a rough life growing up but we are striving to have a brighter future.

A few days later after the detective pulled me over (in the month of December 2015) I arranged a meeting to set down to talk with the detective's Lieutenant "Matt Hutchins" during my meeting with Mr. Matt Hutchins, I told him that I was very concerned with the way his detective treated me and my concern for the way the detective abused his use of power to unlawfully pull me over. I also explained to Mr. Hutchins that I did not know the detective's name, but gave him the detective's tag number, the detective has had the same truck for years, and Mr. Hutchins was able to locate him by me providing the tag number.

I also showed Mr. Matt Hutchins packages of mine that had been tampered with by the postal service (he took pictures) and also showed him the hacking of my personal emails in my phone "tqmmuuse@gmail". I explained to Mr. Matt Hutchins that sometimes my mail never makes it to me, and that it seems to always be my personal mail. Mr. Hutchins took a lot of notes, I thought that he was opening a case for me, but I never heard back from him.

I had to call Mr. Hutchins several times and even reached out to Mr. Hutchins by email, to forward a copy of email hacking again and he never responded, when he finally returned my call, he seem to be upset with me for seeking help.

The next day I went to the FBI in Greenville South Carolina, I met with "Drew Gration" (I can't really make out the correct spelling of his last name, he scribble the last name), but once again after showing Drew everything and sharing my same concerns with him, he treated me worse than Mr. Hutchins. I asked Drew if he could please note that I had been there to file a complaint, he seem to discredit all of my concerns and said that they couldn't help me, I ask for his name or a card, he seem to not want to give it to me, but scribbled it on paper.

A few days later the "Organized Stalking" got worse. Someone starting getting inside of my car tearing up my sun roof, cutting in the door and messing up my starter, I called the police twice they were not helpful and did not want to assist me, I had to ask for a report, they never looked inside my car nor took finger prints. I explained to them that I needed a report for insurance purposes. A few weeks later my car had a wire fire, from someone digging into my starter, I called the fire department, they also did not want to give me a report, to allow my insurance company to help me. The report that the fire department gave me stated "that my car had been running for an hour in my yard, and that it appears to be normal wear and tear", I was shocked! This is what they are putting on all reports, I have filled in reference to my vehicle.

After being treated unfairly again, I went back to the police station to file another complaint against the two officers that came out in reference to my vehicle break in. I've never heard back from anyone. This happened back in December of last year.

I know that organized gang stalking is a hate crime erected in a system. The organized ways that my vehicle is being damage, phone tampering, US Postal mail being intercepted, FED EX mail being intercepted, email hacking, computer hacking and unlawful entrance into my home is being did, leads only to law enforcement. They come into my home a move things arounds on purpose, to show me that they have access to my home and plus to shut me up.

I feel that law enforcement and their recruited members of cult and possibly KKK have studied me to such a level that they know and can predict my daily going coming and behavior. Once they realized that I was on to the stalking and harassment they simply changed dimensions and frequency, and it still continues.

I know that identifying the exact people who initiated this gang stalking campaign against me is difficult, but certainly not impossible to prove, I do have some proof, some Targeted Individual don't even live to tell their stories. When I became aware of what was happening I began to do a ton of research on this, and was brought to tears, while reading others stories on blogs and other websites, people are crying, begging and pleading for help against this horrible attack of terrorism against innocent people just because, they voiced their concerns, whistle blower, African American or because they no too much or have incriminating information against these corrupt people.

They try to silence their target with fear tactics. They do some things boldly because they know that law enforcement is behind them 100%. When this happens on a regular basis, it is quite obvious to their target that it's being done deliberately, and is highly organized as only professional people would have the knowledge and capabilities to get away with this type of thing.


I've also learned that when a targeted individual reaches out for help by friends, family and authorities they often get labelled as paranoid, as there is often no proof of this being done and it all sounds impossible-resulting in the victim being re-victimized all over again. For the harassment to be successful the victim is driven into isolation. There is a desperate need for public awareness of the covert targeting and recruiting/enslavement of good decent people around the globe.

I've also learned that most members of the covert harassment program are respected community members like waitresses, nurses, doctors, judges, government employees, teachers, lawyers, construction workers, doctors, etc. Most members of the program appear to be mind control victims. Many play such a small role, in the targeting process, that they are probably not aware of being used to help destroy the lives of their fellow human beings. On these darker levels of it some members are obvious criminals or dark occult members who are used to execute crimes against their victims. Every level of it appears to be lead and controlled by some sort of dark occult, people with power and law enforcement.

The covert stalking and harassment process is so cruel and barbaric that it becomes unbelievable to those whom we try to get help from. Perhaps the most painful part is the fact that there has been no safe place for Targeted Individuals to turn to for protection and help. People are being hurt in ways that are indescribable. Our lives are being destroyed. There is a desperate need for public awareness of ALL levels of the targeting and recruiting process.
