The CWRC initiative will be developed as a county initiative and will bring multiple partners to the table to include Economic Development, K12, Adult Education, Voc Rehab, Technical Colleges, County Administrators and Business/Industry. Each county will develop a partnership among all stakeholders in order to meet the CWRC county goals.

The Technical Colleges will play a major part in the CWRC initiative as one provider of WorkKeys assessments and job profiles. Currently, the technical colleges charge a proctoring fee for taking the WorkKeys assessment as they do for many other on-line testing/certifications. This fee goes to support the operations of the testing center operations to include proctoring and computer maintenance.

The colleges understand that SCDEW potentially will cover the costs of the WorkKeys assessments. Fees beyond the

costs of the WorkKeys assessment will be determined by each individual college as a partner in the CWRC county initiative.
