I think one of my homework assignments from yesterday was to take a crack at the passage that's highlighted by comment [EB5] (Part IV...the "any relevant discounts" bit). Here's a first attempt at it...this would just replace the "any relevant discounts" sentence itself. As I look at it, it feels a little clunky and overly-complex to me, but you might have a different take. Thanks.

The price proposal shall reflect an Offeror's net proposed cost to the state. SCDHHS recognizes and each prospective Offeror should be aware that similar procurements in other jurisdictions have drawn the interest of a broad range of potential bidders, including publicly-traded consultancies, privately-held advisors, charitable organizations, non-profit advisors, investment banks, and other entities. As a result, one or more Offerors may tender a price proposal that reflects no net cost to the state, due to the Offeror's support from philanthropic interests or other sources.

Any Offeror that submits a price proposal that has effectively been discounted or subsidized due to the Offeror's reliance upon grants or other operating support from another entity or entities must disclose that support by including with its price proposal material that discloses the sources and amounts of that support.
