

A meeting of the **COMMITTEE ON COMMUNITY SERVICES**, Standing Committee of Berkeley County Council, was held on **Monday September 12, 2005**, in the Assembly Room of the Berkeley County Administration Building, 1003 Highway 52, Moncks Corner, South Carolina, at 6:16 p.m.

PRESENT: Mr. Charles E. Davis, Council Member District No. 4, Chairman; Mr. Phillip Farley, Council Member District No. 1; Mrs. Judith K. Spooner, Council Member District No. 2, Mr. Dennis L. Fish, Council Member District No. 5; Mr. Caldwell Pinckney, Jr., Council Member District No. 7; Mr. Steve C. Davis, Council Member District No. 8. Mr. James H. Rozier, Jr., Supervisor, ex officio; Mr. D. Mark Stokes, County Attorney; and Ms. Barbara B. Austin, Clerk of County Council. Mr. William E. Crosby, Council Member District No. 3 and Mrs. Judy C. Mims, Council Member District No. 6 were excused from this meeting.

In accordance with the Freedom of Information Act, the electronic and print media were duly notified.

During periods of discussion and/or presentations, minutes are typically condensed and paraphrased.

Chairman Charles Davis called the meeting to order and asked for approval of minutes from a meeting of the Committee on Community Services dated August 8, 2005.

It was moved by Council Member Farley and seconded by Council Member Pinckney to approve the minutes as presented. The motion passed by unanimous voice vote of the Committee.

A. Ms. Colleen Carney, Berkeley County Library Director, Re:
Change in personnel request.

Ms. Carney requested additional funds for the library's personnel budget. The Administrative Assistant is retiring at the end of November and the position is critical to the library operation. Extensive training of the replacement will be required. The overlap of personnel for training will require funds of \$5,824.78.

It was moved by Council Member Spooner and seconded by Council Member Pinckney to approve \$5,824.78 in additional personnel funds. The motion passed by unanimous voice vote of the Committee.

B. Mr. Barry Jurs, Farm and Land Services Director, Re: Transfer of funds within the department.

Mr. Jurs requested a transfer of \$686 from 5107 (outside temp workers) to 5106 (student interns). The student intern can complete a specified project and fill in while the department secretary is on vacation.

It was moved by Council Member S. Davis and seconded by Council Member Spooner to approve the transfer of \$686 from 5107 to 5106. The motion passed by unanimous voice vote of the Committee.

It was moved by Council Member Farley and seconded by Council Member S. Davis to adjourn the Committee on Community Services meeting. The motion passed by unanimous voice vote of the Committee.
