91.27. (LEG: Statutory Appointments) Beginning on January 9th of the current fiscal year, all appointments of the

◀ **Lieutenant. Governor** provided for by statute shall be made instead by the President of the Senate.

Should we be concerned about our ARCC and the SC Advisory Council on Aging if the General Assembly fail to deal with the Office on Aging in either S.107 or S.1120? If one of those bills doesn't pass than statutorily the Office on Aging remains under the Lt. Governor. However, as worded, this proviso would restrict the Lt. Governor from making appointments to committees failing under his office.
