I WON'T CITE WHAT THAT'S A REPEAT OF HERE, BUT?
IN MY PAPERS ON PAROXYNETINE, YOU'LL FIND FLETCHER PROUTY'S
DESCRIPTION OF THE MATRIX BAD ELEMENTS OF CIA CREATED,
HAS GROWN EXPONENTIALLY, AND IS USING, TO DESTROY THE U.S.
TO DO THIS, THE CONSTITUTION WAS SUBVERTED, AND THAT WAS CLASSIFIED.
THEY CAN BE F.B.I., OR F.D.A., OR C.H.P., OR YOUR DOCTOR;

I HOPE YOU'LL ACCEPT MY APOLOGIES, FOR THAT ASPECT OF DOING
MY CIVIC DUTY. I'VE WORKED FOR AMERICA, AND VETERANS, VERY HARD.

IN THE LETTER, YOU'LL SEE ME SAY, "ALL I EVER WANTED TO DO,
WAS BE MYSELF, PLAY MUSIC, BE SUCCESSFUL, AND LIVE A HAPPY

BECOME AT THE SAME TIME; TO BE THE FORMER, IS TO CHANGE THE
LATTER (WHICH, YES, HAS BEEN WORKING IN CONJUNCTION WITH VERY
SUBVERSIVE DEMOCRATS AS WELL) YOU CAN'T DO/BE BOTH; THEY ARE
INCONGRUENT, AND SHARPLY CONTRADICTORY. FASCISM IS AT WORK -
AFTER WHAT I SEE SO MANY POSTING ON YOUR FB PAGE, I CAN

THAT'S GOING TO TAKE A LOT OF SUNLIGHT, AND A REALLY BIG ROOT CANAL.
TO DO THAT, YOU WILL HAVE TO BECOME PRESIDENT.

IF YOU'RE TRULY 'AMERICA BEFORE PARTY', I HOPE YOU DO.

AND IT SURE AIN'T BECAUSE I WANTED TO BE...

HELLO, GOVERNOR HALEY.

THOUGHT I'D DROP THIS IN THE MAIL, AND SAY,

I THINK I'VE SAID WHAT I'VE NEEDED TO, OVER THE COURSE OF LETTERS, POSTS TO YOUR WEBSITE, PHONE CHATS W/ JAMAL, AND MORE RECENTLY, MY COMPLETELY GRAFFITI-ING YOUR FB PAGE. (SORRY IT TOOK THAT)

WHILE THIS MAY CONSTITUTE MY HAVING "OVERDONE IT" - AND IN THE PROCESS, MY HAVING PROBABLY EVEN MADE YOU ANGRY - IT'S MY HOPE YOU MIGHT PUT THE TRUTHFULNESS - AND THE SERIOUSNESS OF WHAT I'VE SHARED ABOVE AM IRE I'VE DRAWN, BY BEING AS OUT-SPOKEN AS I HAVE.

THERE IS NO ROADMAP FOR NAVIGATING WHAT I'VE BEEN THROUGH/AM IN.

I'D LIKE YOU TO KNOW, I TAKE VERY SERIOUSLY, WATCHING YOUR FACEBOOK TIMELINE OPEN UP, ON IT'S OWN, TO THE OCT. 13, 2011 POST, ABOUT WHAT YOU DO WITH INMATES; AS THAT IS MY OWN BIRTHDAY, I CONSIDERED THESE ONLINE MECHANICS A THREAT, TO MAKE ME ONE OF THOSE INMATES. YOU CAN'T LEGALLY DO THAT.

THIS HAPPENED LATE AT NIGHT, AND MAY OR MAY NOT HAVE BEEN OF YOUR DOING. EITHER WAY, THE NEXT DAY, I DID POST A RESPONSE TO THAT, AND LEFT IT UP FOR ONE HOUR BEFORE REMOVING IT. I IMAGINE IT'S ON RECORD SOMEWHERE. (THAT.)

AS AUTHORITIES DEMONSTRATED IN CALIFORNIA BEFORE I LEFT THERE, I CAN BE ABUSED, MALIGNED, SET UP - MADE TO REACT BADLY - ALL OF THOSE THINGS. IN SPITE OF THEM, I WILL NOT BE INTIMIDATED.

I'D ALSO LIKE YOU TO KNOW I DIDN'T MISS WHAT I SAW IN SAVANNAH, AROUND THE TIME OF YOUR LUNCHEON IN MCCORMICK, AND I REALIZE, MAYBE YOU HAVE FOUND SOME VALUE IN WHAT I'VE SAID, AND MAYBE, YOU MAY HAVE EVEN WANTED TO HELP ME SOMEHOW - (WHICH I MAY HAVE CHANGED FOR THE WORSE, BY BEING SO OUTSPOKEN - I DK.)

I COULD ONLY SEE SAVANNAH THOUGH, AS I'VE SEEN EVERY OTHER AUTHORITY ALMOST CONSTANTLY, WHICH IS, ALWAYS CIRCLING, AND NEVER JUST WALKING UP TO ME AND SAYING, "OKAY LET'S TALK ABOUT THIS." (UNLESS IT'S SOME STATE, LIKE CALIFORNIA, OR COLORADO) IT'S ALWAYS THIS KIND-OF (MIS)MANAGEMENT FROM A DISTANCE, WITH NO ONE EVER JUST DEALING WITH ME IN A KIND, DIRECT WAY.

WHATEVER APPERENCES (OF ME) MAY BE, OR WHATEVER ANY OF OUR LAW ENFORCEMENT AGENCIES THINK THEY KNOW, OR SAY, OF ME, I KNOW MYSELF. BY NOW, I KNOW WHAT I'VE BEEN THROUGH AT EVERY STEP OF MY LIFE - WHAT HAS SHAPED ME, WHAT MY ISSUES REALLY ARE (WHICH ISN'T NEARLY AS BAD AS WHAT THEY'VE BEEN MADE TO BE BY PEOPLE LIKE PAUL KIGER) EVEN WITH THAT,

I STILL HAVE HAD TO LIVE WITH/THROUGH THE CONSEQUENCES OF THAT BIT IN PARENTHESES, EVEN THOUGH I DIDN'T CAUSE IT; THE DAMAGE I WAS CAUSED TO DO TO MYSELF, MY RELATIONSHIPS, ALL OF THAT, IS IRREVERSIBLE, AS, WHEN I'M NOT SUBJECT TO SUCH DRUGGING/POISONING, I REVERT BACK TO WHO AND HOW I REALLY AM - A REALLY SWEET, PRETTY BRIGHT GUY THAT DOESN'T DO STUPID THINGS TO GET IN TROUBLE, WHO'S REALLY NICE.

NOT WITHOUT A LITTLE BRAIN DAMAGE, AND INCREASED SENSITIVITY TO THINGS, BUT I'M STILL PRETTY MUCH THE SAME GUY THAT ALL THE GIRLFRIENDS I'VE LOST BECAUSE OF THIS REALLY LIKED, FOR ALL THE RIGHT REASONS.

WHAT I HAD GOING FOR ME EARLY ON, IS THAT I WAS A GREAT KID, A GREAT GUY - BUT I ALSO HAD THE ABILITY TO CONNECT WITH PEOPLE; BASED ON THAT, THAT ALLOWED ME AN UPWARD SOCIAL MOBILITY - AND ONCE DRUGGED IN THE MIDDLE OF THIS, THOSE QUALITIES - I RECOGNIZE - DID BECOME MORE OF A SOCIOPATHY DURING THAT INFLUENCE - AND I MAINTAIN, THIS IS NOT HOW I REALLY AM. (AND I AM CORRECT ABOUT THIS.) THIS IS THE TRUTH, REGARDLESS OF WHAT ANYONE SAYS OR DOES. I'M STILL LEFT HAVING TO NAVIGATE THE CONSEQUENCES, THE GOOD FRIENDS LOST, TO BEING LED TO BELIEVE I AM THAT UNSTABLE, OR MEAN, ETC.

IT LEAVES ME NO CONTEXT IN WHICH TO LIVE MY LIFE, AS THE REAL ME I'VE MANAGED TO RETAIN. EVERYONE IS ALIENATED. OPPORTUNITIES ARE GONE. TIME HAS PASSED. AND THERE IS NO GETTING ANY OF IT BACK. AND IT SEEMS, NO DOORWAY OUT OF IT.

ONE REASON THOSE CLOSE TO ME - AT VARIOUS TIMES - WERE SO HURT/HARMED, IS BECAUSE THEY TRUSTED WHO I REALLY WAS, AND THEY LOVED THAT DEEPLY, ONLY TO WATCH ME TURN INTO A MONSTER, UNDER THE PRETENSE OF NO SUCH CAUSE. AS?

HALF THE AUTHORITIES, PROFESSIONALS, ETC. STILL TRY TO EXPLOIT THIS, AND CLAIM THAT MONSTER IS REALLY WHAT I AM; SOMETHING TO BE MANAGED FROM A DISTANCE, ETC. (THEN WHEN ENOUGH TIME GOES BY TO SHOW I'M NOT THAT, I GET SET UP TO TRY AND MAKE IT LOOK THAT WAY, WHICH I'M VULNERABLE TO, BECAUSE I'M CONSTANTLY DISRUPTED AND MARGINALIZED, AND WANDERING) (BY THE SAME)

TODAY, I AM 50. THIS HAS KICKED ME 5 FEET OUT OF ME. I FEEL 65. AT THIS POINT, I KNOW THAT IF I COULD FIND THE RIGHT JOB, HOUSING, LACK OF DISRUPTION, ETC., I COULD

REBAND, AND DO WELL. (AND, MAYBE EVEN GET SOME THINGS BUILT THAT WILL NOT EXIST IF I DON'T BUILD THEM) MAYBE EVEN MEET SOME FENCE WITH PEOPLE, WHO GAIN UNDERSTANDING OF ALL OF THIS - AND I COULD COME BACK, AND BE ON TOP OF IT - AND NOT PERPETUALLY UNDER IT.

BUT THE ANSWER - FOR ME - NO LONGER LIES IN "GO OUT AND GET A JOB, NETWORK, AND BOOTSTRAP MY WAY BACK UP -"

I'VE ALREADY DONE THIS, OVER AND OVER, ONLY TO HAVE EVERY INCH OF GROUND I GAIN DISRUPTED, AS IVE ALREADY SAID.

I'M STILL IN THE SAME CIRCUMSTANCES - DRIVING AROUND, TRYING TO FIND A SAFE PLACE TO LAND, GETTING NOTHING DONE, SCRAPING FOR ALWAYS NEVER ENOUGH, CLOSE TO NO ONE, FILTHY 3 1/2 WEEKS OUT OF THE MONTH - AND THE ONLY DOORWAY INTO ANYTHING, LEADS TO THE SAME DSM-BASED PSYCH/PSYCHDRUG CRAP, AND EVERYBODY WHO THINKS THEY KNOW WHAT'S BEST FOR ME, BUT DON'T. WHICH I ARGUE, IS BY DESIGN.

WITH REGARD TO THE ORIGINS AND UPPERMOST LEVELS OF THIS MECHANISM'S HIERARCHY, THE MODEL FOR THE MECHANISM APPEARS TO HAVE BEEN THE WORK OF ^{ALLEN DULLES'} RICHARD HELMS' C.I.A., AND IT'S MK ULTRA PROGRAM. FOLLOWING AN ATTEMPT AT OVERSIGHT WITH THE CHURCH COMMITTEE, AND HELMS' ALLEGED DESTRUCTION OF

MK ULTRA EVIDENCE, IT'S APPARENT BY NOW THE WORK WAS THEN HANDED OFF TO - AND CARRIED OUT IN LARGE ORDER BY - GEORGE H.W. BUSH, DAN QUAYLE, MITCH DANIELS, AND A GREAT MANY OTHERS OF THIS ilk, OPERATING ON MANY DIFFERENT LEVELS OF GOVERNMENT, INDUSTRY AND UNIVERSITY, IN CONCERT.

ACROSS THE POLITICAL SPECTRUM SINCE WW2, VOTING RECORDS WILL REVEAL WHO SUPPORTED WHAT, AND WHICH POLITICIANS ARE A PART OF OUR MECHANISM, AND THIS WILL ALSO LIKELY REVEAL WHICH POLITICIANS ARE AGENTS, SUBVERTING THEIR POLITICAL OFFICE BY SERVING IN CONFLICT OF INTEREST, TO AGENCY ENDS, AND/OR INDUSTRIAL ENDS, WHICH I ALSO BELIEVE HAS BEEN ACTIVELY IN PLAY -

BELOW THE LEVELS OF POLITICIANS WHOSE FACES ARE PUBLIC, THE MECHANISM DISAPPEARS INTO THE AREAS BEHIND CLOSED DOORS AND SLIDING PANELS, AND BECOMES VISIBLE ONLY TO THOSE WHO PAY ATTENTION TO WHO IS A PROPONENT OF WHAT, WHO CAN ALSO CROSS-REFERENCE THAT AGAINST ACCURATE DATA. AND EVEN THEN, THE MAJORITY OF WHAT IS TAKING PLACE REMAINS UNSEEN.

FOR THE PURPOSES OF ILLUSTRATION, WHAT HAS BEEN ESTABLISHED THUS FAR IN THIS SECTION, IS THE "ZERO POINT" ON A NUMBER LINE, WHICH IS CHRONOLOGICAL, WHEREBY THE INVESTIGATION OF RICHARD HELMS' CIA BY THE CHURCH COMMITTEE IS THE "ZERO POINT."

THEREBY, WE HAVE TWO FOCUSES: THAT WHICH OCCURRED BEFORE THE ZERO POINT, AND THAT WHICH HAS OCCURRED AFTER IT, WITH GEORGE H.W. MATTERS FALLING INTO THE CATEGORY OF WHAT IS BEFORE OUR ZERO POINT ARE MURKY AT BEST, AND CLASSIFIED, BUT TO SUMMARIZE WHAT I HAVE BEEN ABLE TO PIECE TOGETHER, IT APPEARS TO BEGIN WITH OTTO LOEWI'S DISCOVERY OF CHEMICAL NEUROTRANSMITTERS, AND HOW THEY FUNCTION, IN EARNEST SCIENTIFIC EFFORT TO UNDERSTAND THE HUMAN BRAIN, PER HISTORICAL RECORD, THIS FELL UNDER THE RISE OF NAZISM IN GERMANY, AND IN EXCHANGE FOR LOEWI'S PASSAGE TO THE U.S., HE WAS MADE TO SURRENDER HIS RESEARCH TO THE S.S., WHO THEN CONTINUED TO DEVELOP THE WORK DURING - AND AFTER - WW2, IN CONJUNCTION WITH INTELLIGENCE INITIATIVES TO WEAPONIZE THE SCIENCE, VIA CHEMICAL MANIPULATION OF WHAT LOEWI DISCOVERED: THE NEUROSYNAPTIC SYSTEM. (WHICH COULD ALSO BE A LESSON ON HOW TO PLANT A NAZI SPY, VIA UTILIZATION OF THE JEW) (MAYBE) THANKFULLY, [THIS] WAS NEVER CARRIED TO FRUITION BY THE NAZIS DURING WW2, BUT AT THIS POINT, IT'S SAFE TO ASSUME THIS KIND OF DEVELOPMENT TOOK PLACE, IN CONJUNCTION WITH GERMAN PHARMA, IN SECRET, BY THE NAZIS. AND WITH THE END OF THE WAR, THIS BECAME WHAT MUST HAVE BEEN "THE CROWN JEWEL" OF BARGAINING CHIPS FOR NAZI INTELLIGENCE, WHICH THEY USED TO FULL ADVANTAGE.

I HAVE NO DOUBTS U.S. INTELLIGENCE BECAME INTIMATELY AWARE OF LOEWI'S WORK AFTER HIS ARRIVAL IN NEW YORK; IF ELEMENTS OF U.S. INTELLIGENCE WERE COMPROMISED IN THE MANNER MUCH SPECULATED OF DULLES, SULLIVAN, CROMWELL AND OTHERS, THERE MAY VERY WELL HAVE BEEN RECIPROCATING INFRASTRUCTURE LAIN ON THIS SIDE OF THE ATLANTIC - AND I BELIEVE THERE WAS. THIS IS SPECULATIVE, AND REMAINS TO BE UNDERSTOOD, BUT WHAT IS CLEAR, IS THAT U.S. INTELLIGENCE OBTAINED THIS TECHNOLOGY FROM THE NAZIS, DEVELOPED IT FURTHER TO WEAPONIZED ENDS, AND THEN, AND SINCE THEN, HAVE IMPLEMENTED IT UPON THE U.S. GEN-POP.

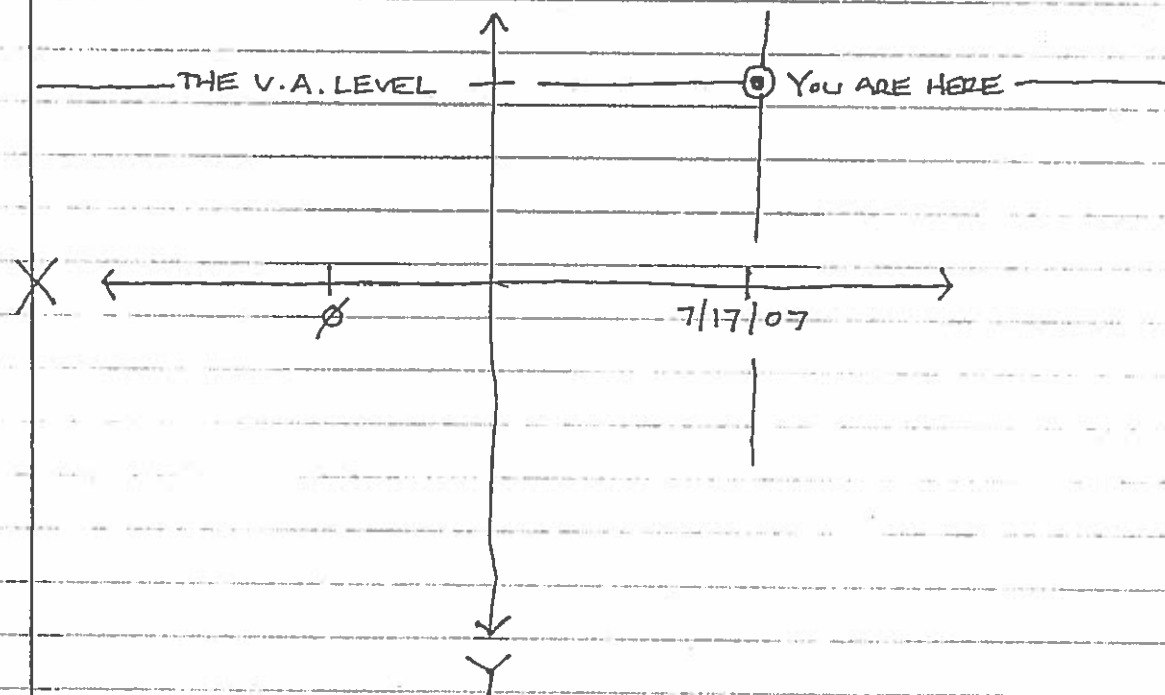

1. Causes of Action

My own research began with a single, simple question about Paxil and FDA, which was, "How could there possibly be a drug on the market affecting so many people so badly?"

To try and answer this question, I decided to research Paxil and other "Serotonin Reuptake Inhibitor" drugs at a medical library, and right out of the gate, I found a profound contradiction: I was able to compile a weighty stack of reports from medical journals, written by doctors, with titles such as "Paroxetine Induced Psychotic Mania" and, "Severe Psychiatric Symptoms Associated with Paroxetine Withdrawal", all bearing dates of 1995 and earlier, yet in 2000, we were all being target-marketed by advertisements in every form, stating the drugs were safe, and had no ill-effects from discontinuation. Which led immediately to the question, "How could this possibly be?"

Given my own experiences reflected the findings reported in the buried medical journal articles, while the marketing continued to assail, this was not the kind of question I was willing to leave unanswered, and to compound matters, I found many other such discrepancies and indications of very organized mass deception, not only by the industry, but also on the parts of government agencies responsible for both regulating industry and enforcing law.

The magnitude and implications of these findings remain overwhelming on many fronts, and due to the types and degrees of industry cooperation on the part of regulatory agencies and other organizations, it became clear that to investigate this class of drugs also meant to investigate the possibility an unprecedented pharmaceutical terrorism – if not a well-conceived and subtle form of planned systematic genocide - may have been, and continue to be, taking place upon the United States, it's allies around the world.

The purpose of this report is to outline the reasons for my conclusions regarding this possibility as affirmative.

In order to comprehend the means by which these efforts have been occurring since WWII, it is essential to understand the compromise of our healthcare systems as part of a far more serious and covertly concerted effort against the United States and it's allies over time. In order for these efforts to take place by the means and on the scale they have, key elements had to have been put in place over time. Many recently released documents confirm these elements have been put in place; it is only by way of these elements working in conjunction over time they have been successful, and in part, it is by way of these successes becoming so overt attention has assembled enough of it's components to reveal the nature of what I understate as this complex and disturbing problem set.

To understand this lucidly, one is required to utilize an ability to think outside long-established contexts and concepts, with specific knowledge of government, intelligence, history, industry, medicine and law, and to recognize key elements of current and past national and international events with a shrewd and logical regard to the same.

2. Historical Misinformation Stands Corrected

The long established, accepted and instructed perception of the end of WWII by Americans in general with regard to Nazi Germany is essentially, "we won" – that,

"The Allies mopped up all but a few errant troublemakers at Nuremberg, and the world was safe again from the terrible scourge of Nazi ideals ethics and practices."

As revealed in the 2004 Cambridge University Press' release, U.S. Intelligence and the Nazis, authored by four members of the Interagency Working Group assigned to obtain and interpret millions of documents pertaining to U.S. utilization of Nazis after WWII (declassified since just 1998 and later), nothing about the perception of the end of WWII I've described could be farther from the truth, more misleading, or more damaging over the years since 1945.

The IWG book is primarily a collection of facts, as it's authors state, to be used as a tool by other researchers. Presented, are good questions pertaining to the non-release of documents still withheld by CIA, and still other questions regarding the motives of many high and lower-level U.S. officials. Understandably, the IWG authors show a great deal of care and restraint in not drawing conclusions which can be easily reached, while it is apparent still others elude them. What is soberingly clear is, the war against the Nazis did not end with WWII; it simply changed, immediately, into the next phase which the Nazis had planned very well for. As the IWG book illustrates – but fails either to fully grasp or fully reveal, once WWII ended in military victory and corresponding military defeat, the war continued, as a busy, behind-the-scenes intelligence game of, "if you can't beat 'em, join 'em – then beat 'em."

One key element illustrated by the IWG book, and by the troves of documents kept classified for so long is, the Nazis had enough of a high level foothold to pull this off. What is glaringly obvious today is, they have used this foothold since WWII to make tremendous, sweeping advances, and by way of this, continue to do so virtually unhindered.

To understand this, one is required to update their definition of the term, "Nazi". By comparison, and in part by Nazism's increasing influence upon the organization, The Ku Klux Klan (which has increasing ties to Nazism and to U.S. Intelligence) have become less about wearing it's ceremonial attire and debasing themselves, and more about operating covertly, blending into the general populace, and infiltrating – banks, business and medical organizations, legal circles, political offices, and even the U.S. Military and other government organizations.

By the same comparison in reverse, Nazis referred to here are no longer the uniformed tormenters of the 1930's and 40's. Like many other groups, they have an upper and lower class - the latter of which is visible any given night, on MSNBC's "Lockup" series. The Nazi upper class, surviving or descendant of WWII, is not so blatant. Since WWII, they have become increasingly engrained in American life, as Americans or citizens of other countries, either by way of having ancestry here, or by being installed covertly, working for corporations and governments around the world. Nazi ideology is basically the same as it ever was – now, however, Nazism is no longer specific to any one nationality, and operates freely and secretly through the world.

Just as one can no longer reliably identify a Nazi by his or her attire, the only sure-fire ways one can identify the modern Nazi, are by identifying actions based upon the Nazi ideology, behavior or known Nazi mission statements – be they actions taken by individuals or by groups – even if (and especially if) any of these groups happen to be part of the U.S. Government.

Increasingly since WWII, actions based in identifiably Nazi ideology and behavior have taken place behind the closed doors of globally-based corporations and universities, working in conjunction - and conflict of interest - with U.S. and other Government Agencies having abilities to classify in secret, and control the actions - and the creation - of other U.S. Government Agencies – and U.S. Policy.

A conclusion not overlooked by IWG is, they – and the American populace - have enough information in front of them to warrant demanding the release of any and all files pertaining to US utilization of Nazis after WWII; IWG began with these grounds, but when IWG member and Congresswoman Patricia Schroeder requested the remaining files, she met with non-compliance, and has stated a high-ranking CIA official advised her, "There are things CIA doesn't want the public to know."

To this day the files have not all been released, but in what is available, there is more than enough evidence to suggest the reasons the files remain classified, are because – by now -releasing them would unearth an exponentially growing number of strings of damning information, running through an array of present issues and Post WWII past events, implicating thousands of, "respectable Americans" and forcing full disclosure and public audit of all CIA activity, due to it's clandestine abuse and corruption of other government bodies and agencies, and industries and universities here and abroad. As the IWG book illustrates clearly, all of these things have been influenced and compromised by extensive, covert employment and placement of high and low-level Nazi intelligence strategists, operatives, scientists, policy makers and genocide planners.

Given the fact persons such as Otto Von Bolschwing and Walter Rauff were given asylum, employed and placed in U.S. based pharmaceutical companies like Parke-Davis and Warner-Lambert (now both part of Pfizer) by CIA;

Given CIA based it's egregiously unethical LSD research on faulty intelligence fabricated for both the U.S. and U.S.S.R. by Reinhard Gehlen and his network (thereby playing both into The Cold War) – who in addition to many others was given asylum in the U.S. and employed by CIA with virtually no oversight;

Given Dr. Robert Felix – one of whom was funded by CIA to conduct part of this LSD research upon Black Americans, was also responsible for lobbying Congress in the early 1960's to pour millions into the creation of NIMH, countless community mental health clinics, and the alteration of university curriculums, to adopt teaching texts such as the DSM;

It is evident these things have lain the groundwork for a system design which subverts, mis-educates and replicates itself. The aim of intelligence is to advance upon (or defeat) an enemy by way of what they do not – or what they think they do – know. Many in healthcare - and in

intelligence – enter their respective fields with no other intention than to help people be healthy, or help protect their country. When what is trusted and taught is sound, the results are positive.

When they are not, proportionately, it is reflected in the results. Given what is outlined in this document, current mental health, drug safety and research ethics lapses we've seen and have been seeing over time are no surprise to those with a grasp of these issues.

Ironically – and to me quite unexpectedly - the same threads running through serious early intelligence compromises continue, as a culture, running straight through the pharmaceutical and university research industries and drug safety issues encircling FDA. They zigzag through both sides of The Cold War, The Korean and Vietnam conflicts, the perpetuated strife in the Middle East – all the way up through explosive seen and unseen events surrounding September 11, 2001. Visible throughout all of these things, are many of the same players operating out of high-end corporate structures doing business spanning decades with the U.S. Government, continually exiting and re-entering government.

3. Contra-Indications, Deception and Harm

At the time I began this research in 2000, I knew very little about neuroscience, but I knew I would have to familiarize myself with as much of it's terms and physiology as possible if I was going to understand any answers I might find, and convey them to regulators.

For example, I found many medical journal articles on the subject of SSRI induced, "anisocoria" but had no idea what it meant; it wasn't until I learned anisocoria is the condition of having one pupil become markedly larger than the other, I was able to attach a name to a side effect I had experienced myself. Shortly after this, I realized this recently-coined term is jargon, designed specifically to confuse, and avoid the question of the SSRI-induced brain imbalance indicated by the condition; anisocoria is merely the indication of a deeper imbalance within the brain. I've seen no such literature addressing SSRI-induced anisocoria as such, and to the best of my knowledge, the condition is neither understood or resolved – it is simply labeled with a name addressing it's indication – and approved – as if it is something you or I might not notice, mind having, or need to understand. By sharp contrast, it is common practice in emergency rooms for staff to check victims of severe head trauma for uneven pupil diameter, as this is an indication of deep brain trauma.

After this, I began searching for a simplified, comprehensive answer which might explain the discrepancies revealed by these initial findings, and reveal the means by which the SSRI drug can wreak such a wide range of havoc within the human physiology. At the time, I wasn't even sure if there was such an answer, but given the degree of contrast between the facts in the buried data, and the fantasy in advertisement, I felt such an answer must exist – and this became the test - if I could find such an answer within the physiology or pharmacology, I could not only expose the fraud and deception, I could debunk the false science behind it.

After months of often frantic trudging through a maze of medical reports and terminology that only seemed to become larger and more incomprehensible, I found my answer – and in this answer, stumbled upon the most egregious, damaging and criminally deceptive mass-marketing ever thrust upon the U.S. and the globe in it's entire history:

Corporate and Federally-sponsored research, "found depressed and otherwise disordered persons maintain lower, "imbalanced" levels of the neurotransmitter, serotonin." Their solution to this has been the Serotonin Reuptake Inhibitor drug, "which blocks the reuptake of serotonin – it keeps the serotonin from exiting the synapses, causing it to build, resulting in a restoration of efficient electrochemical transmission within the brain, and thus, an alleviation of depressive symptoms."

The Merriam-Webster Online Dictionary exposes the deception, and the degree to which scientific basics have been compromised and overlooked:

Serotonin is,

"a phenolic amine neurotransmitter that is a powerful vasoconstrictor, and is found especially in the brain, blood serum and gastric mucosa of mammals."

Nowhere, in the sheaves of medical literature I'd sifted, had I seen serotonin defined as anything other than, "a neurotransmitter" and since, I have found only three other such references to serotonin as, "a powerful vasoconstrictor".

One such reference is historical – and was in the process of being removed from the shelves of a library as I found it – on an outbound cart; this reference illustrated the use of serotonin's vasoconstrictive properties shortly after it was discovered in the early 1940's, by listing accounts of local injection to the vagina, in order to curtail pregnancy-related bleeding.

As the human brain is an organ which thrives upon oxygen carried by it's vasculature, serotonin is most emphatically not a chemical any human needs to cause their brain to stockpile, by way of taking a product designed to cause this action.

By contrast, that serotonin is, "a powerful vasoconstrictor" is likely instructive of the brain's natural ability to fight it's own depressions: if depressed persons were found to have lower serotonin levels, it is far more likely this illustrates the brain's efforts to *increase* it's oxygen levels, by way of *decreasing* it's vasoconstrictor levels.

That these findings of lower serotonin can only be accurately measured (and in such studies, were made) after death indicates no way to make the measurement indicating, "imbalance" upon the living brain in any diagnostic way.

While FDA did finally curtail this type of serotonin-based marketing partially, they have failed to acknowledge the types of damage and probable damage serotonin as vasoconstrictor can bring upon human physical and mental well-being.

One exceedingly plausible and increasingly popular theory states: "Elevated serotonin (as vasoconstrictor) can deprive the brain's conscience mechanisms of the oxygen levels they require to function properly, while increasing electrochemical activity to these improperly functioning brain mechanisms."

The degree of violence and health problems proven to be associated with SSRI drug usage have long been more than enough to warrant full market removal. If those at FDA wish to hold a belief, "more research needs to be done", it is very strongly suggested they (and those of other agencies having influence upon FDA) be made to take a look at the information they've had and avoided addressing for two decades or more, and make altogether certain this and other similarly unethical research does not continue to be carried out upon the general population of the United States.

Instead of this, however, we have been given the Black Box Warning, in a woefully lacking, partial acknowledgement SSRI drugs can cause suicide and violent behavior in children and young adults - up to age 18 – as if there were a biological mechanism they had identified, keeping the mal-effects of SSRI's from occurring once the patient/consumer reached age 18.

There is no such biological mechanism. SSRI induced suicidality and violent behavior can occur in people of any age taking the drugs. Science has no way of telling who will and who will not be affected in these ways. This is supported by the entire chronology of medical journal articles on SSRI-related violence and suicide, and yet another citable reason for market removal.

Also absent from the Black Box Warning was any information on the kinds of severe birth defects resulting in SSRI usage by pregnant women, which have only begun to surface recently. Because of, "fast-tracking" the drug approval process (which is confronted in the pages ahead), no pre-approval, long-term studies were done. Instead, what passes for long-term studies was, and continues to be, carried out upon the general population after market approval.

This applies to all types of drugs, from Vioxx and related, post-approval heart problems - by what have been estimated to be 35,000 people, to Oxycontin's being found - after market approval - to be lethal when mixed with alcohol. The lives lost to bringing this type of information to light were those of American citizens, whose only mistakes were trusting the drug safety system we now have in place.

To add insult to injury, the Black Box Warning - which was touted as, "FDA's strongest warning" - had never been used on any drug literature before it's recent application to SSRI drug warnings; it had only been used on cigarette packaging. While we can expect such warnings to be expanded in content and application, it is certain that if actual drug safety regulators had considered such warnings during the drug approval processes and acted appropriately, and if those that did consider those warnings were not prevented from acting appropriately, an incomprehensible amount of suffering by a great many could have been – and could be – avoided.

Many have remarked, it almost seems as if the same people developing and marketing these types of drugs are "in bed" with the same people approving them without real regulation at FDA, while still others of the same ilk blanket-replace consideration of safety issues with programmed issues of drug price, in a distraction scheme to both, gouge the consumer, and weaken safety regulation systems further. What I have found is, this is exactly what's been happening – and has been since WWII.

The answers to how and by whom would not fully begin to surface until the publication of the IWG book, U.S. Intelligence and the Nazis. While the book does not address this problem set directly, it provides answers which, in tandem with other key information available, provide clear evidence the U.S. is - and has been - under attack, within the framework of new evolutionary steps in intelligence-based warfare altogether, fully utilizing the concept of marketed pharmaceuticals, as weapons, in an unprecedented reinvention of the scale and concept of, "the inside job".

Central to this effort has been the CIA's abilities to place it's, "assets" in positions within other government agencies, businesses and universities - which, in spite of findings by such things as The Church Committee Hearings - has gone on unchecked since this agency's beginnings after WWII. As we but glimpse by way of the IWG book, the creation of the CIA itself may very well have been the next phase of the postwar Nazi plan.

I knew that before I would ever be able to make such an assertion - and certainly, to ever be taken seriously by anyone, I would have to find credible documentation of CIA gaining (by way of subversion of law) and exercising such authority upon other government agencies.

Col. Fletcher Prouty served in presidential administration. Like it or not, he didn't like what he saw happening, and before he died, wrote about it in complex detail. Below is the excerpt from his book, The Secret Team, outlining the means by which FDA, businesses, universities and other government agencies have been compromised:

"This is another part of the special expertise of the ST. The CIA would use secrecy and need-to-know control to arrange with a Cabinet-level officer for the cover assignment of an Agency (CIA) employee to that organization, for example, the Federal Aviation Administration. The Cabinet officer would agree without too much concern, and quietly tip off his manpower officer to arrange a slot (personnel space) for someone who would be coming into a certain office. He would simply say, "the slot would be reimbursed", and this would permit the FAA to carry a one-man overage in it's manning tables. Soon the man would arrive to work in that position. As far as his associates would know, he would be on some special project, and in a short time he would have worked so well into the staff, they would not know he wasn't really one of them. Turnover being what it is in bureaucratic Washington, it would not be long before everyone around that position would have forgotten it was a special slot. It would be a normal FAA position with a CIA man in it.

Then CIA would beef up the power of that position until the man was in a position that could be used for membership on various committees, boards, and so on. In the case of FAA the actual slotted men are in places where they can assist CIA with many requirements in the field of aviation, both transport and aircraft maintenance, and supply companies.

This same procedure works for slots in Departments of State, Defense, and even in the White House. By patient and determined exploitation and maneuvering of these positions, CIA is able to get key men in places where they are ready for a time when CIA wishes to pull strings. This is intricate and long-range work; there are many variations in which this can be done, and CIA is adept at the use of these tactics. It is done skillfully, and under the veil of heavy secrecy. Many key CIA career men have served in such slots as agents operating within the U.S. Government, and there is no doubt security measures utilized to cover these agents within our own government have been heavier than those used between the U.S. and other countries."

The IWG book outlines many whom have been given this type of authority and placed in these types of positions in the time since WWII.

In 2004, I visited CIA's website, and found there were a variety of positions open for psychologists and psychiatrists within CIA – contrary to it's often-referenced mission statement – "in order to implement CIA's medical policies worldwide" (which they have since reworded to read, "Join us on the world stage.")

It is evident CIA has been engaged in this implementation without regard for The Constitution, American or World Citizens, or Truth - in Science, Medicine, Education or Advertisement.

5. The Plot Sickens

During the Church Committee Hearings, Ted Kennedy is quoted as saying (of the MK Ultra projects), "The Deputy Director of the CIA revealed that over thirty universities and institutions were involved in an "extensive testing and experimentation" program which included covert drug tests on unwitting citizens "at all social levels, high and low, native Americans and foreign." Other sources have stated the number of universities and institutions used in these programs at 80 – at a taxpayer cost of (then) over 35 million dollars. CIA head Richard Helms is said to have had all the files on MK Ultra destroyed, but whether this obstruction of justice (via destruction of evidence) actually took place or not, Helms' associate and successor, George H.W. Bush understood this model for exploiting the educational system, and applied it on an exponentially larger scale with regard to the antidepressant drugs pioneered by his own company, Eli Lilly (which was already on the CIA payroll as the company previously contracted to manufacture LSD at the behest of Reinhard Gehlen).

Per it's own statements quoted above from it's website, CIA has been blatantly engaged in this activity of Corporate, Healthcare and Educational system espionage and subversion with no real oversight since it's creation after WWII. And all the while, therein, are Nazis no one ever dreamed could ever be working behind the scenes in our own government. But there (some of) it is, in black and white – as the rest – an unknown amount - remains classified.

This is egregious and unacceptable.

Work occurring under both Bush administrations are obvious continuations of the groundwork in psychiatry and mind altering drugs laid by The Gehlen Network, Robert Felix, and others, as mentioned previously in this document.

Of Nixon's associations with Parke-Davis while Von Bolschwing was employed there and living in California, it is public knowledge. But had it become public knowledge while Nixon was in office, Watergate would have paled in comparison to the resulting scandals – and was likely the tip of the iceberg as it is. This isn't merely an opinion – it's a logical conclusion based upon factual history. And there's a lot more where that came from:

It is public knowledge G.H.W. Bush was head of CIA, and that he sat on the board of Eli Lilly, along with his Vice President, Danforth Quayle.

It is public knowledge many other figures, such as Mitch Daniels and Daniel Troy have also served in conflict of interest on presidential administrations and on pharmaceutical company administrations.

It is public knowledge this is a type of business-model applying to other types of corporate businesses (such as Halliburton and Blackwater) also conducting business in conflict of interest with The U.S. Government.

It is public knowledge Danforth Quayle and George H.W. Bush are responsible for much of the drug safety regulation being dropped in the 80's, and initiation of the, "fast-track" drug approval process (complete with conflict of interest waivers at FDA) being implemented, by way of, "The White House Council on Competitiveness", working under the guise of finding a cure for AIDS, via increasing competition for a cure due to high public demand. But there was no clause in the dropped regulations limiting the fast track process to AIDS-related drugs – and if there was, it was not adhered to. As a result, this type of approval process became the accepted standard we have today for all drugs – either due to an absence of actual drug regulators and regulation, or via the strong-arming of the FDA by an influencing agency or agencies under the clandestine direction of multiple Presidents, acting in direct, multiple conflicts of interest.

This usage of the AIDS epidemic and it's resultant blowback, in tandem with other unanswered questions and still other information available, continues to raise doubts and valid questions about the origins of the AIDS virus, and what could very well have been it's purposes.

Today, in spite of the dangers of Paxil and other SSRI and SNRI drugs increasingly becoming widely understood – albeit still not acknowledged by those entrusted with regulatory authority – the drugs continue to be administered to The American General Population, as the well-documented violence associated continues daily, in one part of the country or another.

Equally treasonous, U.S. Troops continue to be administered Paxil as an FDA -approved treatment for PTSD, for which there remains no comprehensive, fully biologically understood, drug-treatable origins. Government media-drivers and censors continue to dictate misleading stories for mainstream mass media publication of every kind, in blatant, identifiable attempts to deceive the public about causes of the highest U.S. Military Suicide Statistics in history, which are undeniably and directly related to this SSRI usage.

TO THE EDITOR: It is well known that manic episodes can occur in patients who receive antidepressant medication because either the medication provokes the manic episode or the patient has an unrevealed bipolar illness [1,2]. However, there have been few published reports of mania induced by the selective serotonin reuptake inhibitor paroxetine. I wish to report the occurrence of an initial manic episode with psychotic features in a patient whose obsessive-compulsive disorder was being treated with a high dose of paroxetine. A MEDLINE computer search revealed no similar reports in the literature.

Mr. A, a 32-year-old unmarried man with a long history of obsessive-compulsive disorder and dysthymia, was admitted to a public emergency crisis unit for treatment of an initial episode of psychotic mania. At the time of admission, he displayed a euphoric mood, hyperactivity, flight of ideas, and distractibility. In addition, he believed he was Jesus Christ and had been sent by God to heal the other patients at the crisis unit.

According to his parents, Mr. A had been taking paroxetine, 60 mg/day, over the course of 6 weeks for treatment of his obsessive-compulsive disorder. Approximately 5 days before his admission, Mr. A had developed insomnia and irritability but continued to take paroxetine. These symptoms worsened, and, on the night of his admission, Mr. A had threatened his parents with physical harm after they challenged his grandiose delusions.

On admission Mr. A's urine toxicology screen revealed no abnormality, and his blood alcohol level was 0.0. Serum chemistry results were within normal limits. He had no history of medical problems, and no psychosocial stressors were identified for the period before the onset of mania. His psychiatric history was significant for a long-standing obsessive-compulsive disorder and dysthymia. However, he had never experienced a manic episode even though he had been treated for many years with high doses of clomipramine (400 mg/day for over 4 years) and fluoxetine (80 mg/day for 3 years, but this medication had been discontinued for several months before the initiation of paroxetine).

At the time of admission, the paroxetine therapy was stopped. For several days Mr. A's treatment regimen consisted of a low dose of haloperidol and a routine dose of lorazepam. His sleep cycle normalized, and after 6 days Mr. A's manic symptoms and psychotic delusions resolved. He was discharged to outpatient follow-up 10 days after admission and was no longer on any medication regimen.

Paroxetine, a phenylpiperidine derivative, is considered to be the most selective and potent of the current selective serotonin reuptake inhibitors (such as fluoxetine, sertraline, and fluvoxamine) [3]. It has been found to be superior to placebo and equivalent to amitriptyline, imipramine, clomipramine, and doxepin in the treatment of depression [4]. Although paroxetine has not yet been approved by the Food and Drug Administration for use in obsessive-compulsive disorder, multicenter clinical trials are currently underway [5]. Nonetheless, recent case reports suggest that paroxetine, used in doses higher than those routinely prescribed for unipolar depression, may be efficacious in the treatment of obsessive-compulsive disorder [6].

It is interesting in that an initial episode of psychotic mania occurred after paroxetine treatment in a patient who previously received chronically high doses of clomipramine, a tricyclic antidepressant with serotonergic

Sir - To date, selective serotonin reuptake inhibitor (SSRI) withdrawal syndrome has been described predominantly in terms of physical symptoms. [1] We have observed two cases of transient behavioural syndromes with severe aggressive and suicidal impulsivity subsequent to paroxetine withdrawal.

Two healthy white men, aged 36 and 43 years, participated in a controlled double-blind clinical trial of paroxetine treatment for stuttering. Both had a history of brief episodes of minor depression. After completing a 3-week treatment period with 50 mg paroxetine, both men went into a placebo phase. In the first case, 2 days after abrupt drug discontinuation, the subject reported hypomanic-like symptoms, including hyperactivity, decreased need for sleep, and irritability that developed into agitation, aggressiveness, and volatility. After 2 weeks of fluctuating symptoms, he experienced ego-dystonic impulsive behaviour such as shoplifting and suicidal impulses and gestures. All symptoms abated spontaneously after 2 1/2 weeks. In the second case, paroxetine was tapered over a 12-day period. The first week of withdrawal was notable for an uncharacteristic feeling of confidence and optimism, talkativeness, and a subjective feeling of sharpened and quickened thought processes. During the 2nd week, the patient developed physical symptoms of dizziness, blurred vision, nausea, lethargy, and insomnia. He also reported feeling angry, irritable, and short-tempered, with some highly atypical explosive vocal outbursts and tantrums. He became preoccupied with homicidal thoughts and plans, initially directed towards acquaintances and later towards his own children. These became so intense and ego-dystonic that he contemplated suicide. Physical and behavioural symptoms lasted about 9 days and then remitted spontaneously over 2-3 days.

In these two instances, men without a history of major psychiatric disorder developed severe behavioural symptoms when paroxetine was withdrawn. The first few days were characterised by predominantly hypomanic features followed by a period of escalated ego-dystonic aggression, behavioural dyscontrol, and suicidal intention. This biphasic symptom pattern is reminiscent of the case of fluvoxamine-precipitated withdrawal hypomania described by Szabadi. [2]

We believe that the serious behavioural symptoms seen in these cases were adverse effects of paroxetine withdrawal. The reaction was possibly triggered by an insufficiently gradual tapering of the drug and may reflect low central serotonin concentrations in "down-regulated" serotonergic systems. Such a deficiency has been implicated in impulsive and aggressive behaviours. [3] One cannot rule out, though, a delayed hypomanic response to paroxetine. Another possibility is that people who stutter may be unusually vulnerable to SSRI withdrawal because of a neurological abnormality. With the growing number of indications for SSRI treatment, clinicians should be aware of a possible serious withdrawal syndrome with prominent psychiatric symptoms consequent to paroxetine discontinuation.

AND, WERE ALLOWING A DRUG AS DANGEROUS AS PAXIL (AND MANY OTHERS) TO FLOOD THE U.S. MARKET - INCLUDING THE MILITARY - WITHOUT REGULATION, AND ALLOWING THEM TO REMAIN ON THE MARKET, IN SPITE OF THE DAMAGE THEY WERE - AND STILL ARE - DOING.

UPON INVESTIGATING THIS, I RECOGNIZE THIS AS A BROADLY ORCHESTRATED ACT OF WAR AGAINST THE U.S. POPULACE, AND OUR MILITARY, AS STATED IN THE ENCLOSED PAPER. OUR HEALTHCARE SYSTEMS HAVE BEEN SUBVERTED TO THIS END.

I ALSO RECOGNIZE AN ACUTE SUBVERSION OF THE U.S. CONSTITUTION'S 2ND AMENDMENT, IN THE FOLLOWING MANNER:

THE 2ND AMENDMENT OF THE U.S. CONSTITUTION (AS WE ALL KNOW) ESTABLISHES THE RIGHT OF AMERICANS TO BEAR ARMS; THE FDA IS CURRENTLY ALLOWING DRUGS TO REMAIN ON THE U.S. MARKET WHICH INHIBIT AMERICANS' BEARING OF THOSE ARMS RESPONSIBLY; THIS IS A VERY DANGEROUS SUBVERSION OF THE 2ND AMENDMENT, AS WE HAVE SEEN, SOMETIMES DAILY (- AND SOMETIMES, FOR WEEKS AT A TIME) THROUGHOUT THE LATE 1990'S AND 2000'S, TO THE PRESENT.

IN 2006, FDA HELD ADVISORY HEARINGS, AND CONCLUDED THEIR "BLACK BOX WARNING" TO BE THE APPROPRIATE COUNTERMEASURE, ADDING, "MORE RESEARCH NEEDS TO BE DONE." WITH REGARD TO SEROTONIN REUPTAKE INHIBITOR DRUGS.

THIS IS EGREGIOUSLY UNACCEPTABLE, AND AN INSULT TO ANYONE WITH EVEN THE MOST BASIC UNDERSTANDING OF AMERICAN CIVICS AND THE CONSTITUTION.

SADLY, IT APPEARS THE PERCENTAGE OF AMERICANS WITH THOSE UNDERSTANDINGS IS FEEBLE AT BEST, AND THOSE THAT DO HAVE THEM ARE POWERLESS TO AFFECT CHANGE WITHIN PROCESSES THAT OCCUR OUT OF THEIR REACH, BEHIND CLOSED DOORS, AND OUT OF THEIR SIGHT. THEY (WE) ARE SIMPLY EXPECTED TO ACCEPT WHAT BECOMES ESTABLISHED AS "AMERICAN," EVEN WHEN IT IS ANYTHING BUT.

I RECOGNIZED THE ISSUES SURROUNDING MENTAL HEALTH ORIENTED PHARMACEUTICALS AS HAVING CHARACTERISTICS OF NAZISM, BUT IN NEW, "AMERICAN" WAYS, AND AS THE ENCLOSED PAPER ILLUSTRATES, THERE IS PLENTY OF INFORMATION SUPPORTING THIS, AND HOW SUCH THINGS CAME TO BE, WHILE THERE REMAINED ENOUGH INFORMATION MISSING TO STALL ANY ACTION THAT MIGHT BE TAKEN, AND ALLOW THOSE USING THESE MEANS TO CONTINUE USING THEM, FROM BEHIND THE SAFETY OF CLASSIFICATION, THE CLOSED DOORS OF CORPORATE BOARDROOMS AND DOCTOR'S OFFICES AROUND THE WORLD, MUCH TO OUR PERIL.

SINCE THE COMPLETION OF THIS PAPER IN 2005 (AND ITS EMPHATIC REVISION IN 2008), MUCH INFORMATION HAS SURFACED, AND/OR BEEN FOUND TO FIT, IN THE SAME MANNER IN WHICH A PUZZLE-PIECE IS PROPRIETARY, AND ONLY FITS IN THE SPACE IN WHICH IT BELONGS.

IN FINDING MY OWN ANSWERS, I'VE FOUND MANY PIECES OF INFORMATION WHICH COULD SERVE TO ANSWER ANY GIVEN QUESTION, BE IT BIOLOGICAL OR POLITICAL, OR OTHERWISE - BUT IF THE POSSIBLE ANSWER DOES NOT SEAMLESSLY FIT, I CONTINUE TO SEARCH FOR AN ANSWER WHICH DOES, AND MORE OFTEN THAN NOT, I FIND THE CORRECT ANSWER. EVEN IF THIS TAKES YEARS. IT MAY BE A PIECE OF INFORMATION I'VE OVERLOOKED, OR NOT YET FOUND - OR ONE THAT, BY WAY OF ANOTHER'S LEAK, OR DISCOVERY, SURFACES, THEN FITS.

SOMETIMES, I WILL FIND A PIECE OF INFORMATION WHICH APPEARS TO HAVE NO SIGNIFICANCE, AND THEN LATER, OTHER INFORMATION WILL SURFACE WHICH CONNECTS WITH WHAT, BEFORE, SEEMED INSIGNIFICANT. FOR EXAMPLE:

IN 2010, I READ A BIOGRAPHY OF ALLEN DULLES, WHICH IS PART OF THE PUBLIC LIBRARY'S COLLECTION, IN MONROE, GA. THEREIN, THE BOOK STATES A SIMPLE PARAGRAPH OR TWO, ABOUT DULLES' ATTENDING A MEETING WITH HIGH-RANKING NAZIS IN DENMARK, PURPORTEDLY, "TO FINALIZE THE TERMS OF THE END OF THE WAR." THE BOOK STATED THE MEETING WAS SECRET, AND UNDER VERY HIGH SECURITY. AND FROM THIS, ONE CAN GATHER VERY LITTLE.

WHAT CAUGHT MY ATTENTION, WAS THAT THIS OCCURRED IN DENMARK.

I MENTALLY FILED THIS UNDER "DENMARK" AND LEFT IT AT THAT.

IN THE COURSE OF CONTINUING TO READ AVAILABLE INFORMATION, IT CAME TO MY ATTENTION, THE S.S. HAD OBTAINED THE RESEARCH OF NEUROSCIENCE PIONEER OTTO LOEWI IN THE 1930'S; AS LOEWI DISCOVERED THE FIRST NEUROTRANSMITTER CHEMICAL, IT'S NOT A STRETCH TO PRESUME THE S.S. CONTINUED HIS WORK TO THEIR OWN ENDS, OR THAT LOEWI CONTINUED THIS WORK AFTER HIS ARRIVAL IN NEW YORK. THE MAIN IDEA HERE, IS THAT THE S.S. OBTAINED THIS TECHNOLOGY, AND SPENT ALOT OF TIME WITH IT.

THIS YEAR, I FOUND THE INFORMATION I FIRST REPORTED TO YOU, REGARDING THE ORIGINS OF PAROXETINE, BEING NOT WITH BUSS-LASSEN AND NEUROSEARCH IN DENMARK (AS WAS SO WIDELY ACCEPTED FOR DECADES) BUT INSTEAD BEING WITH THE GERMAN PHARMACEUTICAL COMPANY BOEHRINGER-INGLEHEIM, WHO EMPLOYED CENTRAL NERVOUS SYSTEM RESEARCHER - AND S.S. DOKTOR - FRITZ FISCHER. WHILE I CANNOT PERSONALLY VERIFY THIS, THE ASSEMBLER OF THIS GROUP OF INFORMATION PROVIDED A LINK (WHICH DID NOT FUNCTION) TO BOEHRINGER-INGLEHEIM'S U.S. PATENT FOR PAROXETINE IN THE 1970'S, AND A LIST OF COMPANIES IN DENMARK AND THE U.S. INVOLVED IN IT'S DEVELOPMENT, IN AN ATTEMPT TO DECIPHER THE TRAIL, BEFORE FINALLY SAYING, "THIS IS WHAT I HAVE. IT IS OMINOUS. PERHAPS SOMEONE CAN UNRAVEL THIS MYSTERY."

THIS GROUP OF INFORMATION ALSO INCLUDED A LINK TO SWC, AND A LETTER IT SENT OUT, REQUESTING INFORMATION FROM BOEHRINGER-INGLEHEIM ABOUT FORMER NAZIS THEY'VE EMPLOYED. ON THE SURFACE, IT APPEARS THE LETTER WAS SENT AS A RESULT OF THE INFORMATION PRESENTED, ALTHOUGH THIS MAY OR MAY NOT BE THE CASE. IT WAS AT THIS POINT I CONTACTED SWC MYSELF, AND FOLLOWING THIS, I AM ASSEMBLING ALL THE INFORMATION I HAVE, TO BE CONTRIBUTED TO THIS EFFORT.

I CAN ONLY HOPE SUCH AN EFFORT IS UNDERWAY, AND THAT I MIGHT BECOME A PART OF IT - WHILE WORKING ON THIS SUBMISSION RECENTLY IN BIG SUR, A TALENTED YOUNG JEWISH GUITARIST POSED THE QUESTION, "WHY DO GENTILES ALWAYS TRY TO BECOME INVOLVED IN JEWISH MATTERS?" (THIS QUESTION WAS NOT ASKED UPON MY SHARING THIS INFORMATION WITH HIM; I DID NOT)

IF I HAVE TO GUESS, I MIGHT END UP HEARING THIS QUESTION ALOT; MY ANSWER TO THIS QUESTION (AND I DO NOT SPEAK FOR EVERYONE) IS THAT MUCH IN THE SAME WAY AS WWII, WE SHARE AN ENEMY IN COMMON. AND IN MY VIEW, I'M SORRY TO SAY, THE U.S. HAS LOST MUCH TO THAT ENEMY SINCE WWII. ~~AND~~ SO MUCH SO, THE U.S. COULD BECOME THAT ENEMY-STATE, AS THERE ~~HAVE~~ ^{HAS} BEEN MUCH DEVELOPMENT IN THOSE DIRECTIONS, ~~AND THERE HAVE BEEN MUCH DEVELOPMENT IN THOSE DIRECTIONS~~

PERHAPS THE MOST SURPRISING THING I'VE BEEN ABLE TO CONCLUDE FROM THIS WORK I'VE DONE, IS THAT ALL THE HIGH-LEVEL PEOPLE INVOLVED IN CREATING THIS DRUG-DISTRIBUTION MONSTER IN THE U.S. ARE THE SAME ONES WITH THEIR HANDS IN OTHER "BAD PIES" AS WELL.

I WROTE BRENDA TO ACCEPT RESPONSIBILITY IN 2007, AND ASSURE HER AND OTHERS NO SUCH THING WOULD EVER HAPPEN AGAIN, AS IN 2007, I WAS WITH THE BELIEF THAT WHAT ACTUALLY CAUSED MY BEHAVIOR TO GO THAT FAR OUT OF CHARACTER, WAS MY OWN DOING, IN THE FORM OF TAKING A PILL, ON A DARE, BY THE DRUMMER IN OUR BAND, PAUL KIGER, WHO HAD THE PILL.

(AND BACK TO)

THE PILL, BELONGED TO PAUL'S MOTHER'S THEN LIVE-IN BOYFRIEND, A MAN I ONLY KNOW AS, "GARY," WHO HAD RECENTLY BEEN RELEASED FROM THE STATE HOSPITAL ON BULL ST. IN COLUMBIA. I BELIEVE THE PILL WAS HALDOL, BUT AM UNCERTAIN EXACTLY WHICH PSYCHIATRIC MEDICATION IT WAS. (HE WAS ON A NUMBER OF THEM, AND HIS MANNER REFLECTED THE PROFOUND SIDE EFFECTS ASSOCIATED WITH.)

OUTSIDE OF THAT, I DID WRITE THE WALTERS FAMILY IN 2004, OUT OF CONCERN FOR THEIR GENERAL WELL-BEING, TO WARN THEM ABOUT TAKING THE DRUG PAXIL, SHOULD IT BE PRESCRIBED TO ANY OF THEM, BECAUSE THAT AND OTHER DRUGS LIKE IT ARE GRIEVOUSLY HARMFUL TO PEOPLE. (I ALSO NOTIFIED THE ITEM AND MANY OTHERS AROUND THAT TIME, OF WHAT I WAS FINDING IN THE COURSE OF MY OWN RESEARCH INTO THAT CLASS OF PHARMACEUTICALS). I WROTE MRS.

WALTERS AFTER HER HUSBAND'S PASSING, TO THE BEST OF MY ABILITY. I'D NOT TRIED TO CONTACT GINGI AT ALL - AND RIGHTFULLY SO, BECAUSE WHAT COULD I SAY? SHE AND I HAVE NOT SPOKEN SINCE THE 1986 INCIDENT. RECENTLY, HOWEVER, I DID WRITE GINGI, TO LET HER KNOW WHAT I AM NOW LETTING YOU KNOW. SHE CAN CORROBORATE, ALTHOUGH HER HUSBAND MAY NOT LIKE IT.

WHILE IT WAS ^{ALSO} VERY STUPID OF ME TO TAKE THE PILL OFFERED ON A DARE BY PAUL KIGER, IT WOULD NOT HAVE MATTERED - THIS IS THE

REASON? I JUST DIDN'T CARE? NO - I DID - BUT IF IT DIDN'T MATTER -

VERY INTENSE HEADACHES I BEGAN HAVING AS A RESULT OF
WHAT I NOW RECOGNIZE WAS MY BEING POISONED, BY KIGER.

AND IN 2000, AFTER BEING PRESCRIBED PAXIL - NOT FOR ANY MENTAL ISSUE, BUT A PHYSICAL ONE, I BECAME SUICIDAL, COMPLETELY PSYCHOTIC, AND VIOLENT, DURING A HORRIBLE ADVERSE REACTION TO THAT DRUG, WHICH INVOLVED EVERYTHING FROM SEIZURES, TO ... WELL, AT THAT TIME, DURING THAT ADVERSE REACTION, I DID WIND UP IN JAIL, BECAUSE DURING THAT, I DESTROYED AN ENTIRE SPLIT-LEVEL HOUSE, AND ALL IT'S CONTENTS - AFTER YEARS OF NO TROUBLE WHATSOEVER. IN THE DOCUMENTS YOU'LL FIND AFTER THIS LETTER, I HOPE WHAT BECOMES VERY CLEAR, IS EXACTLY HOW STUPID I'M NOT, AMONG MANY OTHER THINGS A PERSON IN YOUR POSITION SHOULD BE AWARE OF, AS WE CONTINUE TO SEE THAT KIND OF PHARMACEUTICAL-RELATED VIOLENCE FESTER IN AMERICA. AND, TO THE DISMAY OF WHAT MUST HAVE BEEN AT LEAST 750 GUYS THAT HAD BEEN JUMPING OUT OF THEIR ASS, TRYING TO DATE HER, OR FUCK HER, OR MARRY HER, OR FUCK WITH HER LIFE, SHE AND I FELL, THE EXTENT OF GOONEY, STUPID - IN - LOVE TWO HUMAN BEINGS POSSIBLY CAN, SO QUICKLY.

(AND YEAH - I FUCKING LOVED EVERY MINUTE OF IT, AND SO DID SHE.)

THIS, OF COURSE, LED TO ALL KINDS OF DYNAMICS IN THE CENTRAL SOCIAL, BUT OVERALL, IT WAS A POSITIVE THING FOR ME, HER, AND VIRTUALLY ANYONE INTERACTING WITH EITHER OF US. AND IT ALL DID STAY THAT WAY FOR A MONTH, THEN ANOTHER, THEN ANOTHER, AND PROBABLY A COUPLE MORE. BY THEN, THE 750 GUYS WERE ALL ON THE VERGE OF RIOTING AND BURNING CARS IN THE STREET, BUT WE DIDN'T CARE, BECAUSE WHAT WE HAD, AND WERE, WAS REAL. YA'LL.

AND THEN, FOR ME, THE BIG MUSICAL FORK IN THE ROAD:

ON ONE BRANCH OF THE FORK, KATE HAD BEEN HEARING WHAT I DO, BECAUSE I PLAYED FOR HER EVERY DAY, AND SHE INTRODUCED ME TO ROSS SHAPIRO, WHOM SHE DATED AND WAS FRIENDS WITH, AND HAD ALSO HEARD; SHE THOUGHT IT WOULD HAVE BEEN A GOOD MIX. AND, SHE WAS SPOT-ON IN HER THINKING OF THAT - SHE WAS RIGHT TOO - TO A DEGREE I NEVER THOUGHT POSSIBLE, UPON HEARING THE GLANDS. AND ROSS DIDN'T EVEN SEEM TO MIND SO MUCH THAT WE WERE DATING. HE HAD HIS ROSSY APREHENSIONS, WHICH HE WOULD HAVE HAD WITH ANYBODY, BUT HE WAS OPEN-MINDED ENOUGH, IN SPIKE OF SOME TENSION OVER KATE - AND HE AND I PROBABLY WOULD HAVE GOTTEN AROUND TO PLAYING, AND EVEN BEING FRIENDS. BUT UNFORTUNATELY, HE AND I NEVER GOT TO, SADLY -

BECAUSE, ON THE OTHER BRANCH OF THE BIG MUSICAL FORK IN THE ROAD, AND AT THE EXACT SAME TIME, I WAS VISITED IN ATHENS BY MY FORMER BAND'S MANAGER (CAROL OROPALLO), AND BY THE GUITARIST IN THE SAME. IN THE TIME I HADN'T BEEN THERE, THEY HAD TRIED 4 OR 5 OTHERS TO FILL MY POSITION, AND IT WASN'T WORKING FOR THEM. SO THEY ASKED ME TO COME BACK - OR AT LEAST THAT WAS THE VERSION OF WHAT WAS UP THAT I GOT. AND HAD I KNOWN WHAT HAD BEEN - AND WAS STILL - UP, I WOULD HAVE RAN SCREAMING, FROM THEM ALL, AND CALLED THE POLICE, AND TAKEN OUT RESTRAINING ORDERS, AND BOUGHT A GUN. BUT, WITHOUT KNOWING WHAT I DIDNT, WHICH WAS KEY FOR ALL THIS BAD SHIT TO HAPPEN, WHAT I THEN HAD ON MY PLATE TO CONSIDER, WAS, THAT THERE HAD BEEN OVER 50 LARGE INVESTED INTO A BAND, IN WHICH, WITH THE GUITARIST, I HAD AN EVOLVED, 15+ YEAR MUSICAL RELATIONSHIP/FRIENDSHIP WITH; AND, THAT IN SPIKE OF SOME REALLY LONG-AWAITED PROGRESS FORWARD, THE WHOLE PROJECT - SOMEHOW - WAS SPLASHING AROUND IN THE TOILET, WHILE OUR MANAGEMENT/INVESTORS - AND I - DEPENDED UPON SUCCESS, AS ENOUGH OF THE FRAMEWORK TO STILL MAKE THAT HAPPEN EXISTED.

SO, I COULD SAY "FUCK YOU" TO ALL OF THAT, CONTINUE LIVING IN ATHENS, AND MAYBE END UP BEING A GLAND - WHICH THEN WAS STILL A CONCEPT, OR, I COULD LEAVE KATE LOCKWOOD (AS IF), HAPPY DAYS, 50-DOLLAR -A-MONTH RENT (COURTESY OF LAMAR WOOD WANTING TO GET IN MY PANTS, I WAS TOLD), AND GO, "WIFT, WILT AND LADEN," BACK TO COLUMBIA, SC, AND BEGIN THAT WORK AGAIN. AND THE QUESTIONS BECAME, WHAT WOULD I DO? WHAT WOULD JESUS DO? WHAT WOULD EARL SCRUGGS, PETE BUCK AND THE DALAI LAMA DO? WHAT WOULD YOU DO? WHAT SHOULD I HAVE DONE?

I SHOULD HAVE RAN SCREAMING, FROM THEM ALL, CALLED POLICE, TAKEN OUT RESTRAINING ORDERS, AND BOUGHT A GUN, AND THEN RENTED 4905 BARNETT SHOALS MYSELF, AND NOT TOLD ANYONE WHERE KATE AND I WERE, BUT AGAW - AT THE TIME, I HAD NO IDEA WHAT WAS UP. AND I HAD TO MAKE A DECISION. THAT WEEK.

BASED UPON WHAT INFORMATION I HAD, I DID MAKE THE BEST DECISION ANYONE PROBABLY COULD HAVE - AND IT WAS THE WRONG ONE, AND NOW.

WHAT I DECIDED WAS,

MY MOVING BACK TO COLUMBIA DIDN'T EVEN MAKE IT TO THE TABLE. I WASN'T DOING IT, AND NOTHING WOULD CONVINCE ME OTHERWISE. THAT MUCH OF THE DECISION PROCESS WAS A NO-BRAINER, NOT EVEN WORTHY OF THE LAUGHTER AT IT. A CARROT WOULD HAVE KNOWN BETTER, BUT, WHAT I WOULD DO, IS COMMUTE TO COLUMBIA TO PRACTICE 2X/WK, AND WE'D SEE HOW IT GOES.

(AND, AT LEAST IN ONE PERSON'S MIND, THE TRAP WAS SET. AND IT WORKED.)

FOR 2-3 WEEKS, IT WENT. BY THEN, WE HAD WORKED UP 3 SETS, AND THEN, IT BECAME THE MATTER OF GETTING THE 3 SETS HEARD. SO AS I'M PREDISPOSED TO DO, I TOOK THE INITIATIVE. I PUT OUR DEMO IN PETE BUCK'S MAILBOX, WITH MY RECEIPT FROM BUYING AUTOMATIC FOR THE PEOPLE, AND WHEN I GAVE IT TO BARRIE, SHE WAS CONVINCED ENOUGH TO GIVE US A FRIDAY AT THE 40-WATT, WITH MAN-OR-ASTROMAN OPENING FOR US. AND HOT DAMN.

CAROL, OUR MANAGER, AND I, WERE ELATED, AT SUCH AN OPPORTUNITY, FOR A BAND THAT HAD NEVER PLAYED THE 40 WATT, AND I WAS TOLD, THAT DIDN'T EVEN HAPPEN, EVER, AND, WE CONTINUED TO PRACTICE FOR THE GIG.

I TOLD EVERYBODY. KATE TOLD EVERYBODY. EVERYBODY TOLD EVERYBODY. MICHAEL STIPE SAID, "YEAH, I'M GOING TO BE IN TOWN THAT DAY, I'LL GO!" (AS CHRIS FARLEY SO ADORABLY PUT IT, "THAT WAS AWESOME...") BUT?

TWO DAYS BEFORE THE GIG, THE GUITARIST AND THE DRUMMER SAID, WHILE REFUSING TO GIVE ANY REASON, THEY JUST WEREN'T GOING TO PLAY IT. AND AS EVERYONE KNOWS, IT NEVER HAPPENED. EVERYONE SAID, "WTF!" AND WENT ON WITH THEIR LIVES. AND (AS PLANNED), I LOOKED LIKE DOUCHEBAG, THE SIZE OF A HOT AIR BALLOON, TO EVERYONE IN TOWN, AND KATE, AND MICHAEL STIPE, AND PETER BUCK, AND ... (COUNTS ON FINGERS...) AND?

ROSS AND RAND AND DEWITT AND GRAHAM AND ROBYN AND CAFE XRAY AND - YEAH, THE 750 GUYS CHEERED IN UNISON. LITTLE DID ANYONE (INCLUDING ME) KNOW, WHAT HAD ALSO STARTED HAPPENING, WAS, I WAS TURNING INTO (OR RATHER, BEING TURNED INTO) A REALLY, REALLY FUCKED UP ASSHOLE. BECAUSE WHAT THE DRUMMER WAS DOING EVERY CHANCE HE GOT WHILE WE PRACTICED, WAS, HE WAS DOSING ME WITH STOLEN PSYCHIATRIC MEDICATION, AS HE HAD DONE PRIOR TO MY LEAVING COLUMBIA FOR ATLANTA. AND, AS HE HAD DONE IN 1986.

AND, THAT'S NOT ALL HE DID. ONCE HE LEARNED I WAS INVOLVED WITH KATE - AND WHILE WE WERE PRACTICING, HE WENT INTO GA BAR WHILE SHE WAS WORKING, AND SCARED THE SHIT OUT OF HER WITH HIS VERSIONS OF THE VERY INSANITY HE HIMSELF HAD CAUSED, WITH THE BAND, AND IN 1986, BEHIND MY BACK; WHAT DIDN'T HELP, IS THAT KATE WAS SO FREAKED OUT, SHE DIDN'T TELL ME ABOUT IT FOR 3 WEEKS - AND IN THAT TIME, THE DRUGS KIGER THEN KNEW HOW TO USE TO ACHIEVE THE DESIRED EFFECTS HAD BEEN DOING JUST THAT, LIKE AN INVISIBLE BOMB GOING OFF.

AND, CONSEQUENTLY, FOR THE VERY FIRST TIME, KATE AND I WERE HAVING PROBLEMS, WE HAD NO WAY OF UNDERSTANDING. KATE WAS AFRAID, PULLED IN MULTIPLE DIRECTIONS, DIDN'T KNOW WHAT TO DO AND A COUPLE OF THE 750 GUYS, HAD MADE IT TO THE 30-YARD LINE, WITH FIRST AND TEN, AND THAT WAS OKAY. I KNOW THIS, BECAUSE ? (OKAY! BE SITTING DOWN!) IT WAS AROUND THIS TIME SHE CONFIDED TO ME, THAT IF SHIT GOT ANY WEIRDER, SHE WOULD - SERIOUSLY - FAKE HER DEATH, GTFO OF ATHENS, AND, IF I WAS TRULY WHAT SHE'D THOUGHT I WAS, FOR SO LONG, I WAS GOING WITH HER. I HAD NO IDEA HOW SHE PLANNED TO PULL THAT OFF, BUT I TOLD HER I WAS WHAT I AM, AND SHOULD SHE SAY THE WORD, I'D GO ANYWHERE WITH HER SHE WANTED, NO QUESTIONS ASKED. BUT?

I COULD NOT BE WHAT I AM, BECAUSE I WAS DRUGGED OUT OF MY MIND, AFRAID MYSELF, AND INSTEAD OF BEING WHO AND WHAT I AM, I BECAME A WEEPY, NOT EVEN NICE DOUCHE, FUCKING UP WORK AND EVERYTHING ELSE, UNTIL FINALLY, I HAD NO MONEY, NO JOB, BAD RELATIONSHIP DYNAMICS GALORE, WHICH WERE PISSING EVERYBODY OFF, BECAUSE THEY SAW IT, AND HEARD ABOUT IT, AND WHAT IT CAME DOWN TO, WAS LOSER LEAVE TOWN. AND BY ALL VISIBLE APPEARANCES, RIGHTLY SO.

- FOR THE RECORD, IT WAS ABOUT HERE, I DROVE MY VOLVO 80 MPH, OVER THE PULASKI ST. RAILROAD TRACKS, ON ELECTION EVE, 1992. (THERE'S A SQUARE STRUCTURE BY THE TRACKS, WITH A TALL, POINTY ROOF, AND THE BOTTOM OF MY CAR WAS ABOVE THAT LEVEL) AND THANKS TO KATE, HER MOTHER, AND THE DOSTER BROTHERS I ALMOST LANDED ON, I WAS ABLE TO GET THE CAR BACK 3 WEEKS LATER - THAT IS HOW INSANE I'D BECOME; AND I STILL OWE DOSTER BRDS. \$500. (I KNOW!)

KATE WAS, OF COURSE, FAR MORE ATTUNED TO SOMETHING NOT BEING RIGHT WITH THIS PICTURE THAN EVERYBODY ELSE (INCLUDING ME) EVEN WITHOUT KNOWING WHAT IT WAS. SO, SHE WAS FAR MORE REASONABLE THAN ANYBODY, IN HER HANDLING OF ALL OF THIS, AND ME, AND WHAT TO DO ABOUT ME. AND, SHE DID HANDLE IT, AS WISELY AS ONLY SHE COULD HAVE. (SHE JUST DIDN'T KNOW W.T. DO W/ HER)

I DIDN'T WANT TO, BUT IT WAS AGREED, UPON HER REASONING WITH ME, I WOULD LEAVE TOWN; SOMETHING SOMEWHERE, WAS FUCKED UP. AND IT MIGHT BE THE END OF US. BUT IT MIGHT NOT. EITHER WAY, IT WAS TIME I HAD TO TAKE COVER, SO I DID. BECAUSE I COULD HAVE BEEN KILLED.

I WENT TO FL. I STAYED WITH FRIENDS. I GOT A JOB. I DETOXED AGAIN, WITHOUT EVEN KNOWING IT. I DID OKAY, AND KATE AND I STAYED IN TOUCH. I DIDN'T KNOW IF I'D SEE HER AGAIN. I DIDN'T THINK I WOULD. IT SUCKED. MY FRIENDS IN FL, MY JOB, AND MY VOLVO. IT COULD HAVE BEEN A LOT WORSE. IT'S IMPOSSIBLE TO GUAGE (-GAGUE?) FUCK. LET ME TRY THAT AGAIN.

IT'S IMPOSSIBLE TO (TELL, MEASURE, ESTIMATE) THE DEGREE OF DRUG EFFECTS, THEIR DURATIONS, ETC., BUT I'M NOT WITHOUT INDICATIONS, I WAS DOSED WITH HUGE DOSES OF HALDOL AND THALIDOMIDE, OR ONE OR THE OTHER, OR BOTH, WITH ALCOHOL AND/OR SMOKE. IF THAT TELLS YOU ANYTHING.

A MONTH WENT BY. AND THEN, ANOTHER, WITHOUT THAT BULLSHIT NEAR ME.

AND THEN, KATE KNOCKED MY SOCKS OFF: SHE HAD RENTED 4905 BARNETT SHOALS. IT WAS SUMMER AGAIN. AND SHE INVITED ME UP. AND, FRIDAY, AT 5 O'CLOCK, I LEFT FROM MY JOB IN TAMPA, AND DROVE THERE, ^{ARRIVING} AT 4 AM, AS SHE WAS GETTING OFF WORK. THIS ROUTINE OCCURED OVER EVERY WEEKEND, THE ENTIRE SUMMER, INTO AUGUST. AND DURING THOSE TIMES, WE WERE AS DELERIOUSLY HAPPY AS WE WERE WHEN THINGS WERE GOOD AT GRADY STREET.

EXCEPT, IT WAS ALL ON THE DL. WE STILL DIDN'T UNDERSTAND WHAT HAD JUST HAPPENED, BUT WE MADE THE BEST OF IT - WE BOTH DID - AND ON EARTH, IN ANY HUMAN FORM, LIFE DOES NOT GET ANY BETTER, OR ANYMORE OF HOW IT OUGHT TO BE, WITH THE EXCEPTION OF HAVING TO HIDE IT, FROM EVERYONE WHO WOULD TEAR IT APART. AND THEN, BECAUSE YEAH, I SHOULD HAVE, I ASKED HER TO FINALLY JUST MARRY ME. IT WAS AUGUST 3RD. AND I'D FOUND THE RIGHT PINK.

HER RESPONSE TO THE QUESTION WAS HYSTERICAL, AND CLASSIC HER.

AND, REGARDLESS OF WHAT ANYONE ELSE THOUGHT, OR THINKS, OR WILL SAY, HER ANSWER TO ME WAS IN THE AFFIRMATIVE, AND THAT WE WOULD MARRY WAS PROBABLE. WE HAD TALKED ABOUT IT A FEW TIMES, AND WE WERE BOTH PRETTY SICK OF ALL THE SHIT WE HAD TO DO, JUST TO BE TOGETHER WITHOUT ONE HASSLE OR ANOTHER FROM SOMEBODY. BUT WE BOTH KNEW, THERE WAS A LOT TO FIGURE OUT/DO BEFORE WE ~~WERE~~ WE DID. I MAINTAIN, IT WAS THE RIGHT THING TO DO, ALTHOUGH FOR HER, SHE WAS BEING PUSHED AND PULLED BY GOOD AND ILL-MEANING PEOPLE, AND HAD LOTS OF GOOD AND BAD OPPORTUNITIES, SO IT WASN'T EASY - OR EVEN POSSIBLE - FOR HER TO GET TO 100% CONFIDENCE, AND IT WAS VERY DIFFICULT FOR HER TO TELL WHO/WHAT I WAS, WHEN, AND AFTER, THE POISON HIT THE GLASS, OR THE DOOB - YEAH. YEAH. YEAH.

IT WAS VIA THESE METHODS, I WAS STOLEN FROM HER. AND ATHENS. AND EVEN MYSELF. (THESE DAYS, PEOPLE ARE CHANGEABLE THAT WAY.)

MY FRIENDS IN FLORIDA, WHO ARE LIKE MY PARENTS, WERE JUSTIFIABLY PUSHING ME OUT OF THE NEST AGAIN. AND I WANTED OUT OF IT, AND OUT OF THE 2+ HR EACH-WAY COMMUTE TO WORK EVERY DAY. ** I'D LIKE TO HAVE KEPT ON DOING WHAT I WAS DOING, BEEN PATIENT, ETC., BUT THE FOLKS WEREN'T DOWN. AND I COULDN'T GO BACK TO ATHENS YET, AND RISK UPSETTING ANY BALANCES KATE MANAGED.

I WENT TO CHARLESTON. I FOUND A ROOM. I GOT A JOB. BUT.

THAT'S ALSO THE LAND OF OUR BAND MANAGEMENT, AND THEN, THERE WAS STILL A GREAT DEAL OF TENSION, SOCIAL UPHRAVAL, ETC., AND IT DIDN'T WORK OUT AT ALL. I CHOSE TO MOVE TO A PLACE I WAS BLACKLISTED; NOTHING WORKED OUT. NOBODY WHO NEEDED TO KNOW, KNEW WHAT HAD BEEN HAPPENING. (IT WAS I THAT FINALLY FIGURED IT OUT)

I COMMUTED TO SEE KATE WHEN I COULD. EVERYTHING WAS UNCERTAIN.

WHAT HAD GONE WRONG? WHY WAS I ACTING LIKE I HAD BEEN SOMETIMES? AND NOT OTHERS? WHAT CAN I TRUST? WHAT CAN I TRUST? WTF?

THEN, OUTSIDE DISGUSTA, EN ROUTE TO VISIT 4905, I WAS REAR ENDED, BY A NECK, IN AN F-150 DOING 70, AS I WAS DOING 5 MPH UP TO A LIGHT. IN MY VIEW, NOW, THE CHANCES OF THIS BEING, "AN ACCIDENT" ARE ZERO. IT WAS A HIT, INTENDED TO TAKE ME OUT. (AND THE FUCK IT WASN'T) IT WAS, TOO - EVEN IF ALL THEY KILLED WAS MY CAR THOUGH, THE DRIVER DIDN'T END: THE VOLVO PROBABLY SAVED MY LIFE, AND IN SPITE OF THE TRUNK BEING SMASHED IN TO THE BACKSEAT, AND THE DRIVE TRAIN BEING PUSHED TOGETHER LIKE AN ACCORDION, THE CAR STILL MADE IT TO ATHENS, AND THEN BACK TO CHARLESTON, WHERE IT WAS DECLARED A TOTAL LOSS, AND TOWN AWAY. HIT. BAM.

I BUSSED OVER TO ATHENS INSTEAD; KATE & I CONTINUED TO SEE ONE ANOTHER, BUT SHE'S LOOKING AT ALL OF THIS, GOING, "YOU KNOW? I DON'T KNOW..." BUT WORSE, I'D BEEN TO A LAWYER IN CHARLESTON ABOUT THE CAR (GARY LING), WHO GOT ME \$1300 FOR A NEW CAR. THE PROBLEM WAS, I COULDN'T FUNCTION ENOUGH TO GO OUT AND FIND A CAR, EVEN WITH \$1300, BECAUSE THE ~~DEED~~ LAWYER HAD SENT ME TO HIS DOCTOR, TO MAKE SURE \$1300 WAS ENOUGH, AND THAT I WAS OK, OR SO I WAS TOLD. WHAT HAPPENED INSTEAD WAS, SHIT GOT TACTICAL MEDICALLY. DURING THAT APPOINTMENT, TO MY SURPRISE, THERE WAS A SECOND DOCTOR IN THE ROOM. BUT HE WASN'T A DOCTOR. HE WAS A PHARMA REP. AND A CIA OR FBI AGENT, OR A POLICE SCIENTIST, OR A NAZI, OR ALL OF THE ABOVE, AND THEY LET ME WALK OUT OF THAT PLACE WITH A PINT-SIZED BOTTLE OF 100 METHOCARBAMOL TABS, WHICH AT THE TIME, WERE BEING TESTMARKETED, AS, "SOMA". MAYBE SO; IT WAS SET UP BY A NANY LAWYER; HIS DOC, HIS DOC'S FAKE DOC REP! THIS WAS THE EXACT SAME THING ACTRESS DANA PLATO BECAME SUICIDAL ON, THEN SUICIDED WITH. THE QUANTITY AND BOTTLE DESCRIPTIONS IDENTICAL, BUT NOT ONE EFFECT - TWO DISTINCT, DIFFERENT EFFECTS AND NEURODYNAMICS! SURE, YOU GOT A BUZZ, AND IT WORE OFF, BUT WITHIN A WEEK OF THAT, MAYBE 10 PILLS INTO THE BOTTLE (AND COUNTING, AS DIRECTED) ALL YOU WANT TO DO, ALL THE TIME, IS DIE! AND IF YOUR LIFE IS GOING AS BADLY AS MINE AND DANA PLATO'S, EVEN MORE SO. SHE ATE THE WHOLE BOTTLE, AND DID; AND WHAT THE FUCK DO I DO? WHY SURE! WANT THE HIGHLIGHTS? OVER A 2 WK PERIOD?

- HERE: HOW WOULD YOU LIKE BEING TURNED INTO THIS:

I POUR A FULL GUINNESS ON KATE'S HEAD WHILE SHE'S SLEEPING. (SHE DOESN'T EVEN GET MAD) I KICK (THE FUCK OUT OF) JULEP, ONE OF THE DOGS, WHEN I WOULD NEVER DO THAT IN A HILLION YEARS - AND THEN, I SLASH MY ARMS OPEN, RIGHT IN FRONT OF KATE. BECAUSE THAT'S JUST THE "KIND OF MENTAL HEALTH I HAVE" AND THE KIND OF SHIT I DO? FUCK YOU. IF

THAT'S WHAT ANYBODY THERE WANTS TO SAY I AM, OR WAS. NO:

I NEVER WOULD HAVE DONE THAT TO KATE OR MYSELF. NO WAY.

I NEVER WOULD DO THAT TO A DOG, MUCH LESS, ROSIE OR JULEP -
AND BEYOND. THESE DAYS, PEOPLE ARE CHANGEABLE TO THAT DEGREE; BEYOND. THESE DA

I NEVER EVEN WOULD HAVE WASTED GOOD GUINNESS LIKE THAT,
AND IF YOU HAD A GUINNESS IN YOUR HAND AT 4905, IT WAS
WORTH A THOUSAND GUINNESSES AT THE BAR. ALL DAY LONG.

I KNEW WHERE I WAS, AND I WAS WHERE I BELONGED. BUT?

EVEN THOUGH I WAS WELL-READ ON ATHENS YEARS BEFORE I WENT,

TRUTH IS STRANGER THAN MOST FICTION, BUT REAL, TRUE BLACK COMEDY
IS BLACKER THAN ANYTHING, IF IT'S AT YOUR EXPENSE.

I'M NOT MEANING ALL THE DRUG SHIT YOU JUST READ.

AND TO EVEN CONVEY THIS INSANITY SANELY, IS NOT EASY; I'LL HAVE TO
PREFACE, BY SAYING, THAT BY WAY OF SO MANY OF THESE UNIQUELY FUCKED

USAGE AGAINST ME, FOR ALL THE INSANE WAYS I HAD BEEN BEHAVING.
(AND BEVERLY KAISER, KATE'S MOTHER, WILL AGREE ALL DAY)

BUT, IF KATE IS LYNDIA, BEVERLY KAISER IS MICHAEL STIPE'S MOTHER, TOO.
 (A SHAKING HAND SLOWLY LIFTS THE CUP FROM THE SAUCER...)
 AND KATE, OR LYNDIA, HAD FAR MORE THAN JUST THE MEANS TO FAKE
 HER DEATH. AND EVERYBODY?

DID HATE ME. JUSTIFIABLY. BUT IT WAS NOT ME THEY HATED.

I AM THE HONEYBAYER. I DO NOT BEHAVE IN THOSE WAYS.

CHANGEABLE TO THAT DEGREE AND BEYOND. THESE DAYS, PEOPLE ARE CHANGEABLE TO THAT DEGREE AND

THESE DAYS, PEOPLE ARE CHANGEABLE TO THAT DEGREE AND BEYOND.

ALL THAT SAID - AND YES, DONE - I HAVE TO VOICE THIS:

THE QUESTION OF KATE BEING KATE OR LYNDIA IS IRRELEVANT TO ME.

BUT I REALLY AND TRULY DON'T KNOW WHAT TO BELIEVE.

I DON'T. AND I DON'T CARE. I WANT MY FRIEND BACK. RIGHT FUCKING NOW.
