#### [Bond Orgs Ask SEC For Clarity On Disclosure Requirements](#)

A group of five trade organizations asked the U.S. Securities and Exchange Commission for guidance that would allow municipal bond issuers to amend continuing disclosure agreements on Tuesday, arguing that the current structure hinders both issuers and investors by requiring issuers to produce irrelevant or outdated information.

The U.S. Department of the Interior said Tuesday that state regulators should not allow coal companies to self-bond for pollution cleanup costs because of the currently weak market for the fossil fuel.

#### [FCC's City-Run Broadband Order Shot Down By 6th Circ.](#)

A Sixth Circuit panel on Wednesday struck down an order by the Federal Communications Commission that overrode state laws in North Carolina and Tennessee that restricted how cities and towns offer their own internet.

#### [IRS Relaxes Rules for Charitable Remainder Annuity Trusts](#)

The Internal Revenue Service is allowing charitable remainder annuity trusts to include a sample provision in their governing agreements so they won't be subject to a disqualifying test, according to a notice published Tuesday.

#### [Feds Claim Bridge Scandal Defendants Punished 2nd Mayor](#)

Prosecutors on Tuesday pushed to introduce allegations at the upcoming trial of two former public officials charged in the George Washington Bridge scandal that they also retaliated against Jersey City Mayor Steven Fulop, as one of those officials accused the government of ignoring evidence that New Jersey Gov. Chris Christie had "lied" about senior staff's involvement in the lane closures.

### Seminole Tribe Say Proposed Fla. Water Regs Are Too Weak

The Seminole Tribe of Florida has urged a state agency to reject a proposed rule that would revise the state's surface water quality standards, saying the rule doesn't include enough protections for tribe members who subsist on fish and other seafood.

### Polar Bear Habitat Suits Axed After 9th Circ. Ruling

A federal district judge on Monday tossed three suits challenging the U.S. Department of the Interior's establishment of an Alaska polar bear habitat, months after the Ninth Circuit found the district court erred when it held the federal government to an unnecessary standard of specificity in designating the habitat.

### DC Circ. Asked To Undo DOT's Ban Of E-Cigs On Flights

The Competitive Enterprise Institute and the Consumer Advocates for Smoke-Free Alternatives Association pressed the D.C. Circuit on Tuesday to vacate the U.S. Department of Transportation's recently imposed rule that explicitly bans electronic cigarette use on commercial flights.

### SL Green Settles Air Rights Row With Grand Central Owner

SL Green Realty Corp. said Wednesday that it has settled a \$1.5 billion lawsuit filed by the owners of New York City's Grand Central Terminal over allegations the landlord lost the right to profit from air rights sales when the city rezoned the site of the developer's One Vanderbilt project.

## Lesbian Couple Sues NJ Insurance Czar Over Infertility Policy

New Jersey's insurance commissioner has been slapped with a federal lawsuit alleging the state discriminates against lesbian women seeking insurance coverage for fertility treatments because it defines infertility as the inability to become impregnated by a male partner.

## Texas Bar Won't Sanction AG For Same-Sex Marriage Opinion

Texas Attorney General Ken Paxton did not violate his oath to defend the U.S. Constitution and the laws of the United States by telling county clerks they could decline to issue marriage licenses to same-sex couples on religious grounds, the state bar concluded last week after an investigation.

### Pa. GOP Sens. Say Judicial Retirement Ballot Not Misleading

A pair of Republican Pennsylvania state senators fighting efforts to change the wording of a controversial ballot measure that would raise the mandatory retirement age for state judges urged state justices on Tuesday to avoid nullifying legislative and executive actions because of subjective beliefs that the question is "misleading."

### Seattle Gets Chamber's Uber Union Antitrust Suit Tossed

A Washington federal judge on Tuesday tossed the U.S. Chamber of Commerce's antitrust challenge to a first-of-its-kind Seattle ordinance allowing drivers for Uber, Lyft and other ride-hailing apps to unionize, saying the suit prematurely alleges future harm from a law that hasn't yet taken effect.

The U.S. Department of Agriculture published a notice Wednesday in the Federal Register allowing the import of fresh pomegranates and figs from Peru into the U.S. after a risk assessment found them unlikely to introduce new pests into the country when certain safety measures are taken.

### Ky. Scraps Tax Board To Focus More Funds On Crime Victims

Kentucky Gov. Matt Bevin has scrapped the state's Board of Tax Appeals along with two other boards to cut costs and create a single claims commission that will focus more heavily on crime victims, according to a statement released Monday.

## Worker Groups Lose Reconsideration Bid In H-2B Suit

A New Jersey federal judge on Tuesday denied a bid by worker groups seeking reconsideration of an earlier ruling finding they lacked standing to challenge an H-2B visa program wage rule, saying they failed to demonstrate that they were entitled to reconsideration under the Federal Rules of Civil Procedure.
