As I read the statutes, you are exempt. The majority of the executive staff now has grievance rights, except for state retirees (i.e., Karl).

In order for each person to obtain grievance rights again, he or she will have to serve out a probationary period. You can choose whether each person's probationary period will be 6 months or 12 months.

The sample letter needs to go to each person, parallel to the letters that went out several years ago, taking grievance rights away.
