Dear Governor Daley,

I'm writing to you to see if you can help me. I have a lot of health problems and my doctor is worried what I'm going through with Walmart insurance, I.C. that I may have a heart attack or stroke at anytime, that's why she put me on heart medication last year. I was borderline heart attack/stroke. This with Walmart has been going on for 4 years and 8 months. In 2011 is when it all started. The boy, I don't know his name but I've tried to find out - all I can tell you he's with Asset and Protection, wears black rimmed glasses, hair on his chin and looks like he's in his 30's or 40's. It all started when in 2011 he accused me of stealing a pair of sunglasses but he didn't and explained where I left the sunglasses I was

considering buying but
changed my mind. I only
wanted to get my mom,
who is 88 years old home
so she could lay down
because she felt faint
since having open heart
surgery just a year
prior to this. I tried
to explain that to him,
but he wouldn't listen.
Instead accused me of
being a communist. He
threatened to have me
arrested, bullied both
my mom and I by shaking
his finger in her face
and threatening to have me
arrested with no proof.
I told him to go through
our groceries that we'd just
bought also my purse.
He wouldn't do it, just kept
accusing me of being a thief.
All he had to do was go
to the little girls department
or have one of the other two

people that was with him go
look, they'd found the sunglasses
2 months later I got a
registered letter "No Trespassing"
later he calls the Sheriff's
Office and tells them I'm in
Wal-Mart but it was my
sister who'd come up from
Florida. She & I both tried
to clear my name with the
Sheriff's Office and Wal-Mart's
main office, but no one would
listen. They all believed him
then thought I had proof where
I was (a letter from witnesses
and a receipt from getting tires
put on my car in Walhalla,
S.C.). My sister had a
list of witnesses also. She
used her credit card at
Wal-Mart. So, in short he
told the Sheriff's Department
and they believed him. He's
also lied numerous times to
The main office of Wal-Mart in
Oklahoma about me and everyone

believes him. This guy has
had it in for me Vendetta, and
I don't know why or even
who he is. I've never stolen
anything. That's wrong. You're
supposed to be innocent until
proven guilty, but it's like
they've done found me guilty
with no proof. I'm on a lot
of medication and this stress
has taken it's toll on my
health. I'm scared because
he and Wal-Mart has it
in for me.

I do have a Public Defender,
but he has me scared by
my ~~own~~ wits. I can't
afford a lawyer because
I don't draw very much
SSI, I'm below poverty
level.

I'm not just worried about
me but I'm worried about
my mother, too, because
she could have another
heart attack.

Wal-Mart and this guy has

destroyed To say the least
my life. They've embarrassed
and humiliated my family
and me because my face
and information was in several
papers.

My public defender is
Russell Patrick and if it
goes to a jury trial Judge
Norton will be presiding.
Please help if you can.

I've pleaded with the main
office in Arkansas (at least)
my innocence but nothing
comes of it, they believe
that guy in Mexico's what
also, my sister has pleaded
with them to, because she
felt bad about going in there
and then I was blamed for it,
also to help her sister.

I look forward to hearing from
you Governor Haley. No one
should be put through this
what I'm going through, nor
my mother.

Thank you for listening
to my story. I forgot in
November of 2014 the Wal-Mart
(same place) had me arrested
saying that again I stole
from the store. He took a
photo of my drivers license
with his cell phone. And
he had me arrested. I didn't
do anything but come onto the
property after being told
they needed people that I
could. I didn't know
that the "No Trespassing" sign
never until the Police and
the Public Defender said so.
That's the first time I'd
been in that store since
April or May 2011. But that's the
only mistake I made.
