I, MILTON HOWARD JONES, OPUS # 0464781, AM INCARCERATED WITHIN THE NORTH CAROLINA DEPT. OF CORRECTIONS AT LUMBERTON CORR. INST. SERVING 27 YEARS, 9 MONTHS FOR COMMON LAW ROBBERY, NOT TO BE RELEASED UNTIL 2032.

HOWEVER, IN 2003 I WAS CONVICTED THERE IN SOUTH CAROLINA IN YORK COUNTY RECEIVING A SPLIT SENTENCE IN WHICH I SERVED THREE (3) YEARS ACTIVE TIME WITHIN THE SOUTH CAROLINA D.O.C., WITH TWO (2) YEARS PROBATION WHICH I HAD TRANSFERRED TO CHARLOTTE NORTH CAROLINA DUE TO I WAS A RESIDENT OF CHARLOTTE AND HAD NEVER RESIDED THERE IN SOUTH CAROLINA.

I HAD RETURNED TO WORK FOR THE COMPANY THAT I HAD BEEN EMPLOYED WITH OFF AND ON SINCE 1997 AS AN ELECTRICIAN, THAT WAS IN JUNE OF 2006 AND IMMEDIATELY I BEGAN TO MEET WITH A PROBATION OFFICER MAKING RESTITUTION PAYMENTS AT EACH SCHEDULED VISIT. HOWEVER, IN SEPTEMBER OF 2006 THERE WAS A CONTRACT DISPUTE BETWEEN THE COMPANY THAT I WAS EMPLOYED WITH AND THE GENERAL CONTRACTOR OVER THE JOBSITE. MY CREW WAS LAYED OFF AND BECAUSE THOSE THAT WERE STILL WORKING AT THE SIGHT WERE ALL IMMIGRANTS THIS ANGERED ME AND I ALLOWED MY EMOTIONS OVER-RIDE THE BENEFIT OF INTELLECT AND I COMMITTED A NUMBER OF COMMON LAW ROBBERIES HERE IN N. CAROLINA.

RECENTLY I HAVE GAINED ACCESS TO THE N.C. DIVISION OF PRISONS POLICY MANUAL AND IN

CHAPTER (6) SECTION .0100 TITLE: OUTSTANDING CHARGES/DETAINEES; (C) INMATES REQUEST:

#1) THE INMATE MAY PETITION FOR FINAL DISPOSITION OF AN OUTSTANDING CHARGE BY SUBMITTING A WRITTEN REQUEST TO THE INTERSTATE AGREEMENT ON DETAINEES ADMINISTRATOR FOR SPEEDY TRIAL. UPON RECEIPT OF THAT REQUEST, THE INTERSTATE AGREEMENT ADMINISTRATOR WILL VERIFY THAT A DETAINEE IS ON FILE IN THE AUTOMATED INMATE RECORDS SYSTEM. IF THE DETAINEE HAS NOT BEEN RECORDED, THE INTERSTATE ADMINISTRATOR WILL ADVISE THE INMATE IN WRITING TO FILE A WRITTEN REQUEST TO THE APPROPRIATE JUDICIAL AUTHORITY, PETITIONING THE OUT-OF-STATE PROSECUTOR TO PROCEED, PURSUANT TO G.S. 15A-761.

HOWEVER, I HAVE BEEN TOLD BY NORTH CAROLINA COMBINED RECORDS THAT I COULD NOT PROCEED, AND THAT THE PROBATION VIOLATION THERE IN SOUTH CAROLINA CANNOT BE DISPOSED OF UNTIL I HAVE COMPLETED MY COMMITMENT HERE IN NORTH CAROLINA.

MY REASONS FOR DISPOSITION OF THE PROBATION VIOLATION PENDING THERE IN SOUTH CAROLINA IN YORK COUNTY IS THAT I CANNOT ADVANCE IN PROMOTIONS IN THIS NORTH CAROLINA PRISON SYSTEM DUE TO THIS DETAINEE.

I DO NOT HAVE THE YORK COUNTY COURT CASE FILE DOCKET NUMBER BUT I WAS SENTENCED IN 2003 AND IF I RECALL IT WAS IN SEPTEMBER ON THE 11TH.

GOVERNOR HALEY I WOULD TRULY APPRECIATE YOUR OVER-VIEW IN THIS MATTER FOR I AM NOW 54 YRS. OLD AND WILL SPEND THE REST OF MY PRODUCTIVE LIFE IN PRISON THANKS TO THE BARBARIAN LAWS IMPOSED BY THE DEMOCRAT PARTY.
