TO WHOM IT MAY CONCERN:

This is in regards to an accident that occurred on November 15th of this year at the intersection of Bridge 1146 and Langston Road in Anderson County, South Carolina.... The problem is that it took an Hour for a Law Officer to get to the scene.. He was dress in a Black Uniform with a Badge and had a Belt with a gun and extra.... We thought he was a City Policeman and was writing up the violations of the accident..

He proceeded to take the first person and when finished came up to me and ask for License and Registration and Proof of Insurance which I gave him and did not take any statement from Me on what did happen....He went back to the Cruiser and wrote up the ticket and when returned gave it to me.. I look at the ticket and found he charge me for failure-to-yield when he did not even listen to me.....I told him then that I have look Left, then Right and even then look Left before pulling out to make the Left turn and when I did pull out there was no car or headlights visible and when I was up in my lane, this pair of headlights came right at me and hit me....It Knot me out for a bit, and when I came conscious, I was against the guard rail on my side of road.....The Cop just said that she slid into me when trying to brake in a 35 Mile Speed Zone.....

He just told me to be at the Court date of 16 December at 2404 N. Main St. in Anderson, South Carolina at; 9 AM , did not mention anything about Bond since I was out of State (Ohio),,,,,,,He then return to his city car and left.....

When I came back in December for Court date, I found out that the Officer was a State Highway Patrolman....I had to plea NO=Contest as I could not stay for another trial if I plea Innocent....The Judge allow me to tell my story of what happen and like I said that he was dress in a black uniform and driving a city cruiser when he came to the scene and did not identify himself when He came up to Me the first time or ever..... The Judge was not happy with him and when I said he did not take a statement, The Judge took the ticket away from the Trooper and wrote something on the bottom and handed to me and told me to leave.....and pay the Cashier for court cost only.....

If this is the way the State Patrolmen of the State of South Carolina act and do in Court then I would advise all visitors from outed state to be aware you are guilty before you have a chance to explained.....

The State Patrolman was J Brant or Brent from Troop #3 and out of Post A located in Anderson, South Carolina.....;Badge # 453 as far a I could read it on the ticket.. This person was Moonlighting for some city and was not dress in State Uniform at the accident that night...

I am advising the Better Business Bureau as to notify if anyone heading to South Carolina to be on the look out for the behavior of the State Highway Patrol if anything happens..

Thank you for reading the above and I Hope some action is taken so this will never occur to someone else.....Most Patrols are good but there are some bad ones.....
