

Dear Ms. Bowling;

This letter is to formally request a meeting regarding the Non-Emergent Transportation Program. As President of the South Carolina EMS Association, I have recently received numerous calls regarding information that providers are receiving from the two brokers that conflict with the education provided by Health and Human Services. Additionally, I would like to have a representative from the Transportation Service to be present and speak at our next Association meeting scheduled for July 12, 2007.

As a provider, our goal is to ensure that the Medicaid beneficiary receives the appropriate transportation, and the services are paid by the appropriate organization. With the conflicting information, I am not sure that this is occurring efficiently.

We also request a meeting with the Executive Committee of the South Carolina EMS Association, South Carolina Department of Health and Human Services, and representatives from both LogistiCare and MTM. The outcome from this meeting is to have a clear definition on what type and parameters of transports that the brokers would be responsible for and what type of transports that the Medicaid program would be responsible for.


Dear Mr. Lesiak:
