Subject: Winter Weather Updates

Thanks to everyone who provided regional updates to Gerry. Going forward (for the sake of uniformity and thoroughness), please use the attached detailed form to submit daily updates to hpage@aging.sc.gov AND jvanceleave@aging.sc.gov by 2:00p each day until further notice. If your region has nothing out of the ordinary to report (or no changes since your last update was submitted), just reply back with “No updates” or “Normal operation”.

As of today, South Carolina is operating at OPCON 4, which means the possibility of an emergency or disaster situation exists that may require state coordination during emergency management operations. Staff at the LGOA continues to be in regular communication with emergency staff and will serve at the Emergency Operations Center, if called upon. We will also continue to gather and forward pertinent information and host any conference calls (if needed).

This morning, our office received an update from the National Weather Service, and we have attached it to this e-mail for your review. Additionally, the following helpful links remain active:
