Consideration of Mission Statement Revisions

Summary

Tri-County Technical College has requested that the Commission approve changes to its mission statement. Changes were submitted in fulfillment of requirements for Performance Finding Indicator 1C, Approval of a Mission Statement. Guidelines for Indicator 1C require that an approximate numerical value for the size of an institution be included in the mission statement. A summary explanation follows, with a staff recommendation for all requested changes at the end of the summary explanation. The mission statement, with changes shown, is attached at the end of the document.

Tri-County Technical College

Tri-County Technical College has requested that the Commission on Higher Education review and approve a revised mission statement for the institution. The revised statement was approved by the Tri-County Technical College Area Board on August 2, 2004. The mission statement is attached at the end of the document.

Commission staff has reviewed the revised statement and found that the statement has been significantly edited for brevity and clarity. The revised statement meets the requirements of Indicator 1C.

Staff Recommendation

The Committee on Academic Affairs and Licensing recommends that the Commission approve the revised mission statement for Tri-County Technical College.

Please find enclosed the most recent mission statement for Tri-County Technical College, as approved by our Commission on August 2, 2004. This resubmission is a result of your e-mail dated July 21, 2004, informing us of the CHE staff requirement to add language regarding the size of the College.

I have been directed by our Commission to note that the updated statement is submitted under protest. It is the strong feeling of our Commission that reference to College size is inappropriate for inclusion in a mission statement. Such language is more appropriately part of an institution's strategic plan. Mission statements should be "timeless" as much as is possible. To include language referring to specific enrollment numbers, or even ranges, dictates a limited usefulness of that which should not be so bound.

I should note that it is not the intention of Tri-County Technical College to grow recklessly. Our desire is to fulfill our mission of serving the educational needs of our service area. Our size will be a factor of whether or not we are in fact accomplishing our mission.

I would be glad to discuss this further with you if necessary.
