The official meeting of the Anderson County Council convened in the Council Chambers of the Historic Courthouse on Tuesday, December 17, 1996 at 7:00 p.m.

Chairman Garrison called the meeting to order and Mr. Gerrard gave the invocation. Everyone stood and pledged allegiance to the flag.

On the motion of Mr. Banister, seconded by Mr. Gerrard, Council voted unanimously to approve the minutes from the December 3, 1996 meeting as mailed.

Ms. Suzanne McMahan, Director of the Special Population Recreation Department, presented a plaque to Council on behalf of Area 14 Special Olympics volunteers, athletics and parents, as a token for Council's support of the program. Council thanked Ms. McMahan for the outstanding job that she does.

Mr. Preston announced that two industries had decided to locate or expand in Anderson County; Alliedsignal and Orian Rugs. Council also heard from Mr. Lawrence Campbell and Mr. Allan Thomas, Vice Chairman of the Economic Advisory Board, who spoke about the industries. They also urged Council to approve the resolution and inducement contracts for these industries. On the motion of Mr. Tolly, seconded by Mr. Floyd, Council voted unanimously to approve Resolution #R96-041 - a resolution authorizing the execution and delivery of an inducement agreement by and between Anderson County and Alliedsignal Corporation whereby under certain conditions, Anderson County will execute a lease agreement(s) for a project(s) involving not less than Five Million Dollars (\$5,000,000) investment.

On the motion of Mr. Floyd, seconded by Mr. Tolly, Council voted unanimously to approve Resolution #R96-041 - a resolution authorizing the execution and delivery of an inducement agreement by and between Anderson County and Orian Rugs, Inc. whereby under certain conditions, Anderson county will execute a lease agreement(s) for a project(s) involving not less than Five Million Dollars (\$5,000,000) investment.

A public hearing was held concerning Ordinance #96-026 - an ordinance entitled "Exemption for Public Schools" relating to Anderson County Building and Codes/permits. No comments were made. On the motion of Mr. Floyd, seconded by Mr. Tolly, Council voted unanimously to approve third and final of Ordinance #96-026. Council also heard from Mr. Tony Saad, Plant Manager.

Mr. Garrison opened a public hearing concerning Ordinance #96-027 - an ordinance providing for the amendment to the Agreement for Development for a joint county Industrial Park with Clarendon County. No comments were heard. On the motion of Mr. Banister, seconded by Mr. Gerrard, Council voted four in favor and one abstention (Floyd) to approve the ordinance on third and final reading. Motion carried.

Mr. Garrison opened a public hearing for comments concerning Ordinance #96-030 - an ordinance creating a special tax district in the Cobb's Glen Subdivision. No comments were heard. On the motion of Mr. Floyd, seconded by Mr. Tolly, Council voted unanimously to approve on third and final reading Ordinance #96-030.

On the motion of Mr. Banister, seconded by Mr. Gerrard, Council voted unanimously to approve second reading of Ordinance #96-031 - an ordinance authorizing the execution and delivery of not less than \$45,000,000 and not exceeding \$103,000,000 Principal amount Industrial Revenue Bonds, for Owens-Corning Fiberglas Corporation Project.

On the motion of Mr. Gerrard, seconded by Mr. Banister, Council voted unanimously to approve first reading of Ordinance #96-032 (title only) amending sections of the Anderson County Code for the purpose of updating the County's Purchasing Code.

On the motion of Mr. Floyd, seconded by Mr. Tolly, Council voted unanimously to approve Resolution #R96-039 - a resolution to implement updated Anderson County Purchasing Procedures and Regulations.

Mr. Banister moved to appoint Bill Bates of 231 Griffin Farm Road, Honea Path, to the Human Relations Council. Mr. Tolly seconded and vote was unanimous.

Mr. Garrison suggested that Vance Wells, III be appointed to replace Juanita Russell on the Planning Commission for District #4. Mr. Tolly moved to approve the appointment and Mr. Tolly seconded. Vote was unanimous.

Mr. Preston presented bids for Engineering Services for the Sunset Forest Sewer Project for \$18,500.00 by BP Barber & Associates. On the motion of Mr. Gerrard, seconded by Mr. Banister, Council voted unanimously to approve as presented.

Mr. Preston presented change order #7 - SC 86/I85 Sewer Project. \$500,000 of the money is presently being provided by a Community Development Block Grant for a force main, pump station and gravity lines. The change order involves rock excavation at pump station #3. Mr. Tolly moved to approve and Mr. Gerrard seconded. Vote was unanimous.

Mr. Stephen Crawford explained bids for removing the Old Double Springs School building. He said that if the county waived the landfill fees the cost would be \$2,000 and if they did not the cost would be \$3,400 to haul off the debris. Mr. Crawford explained that the building burned a couple weeks ago therefore the cost should be lower. Mr. Crawford recommended that council approve the removal of the building and allow the expenditure up to \$2,000 for this phase of the project. Mr. Gerrard moved to approve as recommended and Mr. Banister seconded. Vote was unanimous.

Mr. Crawford presented costs for the grading and grassing and parking lot at the Double Springs Community Park. The grading and grassing would cost \$7,150 and the parking area would be \$11,460 (total \$18,850). These costs are based on bids and therefore would request that the work be approved and the money

to come from District #5 asphalt account. Mr. Preston suggested that the County solicit bids/proposals before Council makes a commitment for County people to do the work. If this can't be done within these figures, then maybe the county can do the work. Mr. Gerrard moved to approve the grading, grassing and parking lot as a contracted job and not to exceed \$18,850. (This will be let for bids and if this is under the limit then it will be contracted out instead of done by Public Works). Mr. Banister seconded and vote was unanimous.

Mr. Gerrard moved that \$6,500 be allocated for backstop and fencing for the first phase of development once the grading and grassing is complete. The money will come from District #5 - Recreation Funds. Mr. Banister seconded and vote was unanimous.

On the motion of Mr. Gerrard, seconded by Mr. Banister, Council voted four in favor on one abstention (Garrison) to approve the 1996-1997 Fiscal Year proposed paving list (copy attached to minutes).

On the motion of Mr. , seconded by Mr. Gerrard, Council approved to allow the removal of remaining piles of storm debris as a result of the tornado for six individuals at no charge to the individuals as set forth in the memo from Mr. McClure.

On the motion of Mr. Tolly, seconded by Mr. Floyd, Council voted unanimously to approve the renewal of a sublease agreement between Skip-J, Inc. and Anderson County for a weapons range.

On the motion of Mr. Banister, seconded by Mr. Gerrard, Council voted unanimously to approve the paving near new brick work around a building at the Ebenezer Fire Department. The amount estimated is \$130.00 which will come from District #3 paving money.

On the motion of Mr. Tolly, seconded by Mr. Floyd, Council voted unanimously to abandon any interest in a portion of Grubb Road C-1-174B (a short road off Joe Black Road). The individuals making the request must petition the courts for abandonment.

ADMINISTRATOR'S REPORT:

Mr. Preston reported that he attended and did a presentation at the meeting "Foundations for the Future" by the Chamber of Commerce and found it to be very informative.

1. A list of County roads approved for ACTC funds for paving was presented to Council. He authorized the paving contractor to go ahead and begin paving because of the time frame.


2. Interest Calculations on "C" Funds lost because of the way the funds were disbursed: \$250,109 - total for past four fiscal years.
3. Training at the Detention center - at least each officer on staff with at least 24 hours of in-service training. This is the first for Anderson County. Michelle Hemphill was recognized for graduating as an Honor Graduate at the state.
4. The advertisement for Reassessment Program was presented for Council's information.
5. Mr. Preston presented a copy of a letter produced by Clemson University.
6. A copy of a request for \$150,000 for installation of a sewer line in Pendleton was presented for information.
7. The annual June 30, 1996 Audit will be presented at the next meeting and it is an UNQUALIFIED audit. Fund balance is \$14,000,000. of that is \$11,892,000 not designated.
8. Monthly reports for the Compliance Office was presented by Mr. Watson.
9. A sample ordinance concerning Sexually Oriented Business Regulations was presented for information.

Council presented Mr. Garrison a plaque for his dedicated service as chairman for the last two years. Mr. Floyd presented Mr. Garrison a car (toy) as a going away present just as he wished Council would.

On the motion of Mr. Gerrard, seconded by Mr. Banister, Council voted unanimously to hold a called meeting for Monday, December 30, 1996 at 4:30 p.m. for the purpose of third readings and public hearings on Ordinance #96-028 & 96-029 (BASF) and third reading of Ordinance #96-031 - Owens-Corning.

On the motion of Mr. Gerrard, seconded by Mr. Banister, Council voted unanimously to adjourn at 8:15 p.m.
