These attendees will be coming from all over the state; and many will have never visited the Mansion. This is a wonderful opportunity for them to see the Mansion and meet the Governor. In the past we have

kept this event very simple. Attendees begin to arrive at 4:00 p.m. They pick up their name badges from our registration table on the front porch area of the Mansion. From 4:00 to 4:30 it is “meet and greet” and folks can enjoy a beverage from the bar; meet fellow execs and walk through the Mansion, and hopefully get to speak to the Governor at some point. At 4:35 p.m. Mikee Johnson, President of Cox Industries and Chamber Chairman, will get everyone’s attention. (usually a ding of a wine glass will stop the chatter). He will then welcome the group and proceed to formally introduce the Governor. At that point the floor is open for Governor Haley to talk about business issues or business topics of her choosing. (usually about 15 minutes or so) and then entertain questions from any of the group. This should take us to about 5:10 p.m. and some last minute networking before the event ends at 6 p.m.
