TALKING POINTS:

Opening Remarks:

- Today really is another great day in South Carolina, as we are here today to announce DSS' new foster care recruitment campaign, "Champions for Children."
- If you look behind me today, we have members of the General Assembly, foster parents from across the state, DSS staff, and children services advocates.
- This really is Team South Carolina coming together to make a difference.
- The Department of Social Services' mission is to strength families in South Carolina, and one of the most important roles DSS has is to provide a safe and nurturing home to children in their care.
- The children that DSS is charged with taking care of are usually coming from extremely unstable environments, and that's where foster parents come in.
- Unfortunately, 54% of the children placed in foster homes are placed outside of their home counties because we don't have enough licensed families in many of our counties to take care of them without making that move.
- That move can cause an added level of stress to an already traumatic situation for these kids, and it's something that we must work together to keep from happening.
- Over the past year, South Carolina has dealt with a number of challenging situations that tested each and every one of us.
- Whether it was the shooting of Walter Scott, the Mother Emmanuel Shooting, or the 1000 year flood, we saw South Carolinians come together in a way that we had never seen before.
- South Carolina embodied grace, courage, and strength in those difficult times, and we showed the world what "neighbors helping neighbors" is all about.
- We're here today to talk about a different kind of crisis – it's what we are calling a "quite crisis," and it affects children across our state, but it's one that can fixed by the same grace and compassion

- that we already know South Carolinians have.
- A lack of licensed foster parents is an issue that you don't normally hear about, but we're here today to change that and to bring awareness to this very real problem.
- The "Champions for Children campaign" that DSS is launching today is aiming to recruit 1500 new foster parents and to celebrate current foster parents like the ones behind us.
- To talk about the specifics of the campaign, I would like to turn it over to one of my partners, Director Susan Alford.

Closing Remarks (Call to Action):

- So now you've heard the charge. You've heard from Director Alford and you've heard from foster parents who have dedicated their lives to fostering.
- Now, we're asking for your help.
- We understand that fostering is a huge undertaking. We understand that it isn't feasible for every family to sign up today, but what we are asking is for you to consider it.
- And if you consider it and decide that it isn't possible for you, there are other ways to help:
 - Be an advocate for foster parents and foster parenting in your community groups, your schools and your recreational organizations.
 - Recognize foster parents in your place of worship and community organizations
 - Ask your church to host DSS recruiters and place announcements in bulletins
 - Rev. James Woodley is the pastor at Gill Creek Baptist Church in Columbia. As a former youth in care in the state of New Jersey, Pastor Woodley raised awareness about the needs foster children in his congregation and they raised \$2000 dollars which they donated to Richland County DSS on behalf of the children in care.
 - Pastor Patrick Connelly stepped up too, and was recently licensed as a foster parent and has been licensed since November 2015. He has already cared for 5 children.
