Good day Governor Haley:

I am not sure who sent this attached note or why, but here is a little procedural history between this State institutional organization and Mr. Wesley Edward Smith III. Since 1996 (See enclosure 1 attached) asking about the State At-Will Law and practices. I believe that since then my family and I have been targeted and collaterally attacked, but on in the realm of employment.

I since been subjected to the State legal practices of which I am being held in contempt of her majesty's Courts and Governorship.

I took an oath to protect her majesties against all persons (enemy combatants), who claims foreign or domestic alliances. I have tried reaching her on several occasions with no response or reply. I assume that if this note is not responded to, that you like I are both be legally being held as POW (Person of War) by the POW (People of War) that are believed to have inextricably interwoven its practices and have taken over her Courts, by converting the furniture for its own compelling reasons.

According to the law tort S C Code 15-78-10 et seg those person found guilty are liable under this section is a punishable criminal offense if any person are found to have violated a person civil rights liberties or freedoms in regards of race, color or any other forms or personal servitude, found by the State as discriminative or retaliatory in nature.

I believe the letter enclosed was not only produced to continually intimidate, harass and psychologically manipulate me, but is being used to draw me into more legal troubles while collaterally attacking and continually damaging my limited financial resources.

Maybe upon your request from the Court of Common Pleas, you will be able to get all applicable information disclosed, because Lord knows that I have been unable. Seems like the persons are being interchanged while others tend to turn the deaf ear and the blind eye towards me regarding illegal business practices and the previous one sided trial treatment with unequal, unfair and biased asset finding at that hearing.
