Thanks – we’ve kept an eye on this bill this week, and ultimately, it wasn’t brought up in committee. Since the bill is still in its originating house, it’s unlikely to move this year. If a bill isn’t passed by its originating house by May 1<sup>st</sup>, then it takes a supermajority for it to advance during that session.

We’re also keeping an eye on S. 193 and S. 293, which also relate to animal issues. Both of those have now passed in the Senate, so they’re more likely to keep moving this session. If you have a take on either of those, just let us know. Thanks again.
