The deputies who were involved in the altercation in Ladson last night are:

Both deputies were released from the hospital very late last night after being treated for their injuries. They both are now recovering at their home with family. Presently, the deputies have been placed on administrative leave with pay. As a common practice and policy of the Charleston County Sheriff's Office, this investigation has been turned over to SLED. The Coroner Office will release additional information on the suspect.

All video evidence have been turned over to SLED. We will not release any video until SLED and our investigators have had the opportunity to review and interview witnesses. Once this process has concluded, we will release what is subject to be release under FOIA.
