

Senator Lindsey Graham asked our agency to respond to your concerns about Medicaid eligibility and other needs.

We are pleased to inform you that your application for Medicaid coverage under the Aged, Blind or Disabled program was approved effective April 1, 2008. Your Medicaid card will be mailed to you and may be used immediately for Medicaid covered services.

The Food Stamp program is administered by the Department of Social Services. In an attempt to be helpful, we have forwarded your question about your Food Stamp application to the Orangeburg County Department of Social Services. We have also enclosed information on other programs and organizations to assist residents in South Carolina with their daily living needs. You may also contact the Lieutenant Governor's Office on Aging at 1-800-868-9095 to learn more about their programs.
