Governor Nikki Haley has not been working behind her desk lately, but out in the counties affected by the flood almost one month ago. Governor Haley was in the Tri-County Wednesday as part of Team South Carolina Day. "I have to work," she said. "It's who I am. It's what keeps me motivated." She has made stops all across the state to give her help with the recovery process for thousands of flood victims.

**Note:** "These team South Carolina Days were to bring all the services available by FEMA and the state to the people," Haley said. "We've seen record crowds from 2,800 in Orangeburg to 1,200 in Williamsburg."

**Note:** Haley said it's important for her to travel to these areas affected by the flooding, and see it first-hand. "You can't sit behind a desk and know that you're helping families," she said. "For me, it's been very important through this process to be on the ground, hearing the stories, talking to the people, working with these agency leaders that are coming out to help them. To make sure that they understand we don't stop until we answer every person's question. We don't stop until we meet every need that we have to. Until that happens... I'm not going to stop."
