LEADERSHIP SPARTANBURG BACKGROUND:

- Leadership Spartanburg, founded by the Spartanburg Chamber of Commerce, is a nine-month course designed to better prepare leaders and volunteers for community service through exploration of issues, challenges, and opportunities facing Spartanburg County now and in the future.
- The main objectives of Leadership Spartanburg are to:
 - Identify and select highly motivated, potential community leaders to participate in the program.
 - Systematically challenge the participants to become aware of, examine, and respond to the social and economic needs of the community.
 - Develop a feeling of pride, fellowship, and common loyalty among the participants, which will provide a common ground for working together on present and future community needs.
 - Identify organizational and individual opportunities for community involvement and assist in the placement of participants.

SUGGESTED TALKING POINTS:

- It's a great day in South Carolina, and it's an honor to be here with you today to celebrate another Leadership Spartanburg graduating class – the 36th graduating class since the program's inception.
- This program is designed to prepare leaders to promote ideas that better the entire community and respond to the social and economic needs of Spartanburg, and looking at the work y'all have done, I would say it has accomplished its goals.
- The diverse nature of this class' participants, ranging from lawyers to bankers to educators and even to congressional staff, has brought together minds that may not have previously interacted nor worked on the same programs.
- Further, utilizing community resources and knowledge to provide issue specific insight, y'all have been able to explore important issues facing Spartanburg, including education, economic development, and health and wellness.
- **The beauty of this approach is highlighted by the work y'all have done:**
 - This class alone has worked on, and continues to work on, five different community programs, including a downtown urban garden, an elementary school book drive, and a fitness park in a local walking and cycling trail.
- Your work to better Spartanburg is a model every county should look towards to develop new community leaders that are invested in the people they live, work, and interact with every day.
- Thank you again for inviting me to speak at your graduation. I look forward to seeing what you accomplish in the years to come.

General Points:

Unemployment Rate

- 5.7 percent

SNAP/Food Stamps

- We have transitioned more than 37,000 South Carolinians from welfare to work.

Youthful Offenders

- When we took office in 2011, more than 50% of youthful offenders, ages 17-25 years old, were returning to prison.
- Our Corrections team started a new, innovative Youthful Offender Intensive Supervision program that same year to reduce the recidivism rate among offenders ages 17-25 years old and make our communities safer.
- As a result, we are now seeing a 13.5% 2-year recidivism rate for youthful offenders. Since this program started, 2,102 Youthful Offenders have been assigned to Intensive Supervision and 1,730 have been paroled.
- The reduction in the number of young men and women in prison is saving tax dollars and helping to end the generational cycle of incarceration.

1. Economic Climate
 - a. First in U.S. exports for tires and passenger automobiles, second in exports of gas turbines, and twelfth in civilian aircraft.
 - b. South Carolina's exports continue to grow because we have built a reputation around the world as a great place to do business.
 - c. South Carolina ranked first for jobs linked to foreign investment.
 - d. Businesses from all over the world are interested in coming to South Carolina, due in large part to our world-class workforce and business-friendly climate.
 - e. Large-scale manufacturers certainly have a significant impact, but small businesses are just as important to our economic future.
 - f. Small businesses account for 97% of our state's total businesses.
2. So things are going well – we're the envy of the nation – but we still have much more to do.
 - i. Get creative in how we train people.
 1. We've already started: opportunity centers in prisons (Manning), welfare-to-work successes.
 2. Pathways Initiative: Scholarships to pursue vocational training and career education that end in a JOB, not a certificate.
 3. Opportunity Centers – culture change.
 4. Small business involvement – companies working with tech schools to develop programs that train workers to fill specific business needs.
 - a. Ethics Reform

- i. You've heard me talk about ethics reform for almost 4 years now, and I'll keep talking about it until it gets to my desk. We finally have a good chance of that happening in 2016. We need ethics reform to restore your trust in our government. We need ethics reform because it's just good government for the people and you deserve that.
 - ii. When it comes to ethics, there are three things that are hugely important to me:
 - 1. Income disclosures for public officials
 - 2. Independent investigations for complaints against legislators – no more fox guarding the henhouse.
 - 3. Removal of conflict of interest – lawyer legislators disclosing money they make when they sue the state.
 - iii. Please contact your House and Senate members and let them know this issue is important.
- b. Infrastructure
- i. Outline the current work being done by DOT:
 - 1. Our DOT has been committed to improving the current state of our roads.
 - 2. In FY 2014-2015, the received and process over 70,000 work requests, resulting in thousands of patched potholes, thousands of mowed acres, tons of trash and debris removal, and more than 9,000 approved encroachments permits.
 - 3. SCDOT also conducted emergency repairs on many of our major highways, including I-77, I-95, I-26, and I-85.
 - 4. Secretary Hall has also implemented transparency mechanisms to help the public understand SCDOT's priorities and way ahead.
 - 5. But, even with her leadership, the work on our roads and at SCDOT is not complete.
 - ii. Outline the current problem:
 - 1. Competitiveness argument – we're doing great but NC and Georgia are gaining on us.
 - 2. Roads – we all know we need more money for roads. It's a safety issue for our people, and it's an economic issue for our businesses.
 - 3. Structure of the DOT – right now it doesn't work, it's regional and political and it has to change.
 - 4. We are happy the Senate and House have passed bills and are currently working on this in conference, but they must address the governance issue for true and lasting DOT reform.
 - 5. I will not sign a roads bill that does not address governance.
 - 6. Roads improvements should be based on safety, traffic, and development, not on which legislative members are in leadership.
 - iii. Summary of Senate Bill:
 - 1. Reconstitutes the Transportation Commission to an 8-member board.
 - 2. Each member of the Commission is appointed by the Governor and subject to Senate confirmation.
 - 3. The Commission submits a Secretary to the Senate for confirmation upon approval of that candidate by the Governor.
 - 4. Establishes oversight of SIB project selections by the commission and vests the Commission with authority to reject SIB projects.
 - 5. Directs the General Assembly to appropriate not less than \$400 million per year to roads.
 - 6. House bill did not address governance.
- c. K-12 Education
- i. Building on four pillars:
 - 1. Fair and simple funding: eliminate ancillary funding streams and distribute funding through the Education Finance Act (EFA), while sustaining and increasing base student costs.
 - 2. Technology: have worked to increase funding to improve broadband access and 1-to-1 computing initiatives, and provide flexibility for districts and the Department of Ed. to purchase digital instructional material or data security investments.
 - 3. Public school choice: support full EFA funding for charter schools, and

3. provide the Superintendent of Education the authority to contract with third party charter school operators in order to attract the most professional and distinguished organizations.
 4. Reading: full implementation of Read to Succeed and increased money for reading coaches to make sure children can read by the time they leave third grade.
- ii. I proposed five core initiatives that are focused recruiting students to become teachers while they are in high school, paying for a teacher's education – either directly or through loan repayment, making sure every teacher has a mentor and helping career teachers advance their own education and professional skills.
1. We have started small on this initiative, but my budget has ramped this program up and we're working to have these initiatives available to you and funded by July 1.
- d. Domestic Violence Task Force
- i. South Carolina is now ranked first in the nation for the rate of women murdered by men, and has consistently been ranked in the top ten over the last decade.
 - ii. Established the Domestic Violence Task Force to comprehensively address domestic violence in South Carolina.
 1. Phase I (Complete): Surveyed and collected data from different regions of the state.
 2. Phase II (Complete): Identify specific problems and create proposed solutions. Task force released 50 recommendations in August ranging from increased domestic violence training for certain professions and occupations to developing best practices for handling domestic violence cases.
 3. Phase III: Implement or begin to implement approved proposals.
 4. Phase IV: Assess short- and long-term goals for combatting and preventing domestic violence.

Spartanburg County

- Announced Capital Investment: \$301,615,000
- Between January 2011 and March 2016, the unemployment rate in Spartanburg County has decreased by 5.8 percentage points from 11.1 percent to 5.3 percent. There are now 17,835 more people employed in the county and 7,157 fewer people unemployed.
