Gilley & this part I believed he told Erin how to get money from my wife & my bank acct when I went to the ATM I noticed a big discrepancy in the balance. I came home & told my wife that we had to go to the bank & Erin & her sister in law were here & Erin said the money had been adjudicated for her Mother's Confinement in an assisted living facility. I assume adjudicated means it was approved by a Judge. If so I never did get a notice. While I was gone to the barber shop & stopped at the Amvets. Amvets Post to drink a few beers, Erin took her mother to the Helena House & 2 deputies came in the Amvets & wanted to talk to me away from the bar & I said let's talk here.
